# Message from the Chair

After another year of great results, the Chantier de l'économie sociale Trust has laid the groundwork for what will be a pivotal year. In 2018, now that all of its initial funds have been well invested, the Trust will recapitalize its tools. The fundamental importance of the Trust's role in the financing ecosystem for collective entrepreneurship in Québec hardly bears repeating. The Trust not only meets substantial capitalization needs, it also serves as a catalyst, attracting investors to complete financing packages for projects destined to make a significant collective impact.

The Trust's initial capitalization of over \$52 million has, with the collaboration of its partners, been converted into total investments of nearly \$374 million in Québec's economy. As you will read in this report, hundreds of Trust loans across Québec and in numerous sectors of activity have supported community development and the maintenance or creation of thousands of jobs and hundreds of social/occupational integration positions.

Clearly, a tool as productive as the Trust must be recapitalized so this collective entrepreneurship movement, now flowering, can pursue its development. An entire generation of new entrepreneurs, conscious of its positive economic and social impacts, have opted for the approach of collective enterprise and responsible finance.



Furthermore, the inevitable transformation of our economy means we will be seeing new types of projects that will require a variety of financial products, yet to be invented. The Trust is strategically positioned to take part in creating these tools, always driven by the goal of growing our solidarity economy.

We cannot speak about the Trust's impressive results without mentioning the exceptional work of its entire staff, the Trustee Council, the Réseau d'investissement social du Québec (RISQ), the Chantier de l'économie sociale, and our countless partners and collaborators, from both the government and private sectors.

The coming year will resemble the one that has just ended, marked by collaboration and an ongoing effort to respond to collective interests.

# Message from the Executive Director



The past year was marked by events to celebrate our 10 years of investments in social economy enterprises.

It has been 10 years of collaboration with local development actors and our social finance partners to stimulate the growth of the social economy throughout Québec.

This year was also a busy one for investments. Our enterprise portfolio grew with the addition of 16 new collective enterprises, bringing the number of partner enterprises up to 168.

We have supported our partners over the past 10 years, making over \$54 million direct investments in these enterprises that are creating social change and innovation.

These investments generated a total of \$374 million in the Québec economy, but, most importantly, they supported the maintenance and creation of over 3,000 jobs.

In 2017, we also instituted partnerships and implemented the conditions necessary to carry out our mission to create a financial environment conducive to the development of capitalization products tailored to social economy enterprises. We also encourage the financial participation of private and public-sector partners, while facilitating their coordinated efforts. We set up the \$32.5 million Fonds d'aide à la rénovation de l'habitation communautaire [Community housing renovation assistance fund] and will continue to set up similar associated funds.

We worked with many partners in different sectors of the social economy to develop innovative products and financial tools to meet their specific needs. These financial innovations require time and patience because they are built on the knowledge and experience of these partners and developers who are dedicated to their respective missions.

A twofold challenge awaits us in 2018: first, the recapitalization of our initial fund to pursue our investment activities with our patient capital products and, second, the finalization of agreements to set up new funds to complete the financial ecosystem that supports social economy enterprises.

Naturally, the work we have accomplished and the work before us could not be done without the contributions of all our partners, and the daily efforts of my team, and the team at RISQ. Without all these dedicated individuals, we would have accomplished nothing.







### Cumulative authorized investment amounts













cumulative amounts: **\$53,3M**





## 7 à nous (NPO)

**Project:** Renovations of Bâtiment 7 with a view to renting space to 6 social economy enterprises (collective real estate component) and setting up a collaborative workshops for artists.

Bâtiment 7 is a heritage industrial building, a piece of Point St. Charles' popular history, that has been converted into an accessible collective meeting space that is teeming with projects of all kinds. The conversion of Bâtiment 7 will be accomplished in several stages, each of which represents one aspect of the mission's deployment: Collaborative Practices, and Local Services, Family and Health, Food Security and Urban Agriculture, Contemporary Art: they are all facets of a common dream created by and for its community. In this context, several individuals, both professionals and residents, created the group 7 à Nous to take back Bâtiment 7 and transform it into a hub of community, cultural, and social activities.

With its production work, Ateliers Transition helps workers acquire new competencies and develop their social skills, so they can eventually return to school or the job market. All revenues are reinvested in the operation to support women and men who are striving to take their rightful place in society.

**Project:** Improve existing structures and build cottages to increase the accommodations offer, food service, and guided outdoor activities, and maintain year-long operations.

Located 50 minutes north of the Gatineau/Ottawa region, a magnificent natural site comprising nearly 170 acres, 90% of which remains in its natural state, is the locale for Air-Eaubois' outdoor recreational area. The organization encourages outdoor activities with an educational component and the provision of outdoor services and programs. It offers an enchanting location for people to engage in activities autonomously or purchase packages with a guide (holiday camp, nature class, and family holidays). Different types of accommodation and food services are provided, and people can rent a variety of outdoor products and accessories.

## FONDS D'AIDE À LA RÉNOVATION DE L'HABITATION COMMUNAUTAIRE

The establishment of the Fonds d'aide à la rénovation de l'habitation communautaire (FondsARHC) [Fund to assist community housing renovations] is an example of a new investment product, created in collaboration with local stakeholders and new financial partners, in response to a development need of this sector of the social economy.

The FondsARHC commenced operations in 2015, on the initiative of the Chantier de l'économie sociale Trust. Our financial partners were the Fonds immobilier de solidarité FTQ and SSQ Groupe financier, subsequently joined by the McConnell Foundation. They invested \$32.5 million that will be used to renovate 1,500 housing units in Québec by 2020, representing an investment of roughly \$20,000 per unit.

The FondsARHC provides a financial product for cooperative and not-for-profit (NPO) housing organizations, with the goal of financing significant renovation projects without affecting the rent paid by tenants and providing groups with more maneuvering room to cope with the challenges of the end of the agreement.

# Governance and Team

The governance of the Chantier de l'Économie sociale Trust consists of a council and two interacting committees. Composed of development and social and solidarity finance stakeholders, representatives of every region in Québec, and Chantier de l'économie sociale Trust staff members, they meet regularly throughout the year.

## Trustee Council

In 2017, the Trustee Council held 12 meetings in which members contributed their expertise to make decisions based on the Investment Committee's recommendations, and develop and confirm the Trust's strategic policy directions. Their work constituted an essential support to the Trust's permanent staff.

## Investment Committee

All investment requests made to the Chantier de l'économie sociale Trust are reviewed by an analyst from the Réseau d'investissement social du Québec (RISQ) who works closely with local development stakeholders. The completed analysis report is submitted to the Chantier de l'économie sociale Trust's Investment Committee. Composed of members of the Chantier Trust and development and social and solidarity finance stakeholders, this committee meets every two weeks. Committee members issue an investment recommendation to the Trustee Council.

It is a priority for RISQ and the Investment Committee to ensure that investment proposals meet a community-identified need and are supported by local development stakeholders.

## Audit Committee

The Audit Committee, whose members come from outside the Trust, ensures that financial information, and risk management and control processes comply with current laws and regulations and are in accordance with our activities. It also recommends the adoption of the draft financial statement. This committee met twice in 2017.
