

# Pragmatism: A Select Bibliography, 1940–2010

*John R. Shook*

This bibliography has seven sections: introductory and general works; history of pragmatism; analytic philosophy themes; continental and postmodernist themes; ethics and politics; and society and culture. The final section, compiled by the volume editor, includes the works cited in the editorial chapters of this volume (that is, Chapters 1–3 and 16–18: *Introduction*, *Glossary*, *Research Methods and Problems*, *New Directions*), insofar as those works are *not* listed in the thematic sections of the bibliography.
