## CONSTITUTION OF NAURU ARTICLE 40(1) PROCLAMATION

WHEREAS the Eighth Parliament of the Republic of Nauru was dissolved on the 30th day of December, 1986.

AND WHEREAS by a writ issued by the Speaker by and with the advice of the President and dated the 30th day of December 1986 the Speaker appointed the twenty-fourth day of January 1987 for the holding of a general election of Members of Parliament in accordance with the advice of the President.

AND WHEREAS I have received the Return of the said writ notifying me that the said general election was duly held and of the names of the persons elected thereat.

I, PRES NIMES EKWONA, in accordance with the advice of the President DO APPOINT AND PROCLAIM that the Ninth Parliament of Nauru shall meet at Parliament House in the District of Yaren at the hour of Ten o'clock in the morning of Tuesday, twenty-seventh day of January 1987 and shall proceed to transact the following business,

NAMELY -

FIRST, the election of a Member of Parliament to be Speaker of Parliament,

SECONDLY, the election of a Member of Parliament to be Depty Speaker of Parliament,

THIRDLY, the election of two Members of Parliament to be Deputy Chairmen of Committees,

and in that order before the transaction of any other business,

AND PARLIAMENT MUST at that its first sitting thereafter elect a Member of parliament to be President of Nauru.
