# SIX YEARS FOR ADAM JOHNSON

**Footballer was a sex addict and was even found with animal porn**

**Footballer Adam Johnson has been jailed for six years for grooming and sexual activity with a girl aged 15.**

Sentencing the ex-Sunderland player, Judge Jonathan Rose told him he had abused a position of trust and caused his victim "severe psychological harm".

The judge told Johnson, 28, he had engaged in sexual activity with her knowing she was under 16.

It can now be reported police also found extreme pornography involving animals on Johnson's laptop.

The matter is not being taken any further, Bradford Crown Court heard.

During the police search of the player's home last year police recovered an extreme pornographic image from his computer of someone having sex with an animal.

He had also carried out searches for images of young girls, one website was called "Nice young teens".

They also found STD medication in a safe by his bed.

Legal restrictions prevented news outlets from publishing these details until now.

It comes as psychiatrists revealed Johnson believed he had a "right" to sex with anyone regardless of their age as he was obsessed with seeking out new sexual experiences.

## **hypersexual disorder**

The judge said Johnson had been hunting out women for sex from the time he joined Manchester City.

Psychosexual therapist Victoria Appleyard said Johnson has a hypersexual disorder and used his profession to gain sex and had "persuaded" himself his actions were not "damaging" to the women.

Speaking about his victim, Johnson had told Priory psychiatrist Dr Philip Hopley: "I treated her like any of the girls I met. I put her age out of my mind. I was

sexually interested but she was just another girl, another opportunity. She was attractive enough. Another one to get with."

He had groomed the girl and sent her more than 800 messages over a two month period after they met as she waited to get his autograph after a game.

He persuaded her to meet him at a private location, adding "Better when it's dark" and asking "You gunna be forward with me".

He also suggesting that she would not be shy if she drank alcohol.

Johnson's usual routine after training with Sunderland was to visit different women for sex on his way home.

Judge Jonathan Rose told Johnson: "It is quite clear that the events with which the Court is concerned took place at a time when you were engaging frequently in sexual intercourse with multiple partners.

"When you had moved to play for Manchester

City you embarked on an extensive social life which involved sexual activity on a very frequent basis with a number of different partners, even when you were ostensibly in a settled relationship.

## **'abuse of trust'**

"Dr Hopley speaks of your careless and reckless disregard for the age of your victim

due to your lack of clear thinking and your compulsive drive to have new sexual experiences." Johnson was convicted of one offence of sexual activity with a child but cleared of another following a two week trial at Bradford Crown Court.

He had already admitted grooming the 15-year-old schoolgirl and kissing her in a

sexual manner.

Judge Rose told Johnson: "There was undoubtedly significant planning involved, there's an abuse of trust, you solicited sexual images of her and there was a significant disparity in age.

"There is an abuse of trust, inasmuch as those who enjoy positions of what today is known as

## House prices set to top £300,000

THE average price of a house is likely to break through the £300,000 barrier this year, new figures have revealed.

Values soared by £18,000 in 2015 to reach an average of £292,077, the equivalent of £1,500 a month or £343 a week.

In December alone asking prices shot up £1,600. These were the strongest monthly sales since 2006 as buyers competing for fewer homes refused to let Christmas put them off.

The housing market has enjoyed some smooth sailing in the past year, rewarding homeowners and reinforcing Britons' collective desire to own our own homes.

"If the current growth continues into 2016 the value of the average home may pass the £300,000 mark, having reached £250,000 in December 2013," said property expert Adrian Gill.

The surge in prices has been propelled by a sinking supply of houses coming on to the market, coupled with increasing enquiries from potential buyers. Alex Gosling, of HouseSimple.com, said: "Property prices will keep rising while there's a lack of supply."

# Quitting the EU 'would help UK security', says former MI6 chief

Leaving the EU would improve Britain's security, a former head of MI6 has suggested, as a series of serious intelligence blunders in the run-up to the attacks in Brussels emerged.

Sir Richard Dearlove said in an article in Prospect Magazine that Britain's borders could be strengthened in the event of a Brexit and extremists could be more easily deported, moves which he said were "security gains" with little apparent downside.

His intervention, which contradicts claims from the Prime Minister and the Home Secretary that EU membership makes Britain safer, helped intensify the row over the security of Europe's borders in the wake of the Brussels attacks.

On Wednesday night there were reports that Islamic State of Iraq and the Levant (Isil) had sent 400 fighters from Syria to Europe, where they can move freely across the Continent with the aim of carrying out terror attacks.

According to European and Iraqi intelligence officials, the fighters have been instructed to carry out multiple attacks like those in Paris and Belgium.

It also emerged that Belgium was warned that one of the bombers was a "known militant" by the Turkish authorities, who arrested and deported him. The Belgians failed to follow up the information, according to Turkey.

Sir Richard, who led MI6 between 1999 and 2004, said that Britain may experience "security gains" from Brexit. In an article for Prospect Magazine, he said: "Whether one is an enthusiastic European or not, the truth about Brexit from a national security perspective is that the cost to Britain would be low. Brexit would bring two potentially important security gains: the ability to dump the European Convention on Human Rights – remember the difficulty of extraditing the extremist Abu Hamza of the Finsbury Park Mosque – and, more importantly, greater control over immigration from the European Union."

### 'colander'

"One loss that would result from Brexit and which has been cited by Theresa May, the Home Secretary, as a reason for her supporting Britain's

continued membership of the EU, would be the European Arrest Warrant. But its importance has been exclusively criminal and few would notice its passing."

Sir Richard said Britain's status as Europe's "leader" in intelligence and security meant it was "difficult to imagine" European nations breaking off their relationships with it.

He dismissed the role of Brussels security

bodies such as Europol, saying they were "of little consequence". Information is not shared across all 28 EU states because they are potentially a "colander" for intelligence, he said.

Boris Johnson, the Mayor of London, who is a leading Out campaigner, warned on Wednesday that the European Court of Justice was hampering the Government's ability to deport terrorists and

carry out surveillance on suspects.

All the main US presidential candidates also criticized the approach of European intelligence and security agencies towards stopping terrorism.

Hillary Clinton, the Democrat front-runner, said the attacks were the "latest brutal reminder" of the Isil threat as she called for the creation of a European border and coast guard.

## QUEEN OF SOAPS: Barbara Windsor honored at Buckingham Palace

**When it comes to British showbiz royalty, they don't come much bigger than Barbara Windsor.**

And the soap legend came face-to-face with the real Queen as she was made a dame by Her Majesty on Tuesday.

The 78-year-old Londoner, who boasts over 60 years in the industry, arrived at Buckingham Palace to be honoured by Elizabeth II.

Looking resplendent in a purple lace dress

and matching fascinator, the bubbly blonde entertainer was ecstatic as she bowed before the royal at her investiture.

Talking about receiving her damehood from the monarch, Barbara joked that it was lovely to meet 'another small lady'.

She added she was impressed by the Queen's 'gorgeous skin' and quipped: 'I wonder what she uses.'

And it seems Her Majesty paid her own kind of

homage to the queen of soaps - she appeared to be wearing a very similar green ensemble she had sported for a visit to the set of EastEnders in 2001.

The royal was shown around Albert Square on a special tour of the show's iconic filming lot by Barbara and her on-screen son, Steve McFadden 15 years ago.

Barbara made her return to the set on Monday as she prepares to reprise her role as

Mitchell matriarch Peggy and was given her own regal welcome by the cast and crew.

She explained: 'They all - all of them - had crowns on. All the crew, everybody. Because I was coming here.'

'I said "Oh shut up, you daft lot"'. It was just so wonderful, because I am the first dame they've ever had.

The actress added that she thought it was funny she had been asked to go in for two early shifts either side of the investiture ceremony at Buckingham Palace.

She said: 'Typical - they call me in first thing in the morning. It made me laugh - "You might be a dame but you're still in first thing in the morning," - I loved it!'

Dame Barbara was joined by her husband Scott Mitchell and her longtime agent, Barry Burnett, at the ceremony.

The Carry On! star was previously awarded an MBE in 2000.

She celebrated her investiture with family and some EastEnders colleagues, including June Brown and Pam St Clement, for a special lunch at Fortnum & Mason in central London.



## Sign of the times: M&S launches new body-covering swimsuits for Muslims

In a sign of the growing diversity of Britain's shoppers, Marks and Spencer has put the burkini on shelves in England.

The burkini - designed to adhere to strict modesty standards - made headlines when donned by Nigella Lawson on a beach holiday five years ago as protection from sunburn.

The M&S version, which promises to cover the whole body "without compromising on style", has already proved

popular in branches in Dubai and Libya, where it has been on sale for three years.

But this is the first time customers have been able to purchase the suits in the UK.

The introduction of the range follows a trend for more modest clothing lines.

Fellow department store House of Fraser already sells lightweight Islamic headscarves, or hijabs, designed by company Shorso to be worn during exercise.

Last year a Muslim model in a hijab appeared in an H&M advert for the first time, and in January Dolce & Gabbana became the latest designer label to offer a 'modest-wear' line, hot on the heels of other brands including Tommy Hilfiger.

The M&S three-piece burkini set comes in two styles - a blue floral number and a black version with a paisley print.

**Pub opening hours will be extended in England and Wales on 10 and 11 June to mark the Queen's 90th birthday, David Cameron has announced.**

Pubs will be able to stay open an extra two hours on both days until 01:00.

The Queen celebrates two birthdays each year - her actual birthday on 21 April and her official birthday on a Saturday in June - this year on 11 June.

The longer opening hours also coincide with England's and

Wales's first games in the European football championships.

On Saturday 11 June, Wales play Slovakia at 17:00 BST and England play Russia at 20:00 BST. Street party

## Trooping the Colour

There will be a series of events over the June weekend to mark the Queen's 90th birthday.

These will include a street party in The Mall, a service of thanksgiving at St Paul's Cathedral and the traditional Trooping the Colour ceremony, also known

as the Queen's Birthday Parade, at Horse Guards Parade.

Announcing the extension during Prime Minister's Questions, Mr Cameron said: "I'm sure that will be welcomed right across the House."

Late opening hours have taken place on other occasions in recent years including the wedding of the Duke and Duchess of Cambridge in 2011, the Queen's Diamond Jubilee in 2012 and the 2014 World Cup.

## Dog Martin: comic actor doubles reward for missing pooch Pippin

**ACTOR Martin Clunes has offered a £2,000 cash reward for the return of a dog which was stolen from the home of one of his biggest fans.**

The Doc Martin star and animal fan stepped in to help after he heard about the theft of elderly pooch Pippin in a smash-and-grab raid.

Pippin's owners, Sarah and Gareth Wilson, have said they are distraught at the loss and are worried that the dog may become ill as he needs regular medication.

They are bowled over by Clunes' generous offer and hope that it may help get Pippin back home.

Ms Wilson, a long-time fan of Clunes, had brought Pippin along

to meet the actor on the set of Doc Martin in Port Isaac.

She said the actor immediately hit it off with the dog, who is a 'Yoodle' - a cross between a Yorkshire Terrier and a Poodle.

But she was left distraught after 15-year-old Pippin was taken by thieves who broke into her home in Wigston, Leicester, last Tuesday.

"They smashed their way through the back door and took Pippin but didn't take anything else even though they had access to the house," said Ms Wilson's son Gareth.

"We are very worried. He is on medication and steroids for his lungs."

When Clunes read

about the loss of the dog in an online appeal offering a £2,000 reward, he offered to double the cash from his own pocket.

A spokeswoman for said: "Martin can't think what he can do to help except add another £2,000 to their existing reward offer."

Clunes presented ITV show A Man and his Dogs in 2008 and then narrated Secret Life of Dogs on the same channel in 2013.

He also hosted a one-off ITV documentary called Martin Clunes and a Lion Called Mugie which was filmed over three years in 2014 and has also presented shows looking at the relationship between humans and animals.

'celebrity' are trusted by their fans and the family of fans to act in an entirely appropriate manner towards, in particular, young people who are less able to protect themselves."

Johnson had used social media to groom the girl after she contacted him on Facebook on New Year's Eve 2014.

The charges against Johnson arose from a meeting between him and the girl in his car in County Durham on January 30 last year.

He groomed the girl by giving her gifts of signed football shirts and sent her explicit messages.

The former England international, was sacked by Sunderland last month following his

guilty pleas.

In a statement, his victim says she has been "bullied".

"What happened a year ago has completely changed my life," she said.

"Hopefully justice will be done and I can move on with my life."

Her mother says since the incident she has been targeted by thousands on internet trolls.

"Through social media my daughter had thousands of malicious remarks and threats of violence towards her," she said.

She said she stands by the decision to report it to the police to protect other young girls.

"Adam Johnson was in a position of trust with hundreds of other idolising young fans who could have been victims themselves," she added.

## Sir Tom 'snubbed' by Welsh hometown



Welsh crooner Sir Tom Jones has been left feeling snubbed after he was denied the freedom of his home county.

Sir Tom (above), who was born in the Welsh Borough of Rhondda Cynon Taff near Pontypridd, was one of three local heroes put forward for the accolade but was pipped to the top spot by boxing champion David Dower, 82, and Mathew James, 30, who survived three gunshot wounds while saving his fiancée Saera Wilson from a terrorist attack in Tunisia last year.

Tom is frequently heralded as a Welsh hero after the singing legend racked up thirty-six top forty hits in a career spanning six decades. Including iconic songs It's Not Unusual, What's New Pussycat, and Sex Bomb.

Speaking to The Daily Express local fan Peter Humphries said: Tom has put Ponty on the world map. Let's face it how many people in Australia or America have heard of Dai Dower?" Adding: "Tom is a symbol of our area and deserves recognition."

The council announced the shortlist, in which Tom was snubbed earlier this month. Councillor Teresa Bates said in response: "No one has got anything bad to say about Sir Tom Jones. "Maybe he will get it in the future, who knows?"

A new stage musical, Tom Jones the Musical, honoring the star's life opened at the Wales Millennium Centre this month.

# 'GI Jane' soldier felled two with one punch in bar brawl, court hears

A soldier nicknamed "GI Jane" after she became a public face of British female troops in Afghanistan has escaped jail after she attacked two people at random while on leave.

L/Cpl Rachael Dorrian, a former British judo champion and weightlifter, felled a man and a woman with the same punch after she allegedly "went mental" when she was ejected from a nightclub.

The 24-year-old broke the nose of her male victim, while the woman, who was caught in the face as she launched the punch, suffered a black eye.

Dorrian was convicted at Manchester Crown Court Dorrian of assault occasioning actual bodily harm and common assault in the attack at New York, New York bar in Manchester's Gay Village.

### Judo champion

Earlier this month a judge allowed her to be sentenced at Bulford military camp in Salisbury, Wiltshire where it is thought she is based. She was conditionally discharged for three years and ordered to pay a £15 victim surcharge.

Dorrian, who serves with the Queen's Royal Hussars, was interviewed by journalists while stationed in Lashkar Gah, in Helmand province in 2011.

She is thought to have joined the army aged 18, won a gold medal in the British Judo Championships in 2010 and was based in Germany before being posted to Afghanistan.

She worked as a company clerk with her regiment but also helped with searches of suspect females and regularly headed out on patrol in Helmand with her

male colleagues. She got her nickname after the movie character played by Demi Moore. In an interview with a local newspaper Dorrian said: "It's great to be finally out here and putting my training into action."

"I feel like I'm doing a good job and I'm really valued within the company. You get used to being in the company of blokes in the Army."

"I always knew I would have an Afghanistan tour. I was told right from basic training that one day I would be going to Afghanistan no matter what cap badge you join. It's just the way life is in the Army. You can't expect not to go Afghanistan because that is what it is all about the moment."

The assault occurred on September 18 2014, while Dorrian and two male friends had been out in Manchester. A fight broke out when someone accidentally barged into them on the dancefloor.

Daniel Hindram, an eyewitness who was celebrating his birthday with partner Matthew Lowe said: "We were just going past them and somebody pushed into another and it started from that. I didn't fight back but I was pushed and punched to the floor and kicked and punched whilst on the floor."

### 'going berserk'

"I didn't fight back because I knew the bouncers would be straight over. Matt was there and him and the girl threw their drinks at each other. He probably stood up for a couple more seconds trying to fight back and the bouncers came over. I only realised it had stopped because I had stopped being beaten so I got myself up presuming Matt was still with me but he had been

taken outside.

"By the time I got to the top of the steps to the bar and the doors I just saw the girl being restrained across the street going mental. She was across the way going berserk, she looked like

a mental wild person. She was shouting and screaming. That's when she launches over to him. I saw her smack Matt in the face.

"I'm watching this crazy person and my partner's Matt's nose

had been broken and was gushing with blood everywhere. Another girl who had been talking to Matt looked bad."

Dorrian denied assault. The Ministry of Defence declined to comment on her conviction.

# Detectorists: one of many reasons to enjoy Acorn TV

## ■ Premium TV channel features a treasure trove of British classics

COMING THIS month to Acorn TV is season two of *Detectorists*, the acclaimed British comedy featuring Mackenzie Crook and Toby Jones as a couple of oddballs scouring the British countryside for treasure.

If you haven't yet seen this show you're missing out on one of the most original and charming half hour comedies from the old country in recent years.

As well as starring in the show, Crook (best known as Gareth from *The Office*) has also written and directed the show, which revolves around the friendship between himself and Jones, a pair of mismatched and troubled souls who seem more comfortable on the company of their metal detectors than their fellow men. But these men are not treasure hunters. They style themselves rather as 'detectorists', joning

forces with a local club of like-minded folks, comprised of an affable ex-military type, two lesbians, a bearded hippie and a youthful Asian. All are misfits in search of a life-altering find like Saxon gold or a Viking burial mound, but more often come up just with soda cans and the other detritus of modern life.

Set in an unnamed but gorgeous corner of the English countryside, the six-episode season slowly unfolds as the detectorists are enlisted by a mysterious German visitor to help unearth the mystery of a downed Second World War German bomber. And although the settings are confined, the characters and their individual stories are rich in texture and detail, proving again that old cliché about all the world being found in a small English village. The deceptively simple story lines are expertly

written, nicely shot and excellently acted. The show boasts the same sort of gentle charm with the occasional moment of laugh-out-loud humor that made *Last of the Summer Wine* such an

enduring favorite. This is the sort of the stuff which the British do better than anybody and *Detectorists* is certainly worth thirty minutes of your time.

Acorn TV is an online

service with over 1,800 hours of programming available, including timeless British classics including *Rumpole of the Bailey*, *Lovejoy*, *Cadfael*, *Upstairs Downstairs*, *The Midsomer Murders*,

## Your nutrition: follow the guidelines, but make them your own...

**We all know the parable about the difference between giving a man a fish and teaching him how to fish. Well guess what, the same applies to your healthy fitness...**

Here at [www.thebodycamp.com](http://www.thebodycamp.com), we would rather teach you how to fish. If you're a good learner, you will eat well for life. You also don't have to depend on me, or a top class retreat like [www.thebodycamp.com](http://www.thebodycamp.com) or anyone else to feed you in the future.

Because of human nature and market pressures, the diet industry keeps prescribing meal plans. But their business plan is still based on the ideas of bad foods, forbidden foods, rigid food lists, magic superfoods and strict diet rules.

I would rather let you

make your own choices inside a structured but flexible framework. If I do show you a sample meal plan, I will explain that it's only an example of how I might eat, or how other people successful at body transformation eat, not a rigid prescription for you. I would tell you that I want you to learn how to create your own meal plans, and I'm simply showing you samples as idea starters.

Bottom line, here is how a meal plan can be flexible: You create and customize your own natural nutrition plan. Creating your own meal plans also aligns with what psychology research says about autonomy and self-motivation.

If you feel you had a hand in the process of creating your own

program (rather than one passed down from the diet dictator) you'll be more self-motivated and more likely to make the changes a lasting part of your lifestyle. This is yet another reason why flexible dieting works, and it has not been discussed nearly enough yet.

### change it up...

Here's another reason why working off a daily meal plan can work: Who says you have to follow the same meal plan every day?

Granted, I follow the same meal plan every day, more or less, but that's my choice. If you don't want to eat the same thing every day, you don't have to. Make two meal plans. Make three! Make seven, if you really want to, but you

don't need many. I've seen diet books with 12 weeks worth of different daily meal plans. Who in the world buys a diet book and eats exactly what someone else prescribed for 84 days? However, if you simply have two or three meal plans that you created, and you rotate them, that is enough variety to make most people happy. If you have three meal plans with five meals each, that's fifteen different meals you could rotate!

For those freestyle-loving people, you can make substitutions off one meal plan – food by food or meal by meal. With the right meal plan template, it's easy. Suppose oatmeal, a banana and scrambled eggs is on your breakfast meal plan, but you

don't want oatmeal yet again this morning. If you understand nutrition, you know that all you have to do is swap one food with a different food from the same group and your calories and macros for the day will automatically be all good.

Lets suppose you were eating ½ cup (40g) of oatmeal. That's 150 calories. If you swap for 2 slices of Ezekiel bread toast that's 160 calories. Close enough – you're done! What could be easier than swapping starchy carb for starchy carb or protein for protein? This isn't rocket science and it isn't new. In fact, good dieticians have been teaching food exchange systems for as long as I can remember. This is simple stuff! It's only hard if you make

it so by accepting the wrong (rigid) rules or trying to micromanage. Simply put, following a structured, yet flexible meal plan is the most powerful nutrition strategy.

There are things I've changed my mind about over the years, but nothing will ever dissuade me from my belief that working from a daily meal plan is a great way to transform your body and health. You don't have to adopt rigid rules.

If you eat mostly healthy, natural foods but leave room for your favorite foods and treats on special occasions by earning them with a great workout, it works.

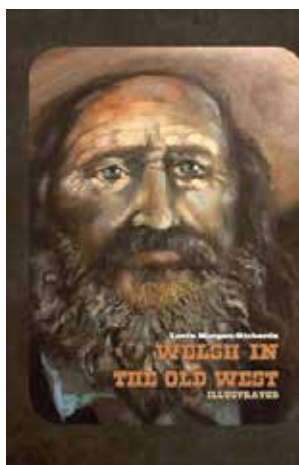
# Welsh in the Old West: more than you thought

Exclusive Interview  
with Lorin Morgan-

"I watched the *Lone Ranger* as a kid and the *Wild Wild West* TV series with Robert Conrad," says *Welsh in the Old West* author and illustrator Lorin Morgan-Richards. "Interestingly, the *Lone Ranger* character by Zane Grey was actually inspired by a Welsh American named John Reynolds Hughes, a Texas Ranger, whose demeanor was quiet and reserved while his call for justice was immeasurable. He served longer than any other Texas Ranger and was awarded Certificate of Valor in 1940."

*Welsh in the Old West* is for anyone who loves the early American West.



Many American West pioneers were from Wales...Daniel Boone, Meriwether Lewis of Lewis and Clark, and William Fargo of Wells Fargo. There are 32 biographies of people from Wales or Welsh descent who helped make the Old West. Richards examines the lives of the Welsh cattle drovers, outlaws, inventors, military leaders, miners and the fate of the Old West ghost towns. All except two stories are about men. There are beautiful illustrations

by Welsh artists curated by Morgan-Richards, who's served as executive director of the Los Angeles St. David's Day Festival, an annual Welsh arts and culture event in March.

"After the 2014 Los Angeles St. David's Day Festival I was looking to curate a new Welsh book for the following year," says Morgan-Richards. "My original intent was to have the festival at Paramount Movie Ranch in Agoura, California where they filmed *How Green Was My Valley*, a 1941 film about Welsh miners."

Morgan-Richards did two years of research for the biographies. "After exhausting The Charles E. Young Research Library at UCLA [a library for scholars], I scrolled through old newspapers in micro-film, investigated grave markers, and made use of genealogy resources to help fill in missing information."

"One of the most

interesting newspaper clippings I found was about the life of Anne Ellis, of Dolgellau, Wales," says Morgan-Richards. "She came from being deserted on the streets of Kansas City at the tender age of 13, lived destitute after her first husband's murder, established her own boarding house in raucous Dodge City, and called the outlaws and lawman of the day like she saw them...as cowardly. Anne went on to become a wealthy woman."

Morgan-Richards has been interested in Native American and American Western history since childhood. "I remember my first book as a child was *The Indians Knew* by Tillie S. Pine, an early reader from 1965 explaining the cultural ways and historical resourcefulness of Native Americans and how they are applied in the sciences today. My great ancestor John Morgan left the Tredegar area of Wales and emigrated to

southern Ohio in the early part of the 1800s."

Morgan-Richards says many of the artists he chose to illustrate his book have been with him since his first Welsh art show in 2011 at the Barnsdall Art Park. "The artists are the real backbone of my art book projects and should be acknowledged... Michele Witchipoo ([www.witchesbrewpress.com](http://www.witchesbrewpress.com)), Robert Karr ([www.karrart.com](http://www.karrart.com)), Rochelle Rosenkild ([shellrosecreations.blogspot.com](http://shellrosecreations.blogspot.com)), Kimberly Wlassak ([gerushiasnewworld.blogspot.com](http://gerushiasnewworld.blogspot.com)), Xavier Lopez Jr. ([xavierlopezjr.blogspot.com](http://xavierlopezjr.blogspot.com)), Welsh twins Nichola Hope ([www.nicholahope.com](http://www.nicholahope.com)) and Sarah Hope ([www.sarahhope.com](http://www.sarahhope.com)), and Welsh author and artist Jo Mazelis ([twitter.com/jomazelis](https://twitter.com/jomazelis))."

Morgan-Richards is an author, poet and illustrator known for his children's books, including *Simon Snootle*

Morgan-Richards lives in Studio City, California. He was born in Beebetown, Ohio, where his father's family has lived since the late 1700s.

"Then she will happily take that weight for me and make sure that I am OK."

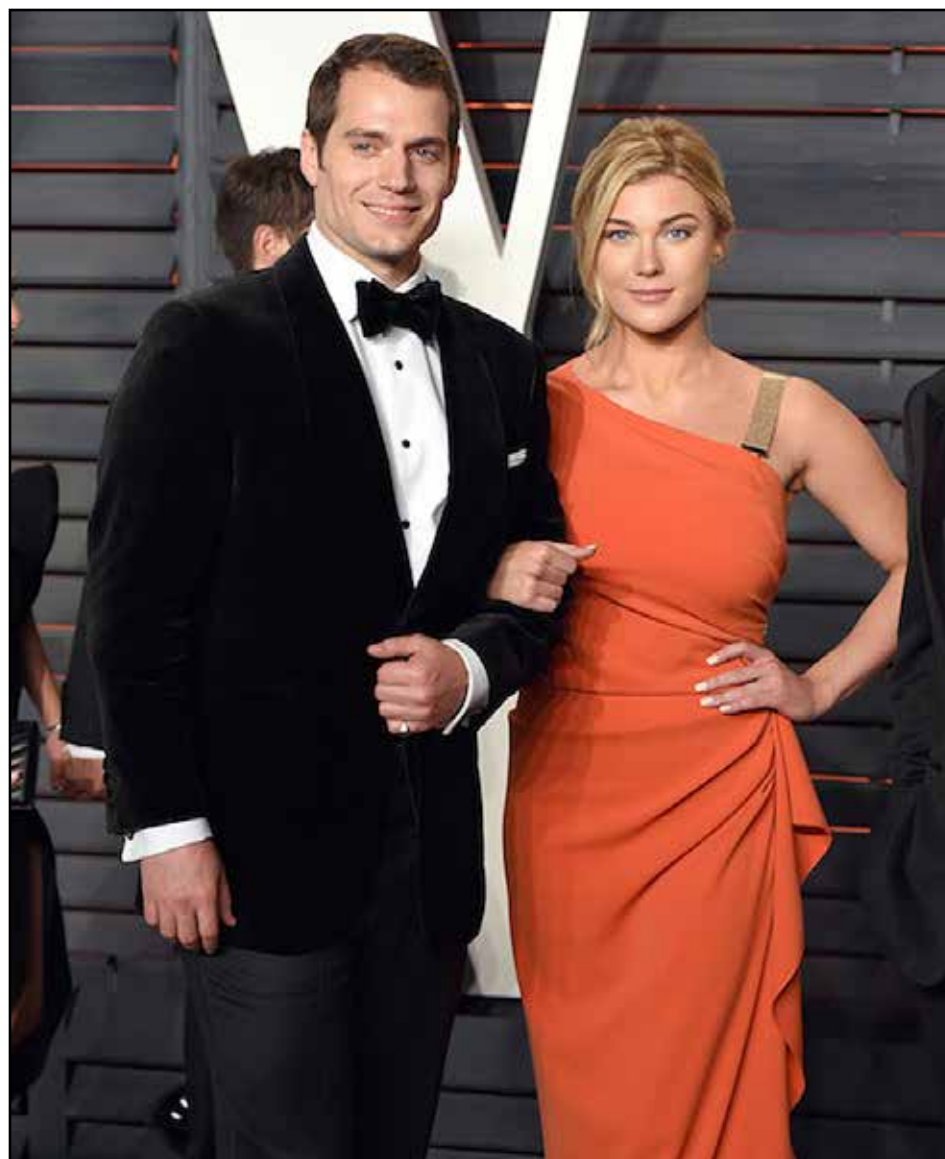

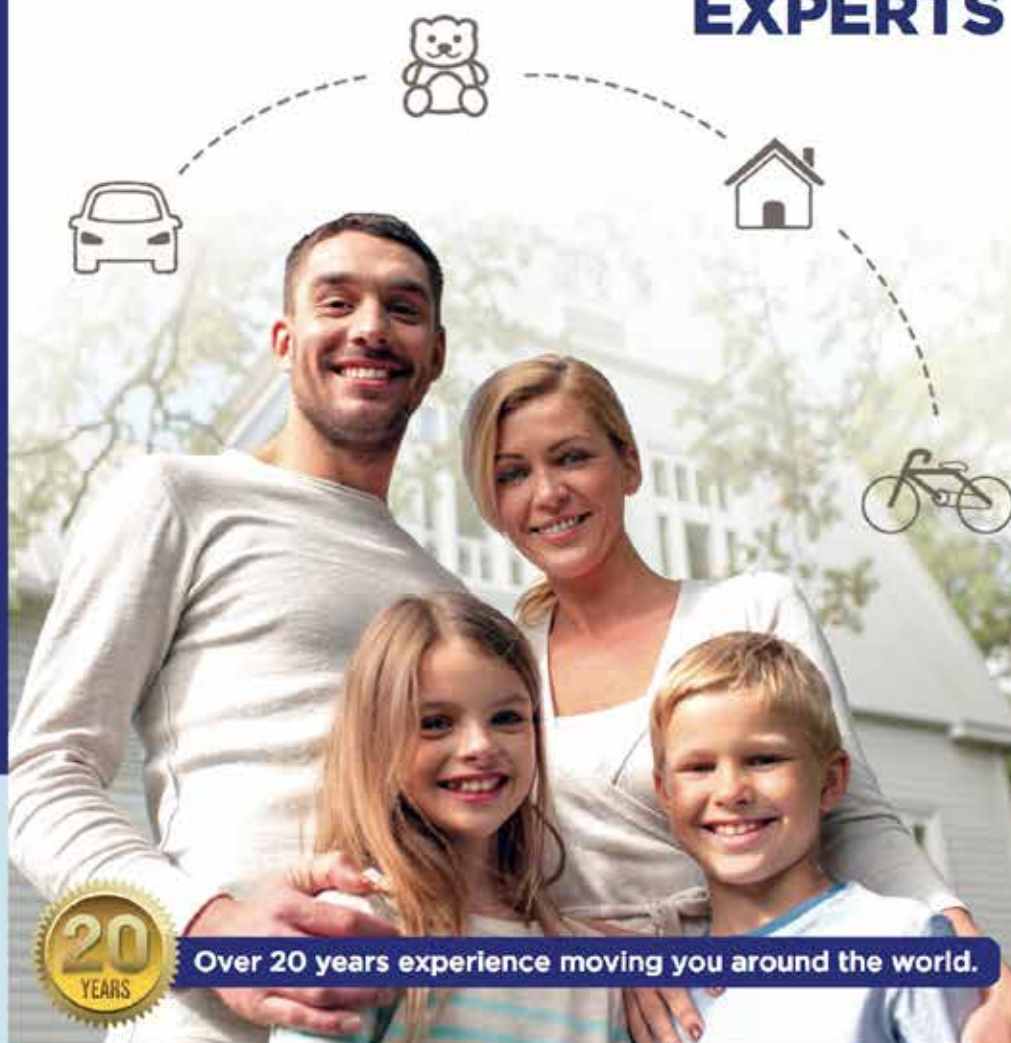

# Kane closes in on £100k/week deal

## Soaring Spurs signal intent to keep red-hot striker

With Manchester United circling Harry Kane, Tottenham Hotspur have begun talks over a new contract for their star striker, which could see his wages more than triple to £100,000 a week.

The England forward, who has struck 20 Premier League goals for the second season running, is valued at £60m, but United could be willing to

offer that if Jose Mourinho becomes manager and makes a move for the player.

However, Spurs are now poised to offer the terrace hero a new deal "to lessen any risk of him forcing a move out", says the Daily Express. It would be his third contract in the space of 18 months, adds the paper, which notes that he signed a five-year deal in

February last year worth £30,000-a-week.

The new deal is worth far more than that, although it would not stop his suitors from trying to seduce him. "United, with six players on £100,000-a-week or more, would likely offer Kane a much higher salary than what he can land at Spurs," says the Express.

But it points out that Spurs are "currently in a Premier League title race and look set to qualify for the Champions League next season, while United are battling with West Ham and Manchester City for fourth place".

Spurs are also confident of holding onto manager Mauricio Pochettino over the summer, even though he is also bound to attract interest from other clubs after overseeing the club's transformation from try

The club expects the coach to agree a new deal in the summer, while The Sun notes that any team that wants to poach him will have to pay a £10m release fee, which is written into his current contract.

## Moyes linked with Villa move

**DAVID MOYES** is ready to take the Aston Villa job and drop down to the Championship.

The doomed Premier League club are set to ditch boss Remi Garde within days and Moyes is keen to take on the challenge.

The ex-Manchester United and Everton boss, (right), was tipped to replace Ronny Deila at Celtic this summer but he'd prefer a crack at restoring Villa's fortunes.

The 52-year-old is ready for a dugout return after four months out of the game and is prepared to drop into a lower division.

Nigel Pearson and Steve Bruce were favourites to replace French boss Garde but Villa now have a second chance to snap up Moyes.

The Scot turned down the job while he was at Real Sociedad before it was handed to Tim Sherwood last summer.

He also rejected approaches from Sunderland and West Ham. But after losing his La Liga job last November, Moyes is now ready to return to work.



Meanwhile, his old club, Manchester United could be hit with another UEFA charge after allegations of illicit chanting in the Europa League clash with Liverpool last week.

Both clubs faced a host of disciplinary proceedings after

disturbances in the last-16 second-leg tie at Old Trafford.

Only Liverpool were charged with illicit chanting, despite some United fans singing about the Hillsborough disaster.

UEFA will now investigate whether United should face action.
