

MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING ("MOU") is entered into between i-Cultiver, Inc., a Delaware corporation (the "Company"), and Dr. Ulrich Kutschera (hereafter referred to either by name or as the "Academic Advisor") as of April 1, 2021 (the "Effective Date"), in order to develop publications to be published in high-level peer-reviewed journals and to collaborate on projects of common interest and goals.

The Company is a new platform for (technical) product development through strategic academic and industry partnerships. The Company leverages its network of multidisciplinary specialists to fill the gaps within technology transfer for commercial application, problem solving and innovation.

Intent: This MOU is based on an ongoing cooperation between Dr. Rajnish Khanna, Founder and CEO, i-Cultiver, Inc. and Dr. Ulrich Kutschera, Professor of Biology, Kassel, Germany.

Whereas both, the Company and the Academic Advisor agree that our former mentor and colleague, Stanford-Professor Dr. Winslow R. Briggs (1928-- 2019) promoted our career and inspired us to perform research projects that are not yet finished. As former members of the Briggs- lab at Carnegie Institution for Science, Stanford University, CA 94305, we agree to officially establish the following terms within the framework of the research conducted by the Company:

1. Establish a new Project "W. R. Briggs/Stanford-019" (hereafter referred to as the "Project"), managed by Dr. Ulrich Kutschera, Germany.
2. Dr. Ulrich Kutschera will join the Company as Academic Advisor starting on April 1, 2021, and will be able to list his new role and affiliation with the Company on Wikipedia and other similar platforms; however, Dr. Kutschera will not use the Company's name in any press releases without obtaining prior permission.
3. The Company may list the Academic Advisor on websites and in Company brochures as a member of the Advisory board; however, the Company will not use the Advisor's name in any press releases without obtaining prior permission.
4. The Academic Advisor will provide high-quality manuscripts on the "Physiology and Evolution of Organisms, with a focus on plants & microbes, plus human biology, within a biohistorical-philosophical context (Research Papers, Review Articles, Commentaries etc.)"
5. Dr. Khanna will be a co-author of these manuscripts, and add to the text whatever is appropriate. In addition, Dr. Kutschera will co-author manuscripts generated by Dr. Khanna, by contributing an Introduction, Abstract or the Discussion-section (middle author).
6. All of these papers will be dedicated to W.R. Briggs, and are related to the work our former PI performed during his long tenure at Carnegie-Stanford University. ...
