## 100. Transferring Portion of Chickasaw Turnpike

Murray County - District VII - Addition of SH 7 Spur to the State Highway System
NOTE: Commissioner Love asked if a situation like this had happened before. Secretary Ridley replied that the Department had never taken a section of a turnpike in the past. The Oklahoma Turnpike Authority (OTA) has rebuilt this portion of the turnpike bringing it up to ODOT standards and all ODOT would have to pay out, would be building the 2 ramps entering and exiting the turnpike. After completion of new interchange, OTA will still own the land, but ODOT would be responsible for the operation and maintenance of this segment of the Chickasaw Turnpike. A Bond Indenture conceived in 1988 allows the OTA to make this agreement with ODOT. We have had public meetings with the people in Sulphur about the traffic problems in this area due to the large amount of trucks entering and leaving the rock quarry plants. This is an opportunity for us to fix this problem very inexpensively and make the people in that area very happy.

Commissioner Alexander asked if this project would be covered in the 8 Year Plan or is it an expedited project. Secretary Ridley replied that it is covered in the 8 Year Plan.

## 106. Director's Report

Secretary Ridley thanked the Commissioners for approving a project that has been long overdue and long awaited, and that is the last paving job on the l-40 relocation in downtown Oklahoma City. This project gives us a fairly firm date as to when we can take the traffic off the existing bridge and put it on the new alignment. The Contractor bid 240 days, so that means it should be done by the end of April or before. They have a $\$ 25,000.00$ a day incentive and disincentive on this project. This is the last project in the first phase of relocating I-40, the next phase will be reconnecting the downtown area to I-35, I-40 and I-235. This is a great milestone for the Department.

Secretary Ridley stated we have not heard anything from Congress in Washington D.C. concerning how much federal money we will receive. He said a few weeks ago he had to give testimony on the reauthorization bill before the Environment \& Public Works (EPW) Committee. He thinks they are getting closer to having final resolutions and hopes to know something within the next couple of months.

Commissioner Regan asked if there was a timeline on when Congress has to have a decision made on the Highway Bill. Secretary Ridley explained the end of the federal fiscal year is at the end of September, a decision has to be made both on the authorizing legislation, as well as the appropriation portion. However, we are now on a continuing resolution for the SAFETEA-LU Bill and have been for 2 years, it ended in September, 2009.

Commissioner Love asked if Congress would just sign another 2 year continuing resolution bill if no decision is made on the authorizing legislation. Secretary Ridley stated that is probably what would happen, but Senator Inhofe and Congressman Lankford are focused on having an authorization piece of legislation in place. He said it is just hard to predict what will happen.

Commissioner Love asked Secretary Ridley to give a little background on the l-40 pedestrian bridge. Secretary Ridley said the pedestrian bridge is going to be built just east of the Union Pacific Station and will be built by the City of Oklahoma City in concert with ODOT. ODOT was already obligated to build a pedestrian bridge there as part of the litigation process of when the "Record of Decision" on the Environmental work was done, and had committed 3.5 million dollars for that project. The City of Oklahoma City wanted a different kind of bridge than we were going to build; they wanted more of a signature bridge. So it was decided that we would let the City build the bridge and ODOT would contribute the allotted 3.5 million dollars towards the cost of this signature bridge.

Commissioner Love asked about the timeline on the deconstruction of the old bridge. Secretary Ridley explained that the plan is to start deconstruction as soon as possible after traffic is rerouted to the new l-40. He stated that it would take about 8 months to deconstruct since we want to try and reuse the beams.

Commission Burrage commended the Department for all their hard work on what they have accomplished.
