**Pre-Trial Chamber I** of the International Criminal Court (“Chamber” and “Court” respectively), hereby renders the following decision:

### **Procedural History and Submissions**

1. Resolution 1970 was adopted by the United Nations Security Council (“UNSC”) on 26 February 2011,<sup>1</sup> whereby the UNSC referred the situation in Libya since 15 February 2011 to the Prosecutor of the Court<sup>2</sup> and decided that the Libyan authorities “shall cooperate fully with and provide any necessary assistance to the Court”.<sup>3</sup>

2. On 27 June 2011, the “Decision on the ‘Prosecutor's Application Pursuant to Article 58 as to Muammar Mohammed Abu Minyar GADDAFI, Saif Al-Islam GADDAFI and Abdullah AL-SENUSSI” was issued by the Chamber (“Arrest Warrant Decision”),<sup>4</sup> as well as a warrant of arrest against, among others, Saif Al-Islam Gaddafi (“Mr Gaddafi”).<sup>5</sup> In the Arrest Warrant Decision, the Chamber decided that the Registry should prepare a request for cooperation asking for Libya’s assistance in arresting Mr Gaddafi, among others, and surrendering him to the Court.<sup>6</sup> This instruction was implemented by the Registry on 4 July 2011.<sup>7</sup>

3. A letter from the National Transitional Council (“NTC”) was transmitted to the Chamber on 23 November 2011, and the official English translation of this letter was formally put into the case record six days later.<sup>8</sup> This letter confirmed the arrest of Mr Gaddafi on 19 November 2011 in Libya.<sup>9</sup>

4. On 6 December 2011, a decision was issued<sup>10</sup> whereby the Chamber: (1) authorised the Office of Public Counsel for the Defence ("OPCD") to represent the interests of the Defence in all instances related to the proceedings against Mr Gaddafi in the present case until otherwise decided<sup>11</sup> and (2) sought submissions from Libya on, *inter alia*, "how, when and where could an expert be mandated by the Court to examine Saif Al-Islam Gaddafi in order to assess his physical and mental state".<sup>12</sup>

5. The Libyan authorities confidentially filed their response to the Chamber's inquiries on 23 January 2012.<sup>13</sup> In response to the Chamber's inquiry about receiving an expert to assess Mr Gaddafi's physical and mental state, the Libyan authorities indicated that "[t]he NTC is willing to facilitate an expert's visit to Saif Al-Islam Gaddafi at [sic] mutually convenient date and place to be agreed upon".<sup>14</sup>

6. From 29 February 2012 to 4 March 2012, pursuant to a decision of the Chamber ordering a visit to Libya,<sup>15</sup> a joint Registry-OPCD delegation visited Libya. A visit to Mr Gaddafi by part of this delegation took place on 3 March 2012. The OPCD filed reports regarding this visit on 2 March 2012<sup>16</sup> and 5 March 2012.<sup>17</sup> In the latter report, the OPCD informed the Chamber that Mr Gaddafi has very bad tooth pain and would like to have dental treatment.<sup>18</sup> The OPCD thus requested for the Chamber, *inter alia*, to provide Mr Gaddafi with immediate dental care, and medical care as necessary.<sup>19</sup>

7. The Registry filed its report regarding the visit to Libya on 6 March 2012 ("Registry Visit Report").<sup>20</sup> The Registry Visit Report mentioned that, during their visit to Mr Gaddafi, he was missing a portion of his thumb and index finger on his right hand.<sup>21</sup>

### **Applicable Law and Discussion**

8. The Chamber, in accordance with article 21 of the Statute, has considered articles 13(b), 58, 86, 87 and 93 of the Rome Statute ("Statute"), article 25 and Chapter VII of the United Nations Charter<sup>22</sup> and Resolution 1970 adopted by the UNSC.<sup>23</sup>

9. The Chamber notes that both the OPCD and the Registry have indicated that Mr Gaddafi is in need of some medical care after seeing him in Zintan on 3 March 2012.

10. Given the observations of the OPCD and Registry of Mr Gaddafi's current condition and the Libyan authorities' previous willingness to allow for a medical professional to examine Mr Gaddafi, the Chamber considers that medical care should be arranged for Mr Gaddafi. The Registry will need to organize, in consultation with the Libyan authorities, the visit of the appropriate medical experts.

11. All other outstanding OPCD requests for relief made in their recent submissions will be addressed by the Chamber in due course.

### **FOR THESE REASONS**

**ORDERS** the Registry to immediately arrange with the Libyan authorities for one or more medical professionals to meet Saif Al-Islam Gaddafi in order to address the health concerns mentioned in paragraphs 6 and 7 of the present decision.






