# DIHEDRAL GROUP FRAMES WITH THE HAAR PROPERTY

ABSTRACT. We consider a unitary representation of the Dihedral group  $D_{2n} = \mathbb{Z}_n \rtimes \mathbb{Z}_2$ obtained by inducing the trivial character from the co-normal subgroup  $\{0\} \rtimes \mathbb{Z}_2$ . This representation is naturally realized as acting on the vector space  $\mathbb{C}^n$ . We prove that the orbit of almost every vector in  $\mathbb{C}^n$  with respect to the Lebesgue measure has the Haar property (every subset of cardinality n of the orbit is a basis for  $\mathbb{C}^n$ ) if n is an odd integer. Moreover, we provide explicit sufficient conditions for vectors in  $\mathbb{C}^n$  whose orbits have the Haar property. Finally, we derive that the orbit of almost every vector in  $\mathbb{C}^n$  under the action of the representation has the Haar property if and only if n is odd. This completely settles a problem which was only partially answered in [7].

### 1. INTRODUCTION

Let  $\mathfrak{F}$  be a set of  $m \geq n$  vectors in an *n*-dimensional vector space  $\mathbb{C}^n$  over  $\mathbb{C}$ . We say that  $\mathfrak{F}$  has the **Haar property** or is **a full spark frame** if any subset of  $\mathfrak{F}$  of cardinality *n* is a basis for  $\mathbb{C}^n$ . We recall that a set  $\mathfrak{F}$  of vectors contained in  $\mathbb{C}^n$  is called a **frame** for  $\mathbb{C}^n$  [3] if  $\mathfrak{F}$  is a spanning set for the vector space  $\mathbb{C}^n$ . Moreover, it is well-known that a countable family of vectors  $\mathfrak{F} = (v_k)_{k \in I}$  is a frame for  $\mathbb{C}^n$  if and only if there exist positive constants A, B > 0 such that

$$A \|v\|_{\mathbb{C}^n}^2 \le \sum_{k \in I} \langle v, v_k \rangle_{\mathbb{C}^n} \le B \|v\|_{\mathbb{C}^n}^2$$

for every vector  $v \in \mathbb{C}^n$ . Let

$$T: \mathbb{C}^{\operatorname{card}(I)} \to \mathbb{C}^n, T(c) = \sum_{k \in I} c_k v_k$$

be the synthesis operator corresponding to  $\mathfrak{F}$ . The adjoint of T also known as the analysis operator is defined as follows

$$T^*: \mathbb{C}^n \to \mathbb{C}^{\operatorname{card}(I)}, \ T^*v = (\langle v, v_k \rangle_{\mathbb{C}^n})_{k \in I}.$$

The composition of the synthesis operator with its adjoint

$$S: \mathbb{C}^n \to \mathbb{C}^n, \ Sv = \sum_{k \in I} \langle v, v_k \rangle_{\mathbb{C}^n} v_k$$

is called the frame operator. It is a well-known fact [3] that if  $\mathfrak{F} = (v_k)_{k \in I}$  is a frame then S is a self-adjoint invertible operator and every vector  $v \in \mathbb{C}^n$  can be represented as

$$v = \sum_{k \in I} \langle v, v_k \rangle_{\mathbb{C}^n} S^{-1} v_k$$

In other words, any vector v can be reconstructed from the sequence  $(\langle v, v_k \rangle_{\mathbb{C}^n})_{k \in I}$ . In fact if K is a proper subset of I such that  $(v_k)_{k \in K}$  is also a frame then any vector v can be reconstructed from the sequence  $(\langle v, v_k \rangle_{\mathbb{C}^n})_{k \in K}$ . Thus, full spark frames are very flexible basis-like tools in the sense that if  $(v_k)_{k \in I}$  is a full spark frame, then for any subset J of I of cardinality n, every vector  $v \in \mathbb{C}^n$  can be uniquely represented as

$$v = \sum_{k \in J} \langle v, v_k \rangle_{\mathbb{C}^n} S_J^{-1} v_k \text{ with } S_J v = \sum_{k \in J} \langle v, v_k \rangle_{\mathbb{C}^n} v_k.$$

We shall now present some examples of full spark frames induced from the action of group representations. Let  $\mathbb{H}_n < GL(n, \mathbb{C})$  be the Heisenberg group which is a finite group generated by

$$T = \begin{bmatrix} 0 & 0 & \cdots & 0 & 1 \\ 1 & 0 & \cdots & 0 & 0 \\ 0 & 1 & \ddots & \vdots & \vdots \\ \vdots & \ddots & \ddots & 0 & 0 \\ 0 & \cdots & 0 & 1 & 0 \end{bmatrix} \text{ and } M = \begin{bmatrix} 1 & \exp\left(\frac{2\pi i}{n}\right) & \exp\left(\frac{4\pi i}{n}\right) & \\ & & & \ddots & \\ & & & & \exp\left(\frac{2\pi i(n-1)}{n}\right) \end{bmatrix}.$$

It is shown in [6, 8] that for almost every vector  $v \in \mathbb{C}^n$  (with respect to Lebesgue measure) the collection

$$\left\{T^{\ell}M^{\kappa}v: (\ell,\kappa) \in \mathbb{Z}_n \times \mathbb{Z}_n\right\}$$

is a full spark frame. Next, let n be a natural number greater than two. Let  $D_{2n}$  be the Dihedral group generated by  $T, D \in GL(n, \mathbb{C})$  where

(1.1) 
$$T = \begin{bmatrix} 0 & 0 & \cdots & 0 & 1 \\ 1 & 0 & \cdots & 0 & 0 \\ 0 & 1 & \ddots & \vdots & \vdots \\ \vdots & \ddots & \ddots & 0 & 0 \\ 0 & \cdots & 0 & 1 & 0 \end{bmatrix}, D = \begin{bmatrix} 1 & 0 & \cdots & 0 & 0 \\ 0 & 0 & \cdots & 0 & 1 \\ \vdots & \vdots & & & 0 \\ 0 & 0 & 1 & & \vdots \\ 0 & 1 & 0 & \cdots & 0 \end{bmatrix}.$$

It is proved in [7] that if n is even then it is not possible to find a full spark frame of the type  $D_{2n}v$ . Moreover, if n is prime then there exists a Zariski open subset  $\Omega$  of  $\mathbb{C}^n$  such that  $D_{2n}v$  is a full spark frame for every vector v in  $\Omega$ . While this result establishes the existence of vectors v such that  $D_{2n}v$  has the Haar property when n is prime, the work in [7] is not constructive. Moreover, the case where n is odd but not prime was left open in [7]. The main objective of the present paper is to fill this gap by settling the following. Let n be an odd number which is not necessarily odd.

#### HAAR PROPERTY

- Is there a vector  $v \in \mathbb{C}^n$  such that  $D_{2n}v$  has the Haar property?
- Can we provide an explicit construction of a vector  $v \in \mathbb{C}^n$  such that  $D_{2n}v$  has the Haar property?

1.1. **Main results.** Here is a summary of our results. For a fixed natural number n > 2, we define  $F_n \subset \mathbb{C}^n$  such that (1.2)

$$\mathcal{F}_{n} = \left\{ \begin{array}{c} w \in \mathbb{C}^{n} : w = \begin{bmatrix} \sum_{k=0}^{n-1} \lambda^{k} \\ \sum_{k=0}^{n-1} \lambda^{k} e^{-\frac{2\pi k i}{n}} \\ \vdots \\ \sum_{k=0}^{n-1} \lambda^{k} e^{-\frac{2\pi k (n-1) i}{n}} \end{bmatrix} \\ \text{where } \lambda \text{ is a either transcendal} \\ \text{or an algebraic number over } \mathbb{Q}\left(\frac{2\pi i}{n}\right) \text{ whose degree is at least } n^{2} - n + 1 \end{array} \right\}.$$

**Theorem 1.** If n is odd and  $w \in F_n$  then  $D_{2n}w$  is a full spark frame.

Suppose now that G is a finite group of matrices of order m acting on  $\mathbb{C}^n$ . Moreover, let us assume that the order of G is greater than or equal to n. It is not hard to verify that if there exists one vector w in  $\mathbb{C}^n$  such that the orbit of w under the action of G has the Haar property then for almost every vector v (with respect to Lebesgue measure) in  $\mathbb{C}^n$ , the orbit of v under the action of G has the Haar property. Indeed, assume that there exists a vector w in  $\mathbb{C}^n$  such that Gw has the Haar property. Consider the matrix-valued function

(1.3) 
$$v \mapsto O(v) = \begin{bmatrix} (g_1v)_0 & \cdots & (g_1v)_{n-1} \\ \vdots & \ddots & \vdots \\ (g_mv)_0 & \cdots & (g_mv)_{n-1} \end{bmatrix}.$$

By assumption, there exists an element O(w) in the range of the function above such that any sub-matrix of order n of O(w) has a non-zero determinant. Let  $P_n$  be the set of all submatrices of O(v) of order n. Next, let p(v) be the least common multiple of all polynomials obtained by computing the determinant of X(v) where  $X(v) \in P_n$ . That is,

$$p(v) = \operatorname{lcm}(\{\det(X(v)) : X(v) \in P_n\})$$

Clearly w is not a zero for the polynomial p. Next, let W be an open set around  $p(w) \neq 0$ such that W does not contain zero. Since p is continuous, the inverse image of the open set W under the map p is an open subset of  $\mathbb{C}^n$ . So, there exists an open subset of  $\mathbb{C}^n$ containing w which is disjoint from the zero set of p. This implies that p is not the zero polynomial. Since the zero set of p is a co-null set with respect to the Lebesgue measure on  $\mathbb{C}^n$ , it immediately follows that for almost every vector v in  $\mathbb{C}^n$ , the set Gv has the Haar property. From the preceding discussion, the following is immediate.

**Corollary 2.** Let n be an odd natural number greater than two. There exists a Zariski open subset  $\Omega \subset \mathbb{C}^n$  such that if  $v \in \Omega$  then  $D_{2n}v$  is a full spark frame.

Finally, a direct application of the results in [7] and Theorem 1 together with Corollary 2 gives the following.

**Corollary 3.** The  $D_{2n}$ -orbit of almost every vector (with respect to the Lebesgue measure) in  $\mathbb{C}^n$  is a full spark frame if and only if n is odd.

The paper is organized as follows. In the second section, we fix notation and we review a variety of relevant concepts. The third section contains intermediate results leading to the proof of the main result which is given in the last section.

### 2. Preliminaries

Let us start by fixing notation. Given a matrix M, the transpose of M is denoted  $M^T$ . The determinant of a matrix M is denoted by det(M) or |M|. The k-th row of M is denoted row<sub>k</sub> (M) and similarly, the k-th column of the matrix M is denoted  $col_k (M)$ . Let G be a group acting on a set S. We denote this action multiplicatively. For any fixed element  $s \in S$ , the G-orbit of s is described as  $Gs = \{gs : g \in G\}$ .

2.1. Fourier Analysis on  $\mathbb{Z}_n$ . Let  $\mathbb{Z}_n = \{0, 1, \dots, n-1\}$ . Let  $l^2(\mathbb{Z}_n) = \{f : \mathbb{Z}_n \to \mathbb{C}\}$  be the vector space of all complex-valued functions on  $\mathbb{Z}_n$  endowed with the dot product

$$\langle \phi, \psi \rangle = \sum_{x \in \mathbb{Z}_n} \phi(x) \overline{\psi(x)} \text{ for } \phi, \psi \in l^2(\mathbb{Z}_n).$$

The norm of a given vector  $\phi$  in  $l^2(\mathbb{Z}_n)$  is computed as follows  $\|\phi\|_{l^2(\mathbb{Z}_n)} = \langle \phi, \phi \rangle^{1/2}$ . We recall that the discrete Fourier transform is a map  $\mathcal{F} : l^2(\mathbb{Z}_n) \to l^2(\mathbb{Z}_n)$  defined by

$$\left[\mathcal{F}\phi\right](\xi) = \frac{1}{n^{1/2}} \sum_{k \in \mathbb{Z}_n} \phi(k) \exp\left(\frac{2\pi i k\xi}{n}\right), \text{ for } \phi \in l^2(\mathbb{Z}_n).$$

The following facts are also well-known [10].

- The discrete Fourier transform is a bijective linear operator.
- The Fourier inverse of a vector  $\varphi$  is given by

$$\left[\mathcal{F}^{-1}\varphi\right](k) = \frac{1}{n^{1/2}} \sum_{\xi \in \mathbb{Z}_n} \varphi\left(\xi\right) \exp\left(-\frac{2\pi i k\xi}{n}\right)$$

• The Fourier transform is a unitary operator. More precisely, given  $\phi, \psi \in l^2(\mathbb{Z}_n)$ , we have  $\langle \phi, \psi \rangle = \langle \mathcal{F}\phi, \mathcal{F}\psi \rangle$ .

The following is proved in [4].

**Lemma 4.** Let  $\mathbf{F}$  be the matrix representation of the Fourier transform. If n is prime then every minor of  $\mathbf{F}$  is nonzero.

#### HAAR PROPERTY

Identifying 
$$l^2(\mathbb{Z}_n)$$
 with  $\mathbb{C}^n$  via the map  $v \mapsto \begin{bmatrix} v(0) & \cdots & v(n-1) \end{bmatrix}^T$ , we may write  $(Tv)(j) = v((j-1) \mod n)$  and  $(Dv)(j) = v((n-j) \mod n)$ .

It is not hard to verify that for any  $\xi \in \mathbb{Z}_n$ , we have  $[\mathcal{F}Bv](\xi) = (\mathcal{F}v)((n-\xi) \mod n)$ and  $[\mathcal{F}Av](\xi) = e^{\frac{2\pi i}{n}\xi}(\mathcal{F}v)(\xi)$ . Next, let **F** be the matrix representation of the Fourier transform with respect to the canonical basis of  $\mathbb{C}^n$ . The matrix *T* is diagonalizable and its Jordan canonical form is obtained by conjugating *T* by the discrete Fourier matrix. More precisely if  $M = \mathbf{F}T\mathbf{F}^{-1}$  then the  $k^{th}$  diagonal entry of *M* is given by  $M_{kk} = e^{\frac{2(k-1)\pi i}{n}}$ . Finally, it is worth noting that *D* commutes with the Fourier matrix **F**.

2.2. **Determinants.** ([5], Section 3.7) Let X be a square matrix of order n. A minor of X is the determinant of any square sub-matrix Y of X. Let  $|Y| = \det Y$  be an m-rowed minor of X. The determinant of the sub-matrix obtained by deleting from X the rows and columns represented in Y is called the complement of |Y| and is denoted  $|Y^c| = \det(Y^c)$ . Let |Y| be the m-rowed minor of X in which rows  $i_1, \dots, i_m$  and columns  $j_1, \dots, j_m$  are represented. Then the algebraic complement, or cofactor of |Y| is given by  $(-1)^{\sum_{k=1}^m i_k + \sum_{k=1}^m j_k} |Y^c|$ . According to **Laplace's Expansion Theorem** (see 3.7.3, [5]) a formula for the determinant of X can be obtained as follows. Let T(n, p) be the set of all ordered sets of cardinality p of the type  $s = \{0 \leq s_1 < s_2 < \cdots < s_p \leq n-1\}$ . Given any two elements s and t in T(n, p), we define X(s, t) to be the sub-matrix of X of order p such that  $X(s, t)_{i,j} = X_{s_i+1,t_j+1}$ . According to Laplace's Expansion Theorem, once we fix an ordered set t in T(n, p), the determinant of X can be computed via the following expansion

(2.1) 
$$\sum_{s \in T(n,p)} (-1)^{\sum_{k=1}^{p} (s_k+1) + \sum_{k=1}^{p} (t_{k+1})} \det (X(t,s)) \det (X(t,s)^c)$$

The following well-known result will also be useful to us.

# Lemma 5. (Page 127, [5]) Let

$$V = \begin{bmatrix} 1 & a_1 & a_1^2 & \cdots & a_1^{n-1} \\ 1 & a_2 & a_2^2 & \cdots & a_2^{n-1} \\ \vdots & \vdots & \vdots & \cdots & \vdots \\ 1 & a_n & a_n^2 & \cdots & a_n^{n-1} \end{bmatrix}$$

be a Vandermonde matrix. Then

(2.2) 
$$\det(V) = \prod_{1 \le j < k \le n} (a_k - a_j)$$

# 3. INTERMEDIATE RESULTS

In this section, we will prove several results which lead to the proof of Theorem 1. Put (3.1)  $\xi = e^{\frac{2\pi i}{n}}.$ 

#### V. OUSSA

Let  $\iota(k)$  is be the inverse of k modulo n. That is  $\iota(k) = (n-k) \mod n$ . Let M be the linear operator obtained by conjugating T by the Fourier transform. Let  $\Lambda$  be the group of linear operators generated by M and D. Fixing an ordering for the elements of  $\Lambda$ , we may write  $\Lambda = \{\gamma_1, \dots, \gamma_{2n}\}$ . We identify the Hilbert space  $l^2(\mathbb{Z}_n)$  in the usual way with the Cartesian product of n copies of the complex plane. For any  $z \in \mathbb{C}^n$ , we define the map  $z \mapsto A(z)$  where A(z) is the 2n by n matrix-valued function whose  $k^{th}$  row corresponds to the vector  $\gamma_k z$  which is an element of the  $\Lambda$ -orbit of z. From our definition, A is regarded as a matrix-valued function taking the vector z to the matrix

$$A(z) = \begin{bmatrix} (\gamma_1 z)_0 & \cdots & (\gamma_1 z)_{n-1} \\ \vdots & \ddots & \vdots \\ (\gamma_{2n} z)_0 & \cdots & (\gamma_{2n} z)_{n-1} \end{bmatrix}.$$

Let S(z) be a fixed submatrix of A(z) of order n. Fixing an ordering for the rows of S(z), we may assume that the following holds true.

**Case** (a): Either

(3.2) 
$$S(z) = \begin{bmatrix} z_0 & z_1 & \cdots & z_{n-1} \\ z_0 & \xi z_1 & \cdots & \xi^{(n-1)} z_{n-1} \\ \vdots & \ddots & \ddots & \vdots \\ z_0 & \xi^{(n-1)} z_1 & \cdots & \xi^{(n-1)(n-1)} z_{n-1} \end{bmatrix}$$

or

(3.3) 
$$S(z) = \begin{bmatrix} z_0 & z_{\iota(1)} & \cdots & z_{i(n-1)} \\ z_0 & \xi z_{\iota(1)} & \cdots & \xi^{(n-1)} z_{i(n-1)} \\ \vdots & \ddots & \ddots & \vdots \\ z_0 & \xi^{(n-1)} z_{\iota(1)} & \cdots & \xi^{(n-1)(n-1)} z_{i(n-1)} \end{bmatrix}$$

**Case** (b): or S(z) is equal to

$$\begin{bmatrix} z_{0} & \xi^{1l_{0}}z_{1} & \cdots & \xi^{(m-1)l_{0}}z_{m-1} & \xi^{ml_{0}}z_{m} & \xi^{(m+1)l_{0}}z_{m+1} & \cdots & \xi^{(n-1)l_{0}}z_{n-1} \\ z_{0} & \xi^{1l_{1}}z_{1} & \cdots & \xi^{(m-1)l_{1}}z_{m-1} & \xi^{ml_{1}}z_{m} & \xi^{(m+1)l_{1}}z_{m+1} & \cdots & \xi^{(n-1)l_{1}}z_{n-1} \\ \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ z_{0} & \xi^{1l_{m-1}}z_{1} & \cdots & \xi^{(m-1)l_{m-1}}z_{m-1} & \xi^{ml_{m-1}}z_{m} & \xi^{(m+1)l_{m-1}}z_{m+1} & \cdots & \xi^{(n-1)l_{m-1}}z_{n-1} \\ z_{0} & \xi^{1j_{0}}z_{\iota(1)} & \cdots & \xi^{(m-1)j_{0}}z_{\iota(m-1)} & \xi^{mj_{0}}z_{\iota(m)} & \xi^{(m+1)j_{0}}z_{\iota(m+1)} & \cdots & \xi^{(n-1)j_{0}}z_{i(n-1)} \\ z_{0} & \xi^{1j_{1}}z_{\iota(1)} & \cdots & \xi^{(m-1)j_{1}}z_{\iota(m-1)} & \xi^{mj_{1}}z_{\iota(m)} & \xi^{(m+1)j_{1}}z_{\iota(m+1)} & \cdots & \xi^{(n-1)j_{1}}z_{i(n-1)} \\ \vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots \\ z_{0} & \xi^{1j_{s-1}}z_{\iota(1)} & \cdots & \xi^{(m-1)j_{s-1}}z_{\iota(m-1)} & \xi^{mj_{s-1}}z_{\iota(m)} & \xi^{(m+1)j_{s-1}}z_{\iota(m+1)} & \cdots & \xi^{(n-1)j_{s-1}}z_{i(n-1)} \end{bmatrix}$$

for some integers  $l_0, \dots, l_{m-1}, j_0, j_1, \dots, j_{s-1}$  such that m + s = n, if  $k \neq k'$  then  $l_k \neq l_{k'}$  and if  $k \neq k'$  then  $j_k \neq j_{k'}$ .

Let  $\mathbf{q}$  be the non-trivial polynomial defined by

(3.5) 
$$\mathbf{q}(t) = \prod_{k=1}^{n-1} t^k.$$

3.1. Case (a). Let us consider the complex curve

(3.6) 
$$\mathbb{C} \ni t \mapsto \mathfrak{c}(t) = \begin{bmatrix} 1 & t & t^2 & \cdots & t^{n-1} \end{bmatrix}^T \in \mathbb{C}^n.$$

The image of this curve under the function S is simply computed by replacing each variable  $z_k$  by  $t^k$ . If we assume that S(z) is equal to the first matrix described in Case (a) then (3.7)

$$\det\left(S\left(1,t,t^{2},\cdots,t^{n-1}\right)\right) = \mathbf{q}\left(t\right) \begin{vmatrix} 1 & 1 & \cdots & 1\\ 1 & \xi & \cdots & \xi^{(n-1)}\\ 1 & \xi^{2} & \cdots & \xi^{2(n-1)}\\ \vdots & \ddots & \ddots & \vdots\\ 1 & \xi^{(n-1)} & \cdots & \xi^{(n-1)(n-1)} \end{vmatrix} = \left(\prod_{0 \le j < k \le n-1} \left(\xi^{k} - \xi^{j}\right)\right) \times \prod_{k=1}^{n-1} t^{k}$$

In a similar fashion, it is easy to verify that if S(z) is equal to the second matrix described in Case (a) then

$$\det\left(S\left(1,t,t^{2},\cdots,t^{n-1}\right)\right) = \left(\prod_{0 \le j < k \le n-1} \left(\xi^{k} - \xi^{j}\right)\right) \times \mathbf{q}\left(t\right).$$

Thus, the determinants of the matrices described in Case (a) are non-zero polynomials.

3.2. Case (b). Define matrices  $A_1(t)$ ,  $A_2(t)$  as

$$\begin{bmatrix} \xi^{0l_0}t & \cdots & \xi^{(m-1)l_0}t^{m-1} \\ \xi^{0l_1}t & \cdots & \xi^{(m-1)l_1}t^{m-1} \\ \vdots & \ddots & \vdots \\ \xi^{0l_{m-1}}t & \cdots & \xi^{(m-1)l_{m-1}}t^{m-1} \end{bmatrix}, \begin{bmatrix} \xi^{ml_0}t^m & \xi^{(m+1)l_0}t^{m+1} & \cdots & \xi^{(n-1)l_0}t^{n-1} \\ \xi^{ml_1}t^m & \xi^{(m+1)l_1}t^{m+1} & \cdots & \xi^{(n-1)l_1}t^{n-1} \\ \vdots & \vdots & \ddots & \vdots \\ \xi^{ml_{m-1}}t^m & \xi^{(m+1)l_{m-1}}t^{m+1} & \cdots & \xi^{(n-1)l_{m-1}}t^{n-1} \end{bmatrix}$$

respectively. Additionally, we define  $A_{3}(t)$ , and  $A_{4}(t)$  as

$$\begin{bmatrix} \xi^{0 \times j_0} t^{n-1} & \cdots & \xi^{(m-1)j_0} t^{n-(m-1)} \\ \xi^{0 \times j_1} t^{n-1} & \cdots & \xi^{(m-1)j_1} t^{n-(m-1)} \\ \vdots & \ddots & \vdots \\ \xi^{0 \times j_{s-1}} t^{n-1} & \cdots & \xi^{(m-1)j_{s-1}} t^{n-(m-1)} \end{bmatrix} \text{ and } \begin{bmatrix} \xi^{mj_0} t^{n-m} & \xi^{(m+1)j_0} t^{n-m-1} & \cdots & \xi^{(n-1)j_0} t \\ \xi^{mj_1} t^{n-m} & \xi^{(m+1)j_1} t^{n-m-1} & \cdots & \xi^{(n-1)j_1} t \\ \vdots & \vdots & \ddots & \vdots \\ \xi^{mj_{s-1}} t^{n-m} & \xi^{m+1j_{s-1}} t^{n-m-1} & \cdots & \xi^{(n-1)j_{s-1}} t \end{bmatrix}$$

respectively. Note that  $A_1(t)$  is a square matrix of order m,  $A_4(t)$  is a square matrix of order n - m = s,  $A_2(t)$  and  $A_3(t)$  are matrices of order  $m \times s$  and  $s \times m$  respectively. If we assume that S(z) is as described in Case (b) then  $S(\mathfrak{c}(t))$  is given in block form as follows

$$(3.8) \qquad \qquad \begin{bmatrix} A_1(t) & A_2(t) \\ A_3(t) & A_4(t) \end{bmatrix}$$

Lemma 6. The following holds true.

(1) det 
$$A_1(t) = \prod_{\substack{0 \le k < j \le m-1 \\ 0 \le k < j \le m-1 \end{pmatrix}} \left( \xi^{l_j} - \xi^{l_k} \right) (t \cdots t^{m-1}).$$
  
(2) det  $A_4(t) = (\xi^{mj_0} \xi^{mj_1} \cdots \xi^{mj_{s-1}}) \prod_{\substack{0 \le k < j \le n-1-m \\ 0 \le k < j \le n-1-m }} (\xi^{j_\ell} - \xi^{j_k}) (t^{n-m} t^{n-m-1} \cdots t^2 t).$ 

*Proof.* The multi-linearity of the determinant function together with Formula (2.2) give the desired result.

Let  $\mathbf{p}_m = \{p_1 < p_2 < \dots < p_{m-1} < p_m\}$  be an ordered subset of  $\mathbb{Z}_n$  of cardinality m and set (3.9)  $\mathbf{i}_m = \{0 < 1 < \dots < m-1\}.$ 

Let  $S(\mathbf{c}(t))$  be the matrix given in (3.8). To avoid cluster of notation, from now on, we shall write  $S(\mathbf{c}(t)) = \mathbf{S}_t$ . Put

(3.10) 
$$C = \left(\xi^{mj_0}\xi^{mj_1}\cdots\xi^{mj_{s-1}}\right) \prod_{0 \le k < \ell \le n-1-m} \left(\xi^{j_\ell} - \xi^{j_k}\right) \prod_{0 \le k < j \le m-1} \left(\xi^{l_j} - \xi^{l_k}\right) \in \mathbb{Q}\left(\xi\right).$$

For  $n, m \in \mathbb{N}$  such that n > 2 and  $m \leq n$ , define

$$\kappa_{(n,m)} = \sum_{k=1}^{m-1} (k) + \sum_{k=1}^{n-m} (k) = \frac{1}{2}m(m-1) - \frac{1}{2}(m-n)(n-m+1)$$
$$= \frac{2m^2 - 2mn - 2m + n^2 + n}{2} \in \mathbb{N}.$$

**Lemma 7.** The product of the determinants of  $\mathbf{S}_t(\mathbf{i}_m, \mathbf{i}_m)$  and  $\mathbf{S}_t(\mathbf{i}_m, \mathbf{i}_m)^c$  is equal to the non-trivial polynomial  $Ct^{\kappa_{(n,m)}}$ .

*Proof.* We check that the determinant of the matrix  $\mathbf{S}_t(\mathbf{i}_m, \mathbf{i}_m)$  is a monomial in the variable t which is given by

(3.11) 
$$(t \cdots t^{m-1}) \cdot \prod_{0 \le k < j \le m-1} \left( \xi^{l_j} - \xi^{l_k} \right).$$

Moreover, the determinant of  $[\mathbf{S}_t(\mathbf{i}_m, \mathbf{i}_m)]^c$  is given by

(3.12) 
$$\left(\xi^{mj_0}\xi^{mj_1}\cdots\xi^{mj_{s-1}}\right) \cdot \prod_{0 \le k < \ell \le n-1-m} \left(\xi^{j_\ell} - \xi^{j_k}\right) \cdot t^{n-m} t^{n-m-1} \cdots t^2 t.$$

In summary, taking the product of (3.11) and (3.12) we obtain  $Ct^{\kappa_{(n,m)}}$ . Moreover, since  $\xi^{j_{\ell}} - \xi^{j_k} \neq 0$  and  $\xi^{l_j} - \xi^{l_k} \neq 0$  for  $0 \leq k < j \leq n - 1 - m$  and  $0 \leq k < j \leq m - 1$ , it must be case that the monomial  $Ct^{\kappa_{(n,m)}}$  is a non-trivial polynomial.

Observe that  $\mathbf{p}_m = (\mathbf{i}_m \cap \mathbf{p}_m) \cup (\mathbf{p}_m - \mathbf{i}_m)$  and  $\mathbf{p}_m - \mathbf{i}_m$  and  $\mathbf{i}_m - \mathbf{p}_m$  are subsets of  $\mathbb{Z}_n$  of the same cardinality. Furthermore if  $\mathbf{p}_m$  and  $\mathbf{i}_m$  are not equal as sets, we shall write  $\mathbf{i}_m = (\mathbf{i}_m \cap \mathbf{p}_m) \cup (\mathbf{i}_m - \mathbf{p}_m)$  and

$$\mathbf{i}_m - \mathbf{p}_m = \left\{ \mathbf{i}_1 < \dots < \mathbf{i}_{u(\mathbf{p}_m)} \right\}, \\ \mathbf{p}_m - \mathbf{i}_m = \left\{ \mathbf{i}_1 + \ell_1 \left( \mathbf{p}_m \right) < \dots < \mathbf{i}_{u(\mathbf{p}_m)} + \ell_{u(\mathbf{p}_m)} \left( \mathbf{p}_m \right) \right\}$$

such that each  $\ell_k(\mathbf{p}_m)$  is a positive number belonging to the set  $\mathbb{Z}_n$ , and  $u(\mathbf{p}_m) = |\mathbf{i}_m - \mathbf{p}_m| > 0$ . We recall that  $\mathbf{S}_t(\mathbf{i}_m, \mathbf{p}_m)$  is the matrix obtained by selecting all entries of the matrix  $\mathbf{S}_t$  of the type  $[\mathbf{S}_t]_{k,k'}$  where k-1 is in  $\mathbf{i}_m$  and k'-1 is an element of  $\mathbf{p}_m$ .

Lemma 8. If n is odd then

$$\det \left( \mathbf{S}_{t} \left( \mathbf{i}_{m}, \mathbf{p}_{m} \right) \right) \det \left( \mathbf{S}_{t} \left( \mathbf{i}_{m}, \mathbf{p}_{m} \right)^{c} \right) = C t^{\kappa_{(n,m)}} \Longleftrightarrow \mathbf{i}_{m} = \mathbf{p}_{m}$$

*Proof.* According to Lemma 7, if  $\mathbf{i}_m = \mathbf{p}_m$  then

$$\det \left( \mathbf{S}_{t} \left( \mathbf{i}_{m}, \mathbf{p}_{m} \right) \right) \det \left( \mathbf{S}_{t} \left( \mathbf{i}_{m}, \mathbf{p}_{m} \right)^{c} \right) = C t^{\kappa_{(n,m)}}.$$

For the other way around, let us suppose that  $\mathbf{i}_m \neq \mathbf{p}_m$ . Then  $u(\mathbf{p}_m) = \operatorname{card}(\mathbf{i}_m - \mathbf{p}_m) > 0$ . First, we observe that, there exists integer  $\delta$  and a complex number q such that

$$\det \left( \mathbf{S}_t \left( \mathbf{i}_m, \mathbf{p}_m \right) \right) \det \left( \mathbf{S}_t \left( \mathbf{i}_m, \mathbf{p}_m \right)^c \right) = q t^{\delta}.$$

Secondly, the monomial  $t^{\delta}$  can be computed by multiplying

$$t^{\kappa_{(n,m)}} = \left(t \cdots t^{m-1}\right) \left(t^{n-m} t^{n-(m+1)} \cdots t^2 t\right)$$

by a suitable rational function of the variable t. Indeed, since the set  $\mathbf{p}_m$  is obtained by taking the union of  $\mathbf{i}_m \cap \mathbf{p}_m$  and  $\mathbf{p}_m - \mathbf{i}_m$ , the above-mentioned monomial  $t^{\delta}$  is the product of  $(t \cdots t^{m-1}) (t^{n-m} t^{n-(m+1)} \cdots t^2 t)$  and r(t) where

$$r(t) = \frac{t^{\sum_{k \in \iota(\mathbf{i}_m - \mathbf{p}_m) \cup \mathbf{p}_m - \mathbf{i}_m(k)}}}{t^{\sum_{k \in (\mathbf{i}_m - \mathbf{p}_m) \cup \iota(\mathbf{p}_m - \mathbf{i}_m)(k)}}}$$

Next, it is clear that  $r(t) = t^{\sigma}$  for some integer  $\sigma$ , and  $\sigma$  is computed as follows. If zero is an element of  $\mathbf{i}_m - \mathbf{p}_m$  then

$$\begin{aligned} \sigma &= \sum_{k=1}^{u(\mathbf{p}_m)} \iota \left( \mathbf{i}_k \right) + \left( \mathbf{i}_k + \ell_k \left( \mathbf{p}_m \right) \right) - \sum_{k=1}^{u(\mathbf{p}_m)} \mathbf{i}_k + \iota \left( \mathbf{i}_k + \ell_k \left( \mathbf{p}_m \right) \right) \\ &= \iota \left( \mathbf{i}_1 \right) + \left( \mathbf{i}_1 + \ell_1 \left( \mathbf{p}_m \right) \right) + \sum_{k=2}^{u(\mathbf{p}_m)} \iota \left( \mathbf{i}_k \right) + \left( \mathbf{i}_k + \ell_k \left( \mathbf{p}_m \right) \right) - \sum_{k=1}^{u(\mathbf{p}_m)} \mathbf{i}_k + \iota \left( \mathbf{i}_k + \ell_k \left( \mathbf{p}_m \right) \right) \\ &= \iota \left( \mathbf{i}_1 \right) + \left( \mathbf{i}_1 + \ell_1 \left( \mathbf{p}_m \right) \right) - \mathbf{i}_1 - \iota \left( \mathbf{i}_1 + \ell_1 \left( \mathbf{p}_m \right) \right) \\ &+ \sum_{k=2}^{u(\mathbf{p}_m)} \iota \left( \mathbf{i}_k \right) + \left( \mathbf{i}_k + \ell_k \left( \mathbf{p}_m \right) \right) - \sum_{k=2}^{u(\mathbf{p}_m)} \mathbf{i}_k + \iota \left( \mathbf{i}_k + \ell_k \left( \mathbf{p}_m \right) \right) \\ &= (*) \end{aligned}$$

Next,

$$\begin{aligned} (*) &= \ell_{1} \left( \mathbf{p}_{m} \right) - \iota \left( \ell_{1} \left( \mathbf{p}_{m} \right) \right) + \sum_{k=2}^{u(\mathbf{p}_{m})} \left( \iota \left( \mathbf{i}_{k} \right) + \left( \mathbf{i}_{k} + \ell_{k} \left( \mathbf{p}_{m} \right) \right) \right) - \left( \mathbf{i}_{k} + \iota \left( \mathbf{i}_{k} + \ell_{k} \left( \mathbf{p}_{m} \right) \right) \right) \\ &= \ell_{1} \left( \mathbf{p}_{m} \right) - \left( n - \ell_{1} \left( \mathbf{p}_{m} \right) \right) + \sum_{k=2}^{u(\mathbf{p}_{m})} \left( \iota \left( \mathbf{i}_{k} \right) + \left( \mathbf{i}_{k} + \ell_{k} \left( \mathbf{p}_{m} \right) \right) \right) - \left( \mathbf{i}_{k} + \iota \left( \mathbf{i}_{k} + \ell_{k} \left( \mathbf{p}_{m} \right) \right) \right) \\ &= \ell_{1} \left( \mathbf{p}_{m} \right) - \left( n - \ell_{1} \left( \mathbf{p}_{m} \right) \right) + \sum_{k=2}^{u(\mathbf{p}_{m})} 2\ell_{k} \left( \mathbf{p}_{m} \right) \\ &= -n + 2\ell_{1} \left( \mathbf{p}_{m} \right) + \sum_{k=2}^{u(\mathbf{p}_{m})} 2\ell_{k} \left( \mathbf{p}_{m} \right) \\ &= \left( \sum_{k=1}^{u(\mathbf{p}_{m})} 2\ell_{k} \left( \mathbf{p}_{m} \right) \right) - n. \end{aligned}$$

Since n is odd, the integer  $\sigma$  cannot be equal to zero. On the other hand, if zero is not an element of  $\mathbf{i} - \mathbf{p}$  then

$$\sigma = \sum_{k=1}^{u(\mathbf{p}_m)} n - \mathbf{i}_k + (\mathbf{i}_k + \ell_k(\mathbf{p}_m)) - \sum_{k=1}^{u(\mathbf{p}_m)} \mathbf{i}_k + n - (\mathbf{i}_k + \ell_k(\mathbf{p}_m))$$
  
= 
$$\sum_{k=1}^{u(\mathbf{p}_m)} (n - \mathbf{i}_k + (\mathbf{i}_k + \ell_k(\mathbf{p}_m))) - (\mathbf{i}_k + n - (\mathbf{i}_k + \ell_k(\mathbf{p}_m))) = \sum_{k=1}^{u(\mathbf{p}_m)} 2\ell_k(\mathbf{p}_m).$$

In this case, since each  $\ell_k(\mathbf{p}_m)$  is positive, r(t) must be a non-trivial homogeneous polynomial in the variable t. It follows that

$$\det \left( \mathbf{S}_t \left( \mathbf{i}_m, \mathbf{p}_m \right) \right) \det \left( \mathbf{S}_t \left( \mathbf{i}_m, \mathbf{p}_m \right)^c \right) = q \left( t \cdots t^{m-1} \right) \left( t^{n-m} t^{n-(m+1)} \cdots t^2 t \right) r \left( t \right)$$
$$= q \left( t \cdots t^{m-1} \right) \left( t^{n-m} t^{n-(m+1)} \cdots t^2 t \right) t^{\delta}$$

and  $\delta$  is a not equal to zero. Thus,

$$\det \left( \mathbf{S}_{t} \left( \mathbf{i}_{m}, \mathbf{p}_{m} \right) \right) \det \left( \mathbf{S}_{t} \left( \mathbf{i}_{m}, \mathbf{p}_{m} \right)^{c} \right) \neq C t^{\frac{2m^{2} - 2mn - 2m + n^{2} + n}{2}}.$$

# Lemma 9. The following holds true.

- (1) Every submatrix of order n of  $A(\mathbf{c}(t))$  is a non-vanishing element of the ring  $\mathbb{Q}(\xi)[t]$ .
- (2) Every submatrix of order n of  $A(\mathfrak{c}(t))$  is a non-vanishing element of the ring  $\mathbb{Q}(\xi)[t]$  of degree less than or equal to n(n-1).

*Proof.* For the first part, let  $S(\mathfrak{c}(t))$  be a submatrix of  $A(\mathfrak{c}(t))$  of order n. Assume that  $S(\mathfrak{c}(t))$  is given as shown in (3.8). Let

$$T(n,m) = \{s = \{0 \le s_1 < s_2 < \dots < s_m \le n-1\} \subseteq \mathbb{Z}_n\}.$$

We fix  $t \in T(n, m)$ . Put  $\mathbf{S}_t = S(\mathbf{c}(t))$ . According to Laplace's Expansion Theorem,

(3.13) 
$$\det (\mathbf{S}_t) = \det (\mathbf{S}_t (t, s)) = \sum_{s \in T(n, p)} (-1)^{|s| + |t|} \det (\mathbf{S}_t (t, s)) \det (\mathbf{S}_t (t, s)^c).$$

Next,

$$\det \left( \mathbf{S}_{t} \right) = \det \left( \mathbf{S}_{t} \left( \mathbf{i}_{m}, \mathbf{i}_{m} \right) \right) + \sum_{s \in T(n,p), s \neq \mathbf{i}_{m}} \left( -1 \right)^{|s|+|t|} \det \left( \mathbf{S}_{t} \left( t, s \right) \right) \det \left( \mathbf{S}_{t} \left( t, s \right)^{c} \right)$$
$$= Ct^{\kappa_{(n,m)}} + h\left( t \right)$$

where

$$Ct^{\kappa_{(n,m)}}, h(t) = \sum_{s \in T(n,p), s \neq \mathbf{i}_{m}} (-1)^{|s|+|t|} \det (\mathbf{S}_{t}(t,s)) \det ((\mathbf{S}_{t}(t,s))^{c}) \in \mathbb{Q}(\xi)[t].$$

From our previous discussion, the monomial  $C \times t^{\frac{2m^2 - 2mn - 2m + n^2 + n}{2}}$  appears once in the expansion above. Moreover, since C is never equal to zero, it follows that the determinant of  $S(\mathfrak{c}(t))$  is a non-vanishing polynomial in the variable t. For the second part, it is clear that the degree of the polynomial det  $(A_1(t)A_4(t))$  satisfies the following condition

$$\deg\left(\det A_{1}(t)\det A_{4}(t)\right) \leq m(n-1) + (n-m)(n-1) = n(n-1).$$

Next, since the determinant of any sub-matrix of order n of  $A(\mathfrak{c}(t))$  must be a sum of polynomials of degree less or equal to n(n-1) then the second part of the lemma holds.  $\Box$ 

### 4. Proof of Theorem 1

First, observe that  $n(n-1) + 1 = n^2 - n + 1$ . Fix  $\lambda \in \mathcal{F}_n$  where  $\mathcal{F}_n$  is as described in (1.2). Since the determinant of every submatrix of  $A(\mathfrak{c}(t))$  of order n is a polynomial in  $\mathbb{Q}(\xi)[t]$  of degree bounded above by n(n-1), it is clear that the determinant of every submatrix of  $A(\mathfrak{c}(\lambda))$  of order n cannot be equal to zero. As such, it immediately follows that  $\Lambda[1, \lambda, \dots, \lambda^{n-1}]^T$  is a set of cardinality 2n in  $\mathbb{C}^n$  which is a full spark frame. Consequently, since  $\Gamma = \mathbf{F}^{-1}\Lambda\mathbf{F} \Leftrightarrow \Gamma\mathbf{F}^{-1} = \mathbf{F}^{-1}\Lambda$  it follows that

$$\mathbf{F}^{-1}\left(\Lambda\left[1,\lambda,\cdots,\lambda^{n-1}\right]^{T}\right)=\Gamma\left(\mathbf{F}^{-1}\left[1,\lambda,\cdots,\lambda^{n-1}\right]^{T}\right)$$

is a set of cardinality 2n in  $\mathbb{C}^n$  enjoying the Haar property.
