On *R***-triviality** of F_4

Abstract

It is known that simple algebraic groups of type F_4 defined over a field k are precisely the full automorphism groups of Albert algebras over k. We explore R-triviality for the group Aut A when A is an Albert algebra. In this paper, we consider the case when A is an Albert division algebra, that arises from the first Tits construction. We prove that Aut A is R-trivial, in the sense of Manin.



3 Automorphisms of Albert algebras




1. Suppose S_{\star} $D_+ \subset A$ for D a degree central simple k-algebra. Write A_{\star} $J D, \mu$ for some $\mu \in k^{\times}$. Then Aut $A/S_{\star} \sim SL_{\star}$, D, the algebraic group of norm elements in D.

2. Let $S_{\bullet\bullet} = B, \sigma_{\bullet+} \subset A$ for B a degree central simple algebra of degree over a quadratic extension K of k with an involution σ of the second kind over K/k. Write $A_{\bullet\bullet} = J = B, \sigma, u, \mu \bullet$ for suitable parameters. Then Aut $A/S = \mathbf{SU} = B, \sigma_{\bullet} \bullet$, where $\sigma_{u} \mathbf{L}_{\bullet\bullet}$ Int $u \circ \sigma$.

In particular, the subgroups described in (1) and (2) are simply connected, simple of type A_2 , defined over k and since these are rank- \mathbf{v} groups, they are are rational and hence are R-trivial.



Theorem 5.1 5.1 Let A be an Albert (division) algebra. Let $S \subset A$ be a -dimensional subalgebra. Then, with the notations as above, **Str** A, **S** is R-trivial.






