SELF-SIMILAR QUANTUM GROUPS

Abstract. We introduce the notion of self-similarity for compact quantum groups. For a finite set X, we introduce a C^* -algebra \mathbb{A}_X , which is the quantum automorphism group of the infinite homogeneous rooted tree X^* . Self-similar quantum groups are then certain quantum subgroups of \mathbb{A}_X . Our main class of examples are called finitely-constrained self-similar quantum groups, and we find a class of these examples that can be described as quantum wreath products by subgroups of the quantum permutation group.

1. INTRODUCTION

Self-similar groups are a class of groups acting faithfully on an infinite rooted homogeneous tree X^{*}. In particular, given an automorphism $g \in Aut(X^*)$ and a vertex $w \in X^*$, by identifying wX^* with $g(w)X^*$, we get an automorphism $g|_w \in Aut(X^*)$ which is uniquely determined by the identity

$$
g \cdot (wv) = (g \cdot w)g|_w \cdot v \quad \text{for all } v \in X^*.
$$

The automorphism $g|_w$ is called the *restriction* of g by w, and a subgroup $G \leq \text{Aut}(X^*)$ is self-similar if it is closed under restrictions. Self-similar groups are a significant class of groups that play an important role in geometric group theory, and have been a rich source of groups displaying interesting phenomena. Most notably, the Grigorchuk group [\[5\]](#page-23-0) is a self-similar group which is an infinite, finitely generated periodic group and provided the first example of a group with intermediate growth, as well as the first known amenable group to not be elementary amenable.

When the group of automorphisms $Aut(X^*)$ is equipped with the permutation topology, the closed self-similar groups are examples of compact, totally disconnected groups, and hence are profinite groups. A particular class of examples of interest are the self-similar groups of *finite type*, which are subgroups of automorphisms of X^* that act like elements of a given finite group locally around every vertex. Grigorchuk introduced this concept in [\[6\]](#page-23-1), where he also showed that the closure of the Grigorchuk group is a self-similar group of finite type. Note that these groups are called finitely constrained self-similar groups in [\[9\]](#page-23-2), and we will use that terminology.

The theory of compact quantum groups is by now a very substantial part of the wider field of quantum groups, and one which sits in the framework of operator algebras. The theory started with Woronowicz's introduction of the quantum $SU(2)$ group in [\[12\]](#page-24-0). Woronowicz then defined compact matrix quantum groups in [\[13\]](#page-24-1), before developing a general theory of compact quantum groups in [\[14\]](#page-24-2). An important class of compact matrix quantum groups was identified and studied by Wang through his quantum permutation

groups in [\[11\]](#page-24-3). Wang was motivated by one of Connes' questions from his noncommutative geometry program: what is the quantum automorphism group of a space? Wang's work in [\[11\]](#page-24-3) provided an answer for finite spaces; in particular, Wang formally defined the notion of a quantum automorphism group, and then showed that his quantum permutation group $A_s(n)$ is the quantum automorphism group of the space with n points. For three or fewer points this algebra is commutative, and hence indicating no quantum permutations; but for four or more points, remarkably the algebra is noncommutative and infinite-dimensional.

Since the appearance of [\[11\]](#page-24-3), follow-up work progressed in multiple directions, including the results of Bichon in [\[2\]](#page-23-3) in which he introduced quantum automorphisms of finite graphs. These algebras are quantum subgroups of the quantum permutation groups. Bichon used this construction to define the quantum dihedral group D_4 . Later still in [\[1\]](#page-23-4), Banica and Bichon classified all the compact quantum groups acting on four points; that is, all the compact quantum subgroups of $A_s(4)$. Quantum automorphisms of infinite graphs have recently been considered by Rollier and Vaes in [\[8\]](#page-23-5), and by Voigt in [\[15\]](#page-24-4).

Our current work is the result of us asking the question: is there a reasonable notion of self-similarity for quantum groups? We answer this question in the affirmative for compact quantum groups. We do this by first constructing the quantum automorphism group \mathbb{A}_X of the homogeneous rooted tree X^* , and then identifying the quantum analogue of the restriction maps $g \mapsto g|_w$ for $g \in Aut(X^*)$, $w \in X^*$. We then define a self-similar quantum group to be any quantum subgroup A of \mathbb{A}_X for which the restriction maps factor through the quotient map $\mathbb{A}_X \to A$. We characterise self-similar quantum groups in terms of a certain homomorphism $A \otimes C(X) \to C(X) \otimes A$, which can be thought of as quantum state-transition function. The main class of examples we examine are quantum analogues of finitely constrained self-similar groups. In our main theorem about these examples we describe a class of finitely constrained self-similar groups as free wreath products by quantum subgroups of quantum permutation groups.

We start with a small preliminaries section in which we collect all the required definitions from the literature on compact quantum groups. In Section [3](#page-3-0) we then identify a compact quantum group \mathbb{A}_X which we prove is the quantum automorphism group of the homogeneous rooted tree X^* . The $\overline{C^*}$ -algebra \mathbb{A}_X is a noncommutative, infinitedimensional C^* -algebra whose abelianisation is the algebra of continuous functions on the automorphism group of the tree X^* . In Section [4](#page-8-0) we introduce the notion of self-similarity for compact quantum groups, and we characterise self-similar quantum groups A in terms of morphisms $A \otimes C(X) \to C(X) \otimes A$, mimicking the fact that classical self-similar action are governed by the maps $G \times X \to X \times G: (q, x) \mapsto (q \cdot x, q|_x)$.

In Section [5](#page-14-0) we define finitely constrained self-similar quantum groups, which are the quantum analogues of the classical finitely constrained self-similar groups studied in [\[4,](#page-23-6) [9\]](#page-23-2). In particular, we consider subalgebras A_d of A_X , which are the quantum automorphism groups of the finite subtrees $X^{[d]}$ of X^* of depth d. To each quantum subgroup $\mathbb P$ of \mathbb{A}_d , we construct a quantum subgroup $A_{\mathbb{P}}$, which we prove is a self-similar quantum group. We then build on the work of Bichon in [\[3\]](#page-23-7) by constructing free wreath products of compact quantum groups by quantum subgroups of the quantum permutation group (which corresponds to the subalgebra \mathbb{A}_1 of \mathbb{A}_X), and we prove that every $A_{\mathbb{P}}$ coming from a quantum subgroup $\mathbb P$ of $\mathbb A_1$ is canonically isomorphic to the free wreath product $A_{\mathbb{P}} *_{w} \mathbb{P}$.

2. Preliminaries

In this section we collect some basics on compact quantum groups. We start with Woronowicz's definition of a compact quantum group [\[14\]](#page-24-2).

Definition 2.1. A compact quantum group is a pair (A, Φ) where A is a unital C^{*}-algebra and $\Phi: A \to A \otimes A$ is a unital *-homomorphism such that

- (1) $(\Phi \otimes id)\Phi = (id \otimes \Phi)\Phi$
- (2) $(A \otimes 1)\Phi(A) = A \otimes A = (1 \otimes A)\Phi(A).$

We call Φ the *comultiplication* and [\(1\)](#page-2-0) is called *coassociativity*.

Remark 2.2. It is proved in [\[14\]](#page-24-2) that (A, Φ) is a compact quantum group if and only if there is a family of matrices $\{a = (a_{\mathcal{X}}) \in M_{d_{\lambda}}(A) : \lambda \in \Lambda\}$ for some indexing set Λ such that

(1)
$$
\Phi(a_{\mathbf{i}} \chi) = \sum_{i=1}^{d_{\lambda}} a_{\mathbf{i}} \chi \otimes a_{\mathbf{i}} \chi \text{ for all } \lambda \in \Lambda \text{ and } 1 \leq i, j \leq d ,
$$

- (2) a and its transpose (a)^{*r*} are invertible elements of $M_{d_\lambda}(A)$ for every $\lambda \in \Lambda$,
- (3) the ∗-subalgebra A of A generated by the entries $\{a_i, j \leq i, j \leq d \}$, $\lambda \in \Lambda\}$ is dense in A.

Example 2.3. A key example for us is Wang's quantum permutation groups $(A_s(n), \Phi)$ from [\[11\]](#page-24-3). Here, *n* is a positive integer, and $A_s(n)$ is the universal C^{*}-algebra generated by elements a_i , $1 \leq i, j \leq n$, satisfying

$$
a_f^2 = a_f = a_f^* \text{ for all } 1 \le i, j \le n,
$$

$$
\sum_{i=1}^n a_i = 1 \text{ for all } 1 \le i \le n,
$$

$$
\sum_{i=1}^n a_i = 1 \text{ for all } 1 \le j \le n.
$$

The comultiplication Φ satisfies $\Phi(a_i) = \sum_{i=1}^n a_i \otimes a_i$ for all $1 \le i, j \le n$.

Definition 2.4. If (A_1, Φ_1) and (A_2, Φ_2) are compact quantum groups, then a *morphism* π from (A_1, Φ_1) to (A_2, Φ_2) is a homomorphism of C^* -algebras $\pi: A_1 \to A_2$ satisfying $(\pi \otimes \pi) \circ \Phi_1 = \Phi_2 \circ \pi.$

Definition 2.5. Let (A, Φ) be a compact quantum group. A *Woronowicz ideal* is an ideal I of A such that $\Phi(I) \subseteq \ker(q \otimes q)$, where q is the quotient map $A \to A/I$. Then $(A/I, \Phi')$, where $\Phi' : A/I \to A/I \otimes A/I$ satisfies $\Phi' \circ q = (q \otimes q) \circ \Phi$ is a compact quantum group called a *quantum subgroup* of (A, Φ) .

Definition 2.6. A (left) coaction of a compact quantum group (A, Φ) on a unital C^* algebra B is a unital \ast -homomorphism $\alpha : B \to A \otimes B$ satisfying

- (1) $(id \otimes \alpha)\alpha = (\Phi \otimes id)\alpha$
- $(2) \alpha(B)(A \otimes 1) = A \otimes B.$

We refer to (1) as the *coaction identity* and (2) is known as the *Podle's condition*.

3. Quantum automorphisms of a homogeneous rooted tree

In this section we introduce a compact quantum group \mathbb{A}_X which we prove is the quantum automorphism group of the infinite homogeneous rooted tree X[∗] . We start with the notion of an action of a compact quantum group on X^* . Note that for $n \geq 0$ we write $Xⁿ$ for all the words in X of length n, and we then the tree X^* can be identified with $\bigcup_{n\geq} X^n$, where $X^0 = \{\varnothing\}$ and \varnothing is the root of the tree.

Definition 3.1. Let X be a finite set and let (A, Φ) be a compact quantum group. An action of A on the homogeneous rooted tree X^* is a system

$$
\alpha = (\alpha_n : C(X^n) \to A \otimes C(X^n))
$$

of left coactions, such that for any $m < n$ the diagram

$$
C(X_{l}) \xrightarrow{m,n} C(X^{n})
$$

$$
\downarrow m \qquad \qquad \downarrow n
$$

$$
A \otimes C(X_{l}) \xrightarrow{\mathrm{id} \otimes_{l} m,n} A \otimes C(X^{n})
$$

commutes, where $i_{\mathcal{A}} : C(X_{\mathcal{A}}) \to C(X_{\mathcal{A}})$ is the injective homomorphism satisfying

$$
i_{\iota} \cdot X(p_w) = \sum_{w' \in X^{n-m}} p_{ww'}.
$$

We now define the main object of interest in this section, the C^* -algebra \mathbb{A}_X , before proving that it is indeed a compact quantum group in Theorem [3.4.](#page-4-0) At some point in the later stages of this project we became aware of [\[8\]](#page-23-5), and their notion of the quantum automorphism group QAut Π of a locally finite connected graph Π. A straightforward argument shows that A_X is QAut Π for Π the homogeneous rooted tree, but we include the proof of Theorem [3.4](#page-4-0) for completeness.

Definition 3.2. Let X be a finite set. Define \mathbb{A}_X to be the universal C^* -algebra generated by elements $\{a_u x : u, v \in X^n, n \ge 0\}$ subject to the following relations:

$$
(1) a_{\emptyset} = 1,
$$

- (2) for any $n \geq 0, u, v \in X^n$, $a_u^* y = a_u^2 y = a_u^2 y$,
- (3) for any $n \geq 0, u, v \in X^n$ and $x \in X$

$$
a_u x = \sum_{y \in X} a_{ux} x_y = \sum_{z \in X} a_{uz} x_x.
$$

- Remarks 3.3. (i) For each $d \in \mathbb{N}$ we denote by \mathbb{A}_d the subalgebra of \mathbb{A}_X generated by ${a_u x : u, v \in X^d}$. Note that A_1 is the Wang's quantum permutation group $A_s(|X|)$ from Example [2.3.](#page-2-3)
	- (ii) We can interpret [\(3\)](#page-3-1) as follows: each projection $a_u x$ decomposes as an $|X| \times |X|$ square of projections $\{a_{ux}x_y : x, y \in X\}$ with a magic square type property where every row and column sums to $a_u x$. For example, if $X = \{0, 1, 2\}$ we have the following structure.

(iii) Repeated applications of (3) from Definition [3.2](#page-3-2) show that for all $u, u', v, v', w \in$ $X^n, n \in \mathbb{N}$, we have

$$
u \neq u', v \neq v' \implies a_u x_a u' x_v = 0 = a_w x_a x_w x',
$$

and that for all $u = u_1 \cdots u_n, v = v_1 \cdots v_n \in X^n, n \in \mathbb{N}$, and $x, y \in X$ we have

$$
a_x \mathbf{x} a_y \mathbf{x} = a_y \mathbf{x} a_x \mathbf{x} = \begin{cases} a_y \mathbf{x} & \text{if } u_1 = x, v_1 = y \\ 0 & \text{otherwise.} \end{cases}
$$

We will freely use these two identities without comment throughout the rest of the paper.

Theorem 3.4. The C^{*}-algebra \mathbb{A}_X is a compact quantum group with comultiplication $\Delta: \mathbb{A}_X \to \mathbb{A}_X \otimes \mathbb{A}_X$ satisfying

$$
\Delta(a_{u}x) = \sum_{w \in X^{n}} a_{u}x \otimes a_{w}x,
$$

for all $u, v \in X^n$ and $n \geq 1$

Proof. To see that Δ exists, it's enough to show that the elements

$$
b_u\chi:=\sum_{w\in X^n}a_u\chi\otimes a_w\chi
$$

for $u, v \in X^n$ and $n \geq 1$ satisfy Definition [3.2.](#page-3-2)

Firstly, b_{\emptyset} $\mathscr{L} = \Delta(a_{\emptyset} \mathscr{L}) = a_{\emptyset} \mathscr{L} \otimes a_{\emptyset} \mathscr{L} = 1 \otimes 1$. For [\(2\)](#page-3-3), we have

$$
b_u^* \mathbf{y} = \sum_{w \in X^n} a_u^* \mathbf{y} \otimes a_w^* \mathbf{y} = \sum_{w \in X^n} a_u \mathbf{y} \otimes a_w \mathbf{y} = b_u \mathbf{y}
$$

and

$$
b_u^2 \mathbf{y} = \left(\sum_{w \in X^n} a_u \mathbf{y} \otimes a_w \mathbf{y}\right)^2
$$

=
$$
\sum_{w \le x} a_u \mathbf{y} a_u \mathbf{y} \otimes a_w \mathbf{y} a_z \mathbf{y}
$$

=
$$
\sum_{w \in X^n} a_u^2 \mathbf{y} \otimes a_w^2 \mathbf{y}
$$

=
$$
\sum_{w \in X^n} a_u \mathbf{y} \otimes a_w \mathbf{y}
$$

=
$$
b_u \mathbf{y}.
$$

For [\(3\)](#page-3-1) fix $u, v \in X^n$ and $x \in X$. Then

$$
b_u x = \sum_{w \in X^n} a_u x \otimes a_w x
$$

=
$$
\sum_{w \in X^n} \sum_{z \in X} a_{ux} x_z \otimes a_w x
$$

=
$$
\sum_{w \in X^n} \sum_{z \in X} a_{ux} x_z \otimes \sum_{y \in X} a_{wz} x_y
$$

$$
= \sum_{y \in X} \sum_{w \in X^{n+1}} a_{ux} x \otimes a_{w} x_{y}
$$

$$
= \sum_{y \in X} b_{ux} x_{y}.
$$

So by the universal property of \mathbb{A}_X there is a homomorphism $\Delta : \mathbb{A}_X \to \mathbb{A}_X \otimes \mathbb{A}_X$ such that

$$
\Delta(a_{u} \mathbf{y}) = \sum_{w \in X^{n}} a_{u} \mathbf{y} \otimes a_{w} \mathbf{y}.
$$

For coassociativity, we have

$$
(\mathrm{id} \otimes \Delta) \circ \Delta(a_{u_{\bullet}}\mathbf{y}) = \sum_{w \in X^{n}} a_{u_{\bullet}}\mathbf{y} \otimes \Delta(a_{w_{\bullet}}\mathbf{y})
$$

=
$$
\sum_{w \in X^{n}} a_{u_{\bullet}}\mathbf{y} \otimes \left(\sum_{z \in X^{n}} a_{w_{\bullet}}\mathbf{y} \otimes a_{z_{\bullet}}\mathbf{y}\right)
$$

=
$$
\sum_{z \in X^{n}} \left(\sum_{w \in X^{n}} a_{u_{\bullet}}\mathbf{y} \otimes a_{w_{\bullet}}\mathbf{y}\right) \otimes a_{z_{\bullet}}\mathbf{y}
$$

=
$$
\sum_{z \in X^{n}} \Delta(a_{u_{\bullet}}\mathbf{y}) \otimes a_{z_{\bullet}}\mathbf{y}
$$

=
$$
(\Delta \otimes \mathrm{id}) \circ \Delta(a_{u_{\bullet}}\mathbf{y}).
$$

Finally, we show that that the set of matrices

$$
\{a_n = (a_u x)_u x \in X^n \in M_{X^n}(\mathbb{A}_X) : n \ge 1\}
$$

satisfy the conditions of Definition [2.2.](#page-2-4) Conditions (1) and (3) are clear. For (2) we show that given any $n \geq 1$ the matrix a_n is invertible with inverse given by $(a_n)^{\mathbf{F}}$. Given $u, v \in X^n$ we have

$$
(a_n(a_n)^{\mathbf{F}})_{u} \mathbf{x} = \sum_{w \in X^n} a_u \mathbf{x} a_v \mathbf{x} = \delta_u \mathbf{x} \sum_{w \in X^n} a_u \mathbf{x} = \delta_u \mathbf{x} 1_A.
$$

Likewise, we can show $((a_n)^{\mathbf{F}} a_n)_{\mathbf{u}} \mathbf{x} = \delta_{\mathbf{u}} \mathbf{x} \mathbf{1}_A$ and hence $(a_n)^{\mathbf{F}} = a_n^{-1}$ as required. \square

Remark 3.5. The canonical dense $*$ -subalgebra of \mathbb{A}_X is the $*$ -subalgebra generated by the projections $\{a_u x : u, v \in X^n, n \geq 0\}$. This is a Hopf *-algebra with counit $\varepsilon: A_X \to \mathbb{C}$ and coinverse $\kappa: \mathbb{A}_X \to \mathbb{A}_X$ satisfying $\varepsilon(a_u x) = \delta_u x$ and $\kappa(a_u x) = a_v x$, for $u, v \in X^n$, $n \in \mathbb{N}$.

We now show that (A_X, Δ) is the quantum automorphism group (in the sense of [\[11,](#page-24-3) Definition 2.3]) of the homogeneous rooted tree.

Proposition 3.6. There is an action $\gamma = (\gamma_n)_{n=1}^{\infty}$ of \mathbb{A}_X on X^* . Moreover, if $\alpha = (\alpha_n)_{n=1}^{\infty}$ is an action of a compact quantum group (A, Φ) on X^* then there is a quantum group homomorphism $\pi : \mathbb{A}_X \to A$ such that $(\pi \otimes id) \circ \gamma_n = \alpha_n$ for any $n \geq 1$.

Proof. For any $n \geq 1$, the elements

$$
q_w := \sum_{w' \in X^n} a_{w} x_{w'} \otimes p_{w'} \in A_X \otimes C(X^n)
$$

for each $w \in X^n$ are mutually orthogonal projections and satisfy

$$
\sum_{w \in X^n} q_w = \sum_{w \mathbf{w} \in X^n} a_{w \mathbf{w}} \mathbf{w} \otimes p_{w'} = 1 \otimes 1
$$

Therefore there is a unital *-homomorphism $\gamma_n : C(X^n) \to \mathbb{A}_X \otimes C(X^n)$ satisfying $\gamma_n(p_w) = q_w$. We have

$$
(\Delta \otimes id)\gamma_n(p_w) = \sum_{w' \in X^n} \Delta(a_w \chi_y) \otimes p_{w'}
$$

=
$$
\sum_{w' \chi \in X^n} a_w \chi \otimes a_z \chi_y \otimes p'_w
$$

=
$$
\sum_{z \in X^n} a_w \chi \otimes \alpha_n(p_z)
$$

=
$$
(id \otimes \gamma_n)\gamma_n(p_w),
$$

and so each γ_n satisfies the coaction identity.

For a fixed $v \in X^n$ we have

$$
\sum_{u\in X^n}\gamma_n(p_u)(a_u\mathbf{y}\otimes 1)=\sum_{u\mathbf{y}\in X^n}a_u\mathbf{y}\otimes a_u\mathbf{y}\otimes p_w=\sum_{u\in X^n}a_u\mathbf{y}\otimes p_v=1\otimes p_v.
$$

Multiplying by any element $a \otimes 1 \in A_X \otimes 1$ shows that $\gamma_n(C(X^n))(\mathbb{A}_X \otimes 1)$ contains the elements $a \otimes p_v$ of $\mathbb{A}_X \otimes C(X^n)$ and hence the required density is satisfied.

Finally, fix $m < n$ and $w \in X_i$. Then

$$
(\mathrm{id}\otimes_{l}^{i} \mathbf{x})\gamma_{l}(p_{w})=\sum_{z\in X^{m}} a_{w} \mathbf{x}\otimes_{l}^{i} \mathbf{x}(p_{z})
$$

$$
=\sum_{z\in X^{m}} \sum_{z'\in X^{n-m}} a_{w} \mathbf{x}\otimes p_{zz'}
$$

$$
=\sum_{z\in X^{m}} \sum_{z'\in X^{n-m}} \sum_{w'\in X^{n-m}} a_{ww'} \mathbf{x}_{z'}\otimes p_{zz'}
$$

$$
=\sum_{w'\in X^{n-m}} \alpha_{n}(p_{ww'})
$$

$$
=\gamma_{n}(\mathbf{x}_{l}^{i} \mathbf{x}(p_{w})),
$$

and so the collection $\gamma = (\gamma_n)_{n=1}^{\infty}$ defines an action of (\mathbb{A}_X, Δ) on the homogeneous rooted tree X^* .

Now suppose $(\alpha_n)_{n=1}^{\infty}$ is an action of a compact quantum group (A, Φ) on X^* . Let $b_{\varnothing,\mathcal{C}} := 1 \in A$ and for $n \geq 1$ and $u, v \in X^n$ define $b_u \mathcal{C} \in A$ to be the unique elements satisfying

$$
\alpha_n(p_u)=\sum_{v\in X^n}b_u\mathbf{y}\otimes p_v.
$$

The coaction identity for α_n says that

(3.1)
$$
\Phi(b_u \mathbf{x}) = \sum_{w \in X^n} b_u \mathbf{x} \otimes b_w \mathbf{x}
$$

for any $u, v \in X^n$.

We claim that the collection $\{b_u x : u, v \in X^n, n \geq 0\} \subseteq A$ satisfies Definition [3.2.](#page-3-2) Condition (1) is by definition. For (2) and (3) , we appeal to the universal property of the quantum permutation groups $A_s(|X|^n)$ for $n \geq 1$. Since for any $n \geq 1$, α_n defines a coaction of (A, Φ) on $C(X^n)$, [\[11,](#page-24-3) Theorem 3.1] says that the elements $\{b_u x : u, v \in X^n\}$ satisfy conditions (3.1) – (3.3) of [\[11,](#page-24-3) Section 3]. Condition (3.1) is precisely (2) . Conditions (3.1) and (3.2) say that for any $v \in X^n$ we have

$$
\sum_{u \in X^n} b_u x = 1_A = \sum_{w \in X^n} b_v x.
$$

For any $u \in X^n$ and $x \in X$ we have

$$
p_{ux} \le \sum_{y \in X} p_{uy} = i_{n} X_{+1}(p_u),
$$

and hence

$$
\sum_{v \in X^n} \sum_{y \in X} b_{ux} \chi_y \otimes p_{vy} = \alpha_{n+1}(p_{ux})
$$
\n
$$
\leq \alpha_{n+1}(i_n \chi_{+1}(p_u))
$$
\n
$$
= (id_A \otimes i_n \chi_{+1}) \alpha_n(p_u)
$$
\n
$$
= \sum_{v \in X^n} \sum_{y \in X} b_u \chi \otimes p_{vy}.
$$

It follows that $b_{ux}x_y \leq b_ux$ for any $x, y \in X$. Therefore, for any $u, v \in X^n$ and $x \in X$ we have

$$
b_u x = b_u x \left(\sum_{w \in X^n} \sum_{y \in X} b_{ux} x_{y} \right) = \sum_{y \in X} b_{ux} x_{y}.
$$

Likewise for any $y \in X$ we have $b_u x = \sum_{x \in X} b_{u x} x_y$ and [\(3\)](#page-3-1) holds.

Therefore, the universal property of \overline{A}_X^{∞} provides a homomorphism $\pi : A_X \to A$ satisfying $\pi(a_u x) = b_u x$. It follows from [\(3.1\)](#page-6-0) that $(\pi \otimes \pi) \circ \Delta = \Phi \otimes \pi$ and so π is a compact quantum group homomorphism. The identity $(\pi \otimes id) \circ \gamma_n = \alpha_n$ is immediate.

Proposition 3.7. For $|X| \geq 2$ the C^{*}-algebra \mathbb{A}_X is non-commutative and infinite dimensional.

Proof. Without loss of generality, assume $X = \{0, 1\}$. Let B be the universal unital C^* algebra generated by two (non-commuting) projections p and q . It is known from [\[7\]](#page-23-8) that $B \cong C^*(\mathbb{Z}_2 * \mathbb{Z}_2)$, which is non-commutative and infinite dimensional. Define the matrix

$$
(b_u x)_u x \in X^2 = \begin{pmatrix} p & 1_B - p & 0 & 0 \\ 1_B - p & p & 0 & 0 \\ 0 & 0 & q & 1_B - q \\ 0 & 0 & 1_B - q & q \end{pmatrix} \in M_4(B).
$$

Define b_{\emptyset} $\mathscr{L} = b_0 \mathscr{L} = b_1 \mathscr{L} = 1_B$, $b_0 \mathscr{L} = b_1 \mathscr{L} = 0$ and for $u, v \in X^2$ and $w, w' \in X^*$ define $b_{uw}x_{w'} := \delta_{w}x'v_{u}x$. Then these elements satisfy the relations in Definition [3.2](#page-3-2) and hence there is a surjective homomorphism $\mathbb{A}_X \to B$. Since B is non-commutative and infinite-dimensional so is \mathbb{A}_X .

 \Box

Remark 3.8. The group $Aut(X^*)$ of automorphisms of a homogeneous rooted tree X^* is compact totally disconnected Hausdorff group under the permutation topology. A neighbourhood basis of the identity is given by the family of subgroups

$$
\{G_u := \{ g \in Aut(X^*) : g \cdot u = u \} : u \in X^* \},\
$$

and since the orbit of any $u \in X^*$ is finite, each of these open subgroups is closed and hence compact. Cosets of these subgroups are of the form $G_u\mathfrak{z} := \{g \in G : g \cdot v = u\}.$ Then $\{G_u\mathfrak{F} : u, v \in X^*\}$ is a basis of compact open sets for the topology on Aut (X^*) . It follows that the indicator functions f_{u} $\mathfrak{g} := 1_{G_{u,v}}$ span a dense subset of $C(\text{Aut}(X^*))$. It is easily checked that the elements f_{u} _x satisfy $(1)-(3)$ $(1)-(3)$ of Definition [3.2](#page-3-2) and the universal property of $C(\text{Aut}(X^*))$ then implies that it is the abelianisation of \mathbb{A}_X .

4. Self-similarity

If $g \in Aut(X^*)$ and $x \in X$, the restriction $g|_x$ is the unique element of $Aut(X^*)$ satisfying

$$
g \cdot (xw) = (g \cdot x)g|_x \cdot w
$$
 for all $w \in X^*$.

A subgroup $G \leq Aut(X^*)$ is called *self-similar* if G is closed under taking restrictions. That is, whenever $g \in G$ and $x \in X$, the restriction $g\vert_x$ is an element of G. With the topology inherited from Aut (X^*) , the restriction map $G \to G: g \mapsto g|_x$ is continuous. If G is any group acting on X^* by automorphisms, we call the action self-similar if the image of G in $Aut(X^*)$ is self-similar.

To have a reasonable notion of self-similarity for quantum subgroups of \mathbb{A}_X , we need to understand how restriction manifests itself in the function algebra $C(\text{Aut}(X^*))$. Given $x \in X$ and $u, v \in X^n$ we have

$$
\{g : g|_x \cdot u = v\} = \left(\bigcup_{y \in X} \{g : g \cdot x = y\}\right) \cap \{g : g|_x \cdot u = v\}
$$

$$
= \bigcup_{y \in X} (\{g : g \cdot x = y\} \cap \{g : g|_x \cdot u = v\})
$$

$$
= \bigcup_{y \in X} \{g : g \cdot (xu) = yv\},
$$

and hence the corresponding indicator functions satisfy

$$
1_{\{\mathbf{x} \mathbf{A}_x \cdot u = v\}} = \sum_{y \in X} 1_{\{\mathbf{x} \mathbf{A}(xu) = yv\}}.
$$

This formula motivates the following result.

Proposition 4.1. For each $x \in X$ there is a homomorphism $\rho_x : \mathbb{A}_X \to \mathbb{A}_X$ satisfying

(4.1)
$$
\rho_x(a_u \mathbf{x}) = \sum_{y \in X} a_{yu} \mathbf{x}_v,
$$

for all $u, v \in X^n$.

We illustrate the formula for a restriction map in Figure 1 by considering $X = \{0, 1, 2\}$ and looking at what the restriction map ρ_1 does to the projection $a_1 \chi$.

FIGURE 1. $\rho_1(a_1x) = a_{01}x_2 + a_{11}x_2 + a_{21}x_2$

Proof of Proposition [4.1.](#page-8-1) Fix $x \in X$. We show that the elements

$$
\{b_u x:=\rho_x(a_u x): u,v\in X^n, n\geq 1\}
$$

satisfy the conditions of Definition 3.2 . For (1) we have

$$
b_{\varphi} \mathbf{x} = \rho_x(a_{\varphi} \mathbf{x}) = \sum_{y \in X} a_y \mathbf{x} = 1.
$$

For (2) , we have

$$
b_u^*\mathbf{y}=\left(\sum_{y\in X}a_{yu}\mathbf{y}_v\right)^*=\sum_{y\in X}a_{yu}^*\mathbf{y}_v=\sum_{y\in X}a_{yu}\mathbf{y}_v=b_u\mathbf{y}
$$

and

$$
b_u^2 \mathbf{y} = \left(\sum_{y \in X} a_{yu} \mathbf{y}_v\right)^2 = \sum_{y \in X} a_{yu} \mathbf{y}_v a_{zu} \mathbf{y}_v = \left(\sum_{y \in X} a_{yu} \mathbf{y}_v\right) = b_u \mathbf{y}.
$$

For (3) , fix $y \in X$. Then

$$
\sum_{z \in X} b_{uy} x_z = \sum_{z \in X} \sum_{w \in X} a_{wuy} x_{vz} = \sum_{w \in X} a_{wu} x_v = b_u x.
$$

A similar calculation shows $\sum_{z \in X} b_{uz} x_y = b_u x$. Hence there is a homomorphism ρ_x with the desired formula. $\qquad \qquad \qquad \qquad \qquad \qquad \qquad \qquad \qquad \qquad \Box$

Remark 4.2. We define ρ_{\emptyset} to be the identity homomorphism $\mathbb{A}_X \to \mathbb{A}_X$, and for $w =$ $w_1 \cdots w_n \in X^n$ we define ρ_w to be the composition $\rho_{w_1} \circ \cdots \circ \rho_{w_n}$. A routine calculation shows that for all $u, v \in X^n$ we have

$$
\rho_w(a_u x) = \sum_{z \in X^n} a_{zu} x_v.
$$

Remark 4.3. A similar argument to the one in the proof of Proposition [4.1](#page-8-1) shows that for each $x \in X$ there is a homomorphism $\sigma_x: \mathbb{A}_X \to \mathbb{A}_X$ satisfying

$$
\sigma_x(a_u x) = \sum_{y \in X} a_{xu} x_y
$$

for all $u, v \in X^n$, $n \in \mathbb{N}$. It is straightforward to see that $\sigma_x = \kappa \circ \rho_x \circ \kappa$, where κ is the coinverse.

We can now state the main definition of the paper.

Definition 4.4. We call ρ_w the restriction by w. A quantum subgroup A of \mathbb{A}_X is selfsimilar if for each $x \in X$ the restriction ρ_x factors through the quotient map $q : A_X \to A$; that is, if there exists a homomorphism $\tilde{\rho}_x : A \to A$ such that the diagram

$$
\begin{array}{ccc}\n\mathbb{A}_X & \xrightarrow{x} & \mathbb{A}_X \\
\downarrow q & & \downarrow q \\
A & \xrightarrow{x} & A\n\end{array}
$$

commutes.

To motivate the main result of this section, let G be a group. To construct a selfsimilar action of G on X^* , it suffices to have a function $f: G \times X \to X \times G$ such that $f(e, x) = (x, e)$ for all $x \in X$, and such that the following diagram commutes

$$
G \times G \times X^t \xrightarrow{G \times id_X} G \times X
$$

\n
$$
G \times X \times G
$$

\n
$$
\downarrow^{id_G \times f}
$$

\n
$$
\downarrow^{f \times id_G}
$$

\n
$$
X \times G \times G \xrightarrow{id_X \times G} X \times G
$$

This data allows us to define an action of G on X^* , which is self-similar with $g \cdot x$ and $g|_x$ the unique elements of X and G satisfying $(g \cdot x, g_x) := f(g, x)$.

Our next result is a compact quantum group analogue of the above result. We will be working with multiple different identity homomorphisms and units. For clarity we adopt the following notational conventions: we write id_A for the identity homomorphism on a C^* -algebra A, and for $n \geq 1$ write id_n for the identity homomorphism on the commutative C^* -algebra $C(X^n)$. Likewise, 1_A will denote the unit of A, 1 and 1_n will denote the units of $C(X)$ and $C(X^n)$ respectively.

Theorem 4.5. Suppose (A, Φ) is a compact quantum group equipped with a unital $*$ homomorphism $\psi : C(X) \otimes A \rightarrow A \otimes C(X)$ satisfying

(4.2)
$$
(\Phi \otimes id_1)\psi = (id_A \otimes \psi)(\psi \otimes id_A)(id_1 \otimes \Phi)
$$

and

(4.3)
$$
\psi(C(X) \otimes 1_A)(A \otimes 1) = A \otimes C(X).
$$

Then (A, Φ) acts on the homogeneous rooted tree X^* and moreover the image of \mathbb{A}_X , under the homomorphism $\pi : A_X \to A$ from Proposition [3.6,](#page-5-0) is a self-similar compact quantum group.

Proof. We begin by defining an action of (A, Φ) on X^* . Identify $C(X)$ with $C(X) \otimes$ $1_A \subseteq C(X) \otimes A$ and let $\alpha_1 := \psi|_{C(X) \otimes 1_A}$. Then α_1 is clearly unital and the coaction identity and Podles´ condition for α_1 follow from [\(4.2\)](#page-10-0) and [\(4.3\)](#page-10-1). Now inductively define $\alpha_{n+1} := (\psi \otimes id_n)(id_1 \otimes \alpha_n) : C(X^{n+1}) \to A \otimes C(X^{n+1})$ for $n \geq 1$, where we are supressing the canonical isomorphism $C(X^{n+1}) \cong C(X) \otimes C(X^n)$. Again, α_{n+1} is clearly unital whenever α_n is. If we assume α_n satisfies the coaction identity, then

$$
(\Phi \otimes id_{n+1})\alpha_{n+1} = (\Phi \otimes id_{n+1})(\psi \otimes id_n)(id_1 \otimes \alpha_n)
$$

=
$$
(id_A \otimes \psi \otimes id_n)(\psi \otimes id_A \otimes id_n)(id_1 \otimes \Phi \otimes id_n)(id_1 \otimes \alpha_n)
$$

$$
= (\mathrm{id}_A \otimes \psi \otimes \mathrm{id}_n)(\psi \otimes \mathrm{id}_A \otimes \mathrm{id}_n)(\mathrm{id}_1 \otimes \mathrm{id}_A \otimes \alpha_n)(\mathrm{id}_1 \otimes \alpha_n)
$$

$$
= (\mathrm{id}_A \otimes \psi \otimes \mathrm{id}_n)(\mathrm{id}_A \otimes \mathrm{id}_1 \otimes \alpha_n)(\psi \otimes \mathrm{id}_n)(\mathrm{id}_1 \otimes \alpha_n)
$$

$$
= (\mathrm{id}_A \otimes \alpha_{n+1})\alpha_{n+1},
$$

and so α_{n+1} also satisfies the coaction identity. Since α_1 is a coaction, we see that α_n satisfies the coaction identity for any $n \geq 1$.

To see that each α_n satisfies the Podles' condition, we argue by induction. We know it is satisfied for $n = 1$. Suppose for some $n \geq 1$ that

$$
\overline{\alpha_n(C(X^n))(A\otimes 1_n)}=A\otimes C(X^n).
$$

Fix a spanning element $a \otimes p_u \otimes p_x \in A \otimes C(X^{n+1})$ where $u \in X^n$ and $x \in X$. By the inductive hypothesis we can approximate

$$
a\otimes p_u \sim \sum_{\mathbf{I}} \alpha_n(f_{\mathbf{I}})(a_{\mathbf{I}}\otimes 1_n),
$$

where $f \in C(X^n)$ and $a \in A$. Then

(4.4)
$$
a \otimes p_u \otimes p_x \sim \sum_i (\alpha_n(f_i) \otimes 1)(1_A \otimes 1_n \otimes p_x)(a_i \otimes 1_{n+1}).
$$

By definition of α_n , for any $f \in C(X^n)$ we have

$$
\alpha_n(f) \otimes 1 = ((\psi \otimes id_{n-1}) \dots (id_{n-1} \otimes \psi)(f \otimes 1_A)) \otimes 1
$$

= $(\psi \otimes id_n) \dots (id_{n-1} \otimes \psi \otimes id_1)(f \otimes 1_A \otimes 1)$
= $(\psi \otimes id_n) \dots (id_{n-1} \otimes \psi \otimes id_1)(id_n \otimes \psi)(f \otimes 1 \otimes 1_A)$
= $\alpha_{n+1}(f \otimes 1).$

So we can write (4.4) as

$$
\sum_{\mathbf{A}} \alpha_{n+1} (f_{\mathbf{A}} \otimes 1) (1_A \otimes 1_n \otimes p_x) (a_{\mathbf{A}} \otimes 1_{n+1}).
$$

Since ψ is unital, we have

$$
1_A \otimes 1_n \otimes p_x = (\psi \otimes id_n)(1 \otimes 1_A \otimes 1_{n-1} \otimes p_x),
$$

which can be approximated using the induction hypothesis by

$$
(\psi \otimes id_n)(1 \otimes 1_A \otimes 1_{n-1} \otimes p_x) \sim (\psi \otimes id_n) \left(1 \otimes \sum_i \alpha_n(g)(b_i \otimes 1_n)\right)
$$

= $(\psi \otimes id_n) \left(\sum_i (id_1 \otimes \alpha_n)(1 \otimes g)(1 \otimes b_i \otimes 1_n)\right)$
= $\sum_i \alpha_{n+1}(1 \otimes g)(\psi \otimes id_n)(1 \otimes b_i \otimes 1_n).$

Finally, applying the Podles' condition for α_1 we can approximate

$$
\psi(1\otimes l_1)\sim \sum \alpha_1(h_1)(c_1\otimes 1)=\sum \psi(h_1\otimes 1_A)(c_1\otimes 1),
$$

so

$$
(\psi \otimes id_n)(1 \otimes \phi \otimes 1_n) \sim \sum (\psi(h \otimes 1_A) \otimes 1_n)(c \otimes 1_{n+1})
$$

$$
= \sum \alpha_{n+1}(h \otimes 1_n)(c \otimes 1_{n+1}).
$$

Combining these approximations we can write

$$
a \otimes p_u \otimes p_x \sim \sum_{\substack{\cdot \nearrow X \\ \bullet \bullet}} \alpha_{n+1}((f_{\bullet} \otimes 1)(h \otimes g_{\bullet})) (c \cdot a_{\bullet} \otimes 1_{n+1}),
$$

where $f, g \in C(X^n)$, $h \in C(X)$ and $a, c \in A$. Thus α_{n+1} satisfies the Podles' condition and so by induction α_n satisfies the Podles' condition for every $n \geq 1$.

It remains to show that $\alpha_n \circ i \chi = (id_A \otimes i \chi) \circ \alpha$ for any $m < n$. As in the proof of Proposition [3.6](#page-5-0), for any $n \geq 1$ and $u, v \in X^d$ we will let $b_u x \in A$ be the unique elements satifsying

$$
\alpha_n(p_u)=\sum_{v\in X^n}b_u\mathbf{y}\otimes p_v.
$$

We know from the same proof that for any $n \geq 1$ and $v \in X^n$ we have

$$
\sum_{u\in X^n}b_u\mathbf{y}=1_A.
$$

If $m < n$, for any $u \in X_l$ we have

$$
\alpha_n \circ i_{\bullet} \mathbf{x}(p_u) = (\psi \otimes \mathrm{id}_{n-1}) \dots (\mathrm{id}_{\bullet -1} \otimes \psi \otimes \mathrm{id}_{n-1}) (\mathrm{id}_{\bullet} \otimes \alpha_{n-1}) (i_{\bullet} \mathbf{x}(p_u))
$$

\n
$$
= \sum_{w \in X^{n-m}} (\psi \otimes \mathrm{id}_{n-1}) \dots (\mathrm{id}_{\bullet -1} \otimes \psi \otimes \mathrm{id}_{n-1}) (\mathrm{id}_{\bullet} \otimes \alpha_{n-1}) (p_u \otimes p_w)
$$

\n
$$
= \sum_{w \neq \in X^{n-m}} (\psi \otimes \mathrm{id}_{n-1}) \dots (\mathrm{id}_{\bullet -1} \otimes \psi \otimes \mathrm{id}_{n-1}) (p_u \otimes b_w \mathbf{x} \otimes p_z)
$$

\n
$$
= \sum_{z \in X^{n-m}} (\psi \otimes \mathrm{id}_{\bullet -1}) \dots (\mathrm{id}_{\bullet -1} \otimes \psi) (p_u \otimes \sum_{w \in X^{n-m}} b_w \mathbf{x}) \otimes p_z
$$

\n
$$
= \sum_{z \in X^{n-m}} (\psi \otimes \mathrm{id}_{\bullet -1}) \dots (\mathrm{id}_{\bullet -1} \otimes \psi) (p_u \otimes 1_A) \otimes p_z
$$

\n
$$
= \sum_{z \in X^{n-m}} \alpha_{\bullet} (p_u) \otimes p_z
$$

\n
$$
= \sum_{v \in X^m} b_u \mathbf{x} \otimes \sum_{z \in X^{n-m}} p_v \otimes p_z
$$

\n
$$
= \sum_{v \in X^m} b_u \mathbf{x} \otimes i_{\bullet} \mathbf{x}(p_v)
$$

\n
$$
= (\mathrm{id}_A \otimes i_{\bullet} \mathbf{x}) \circ \alpha_{\bullet} (p_u).
$$

So we have that $(\alpha_n)_{n=1}^{\infty}$ defines an action of (A, Φ) on X^* .

Finally, let $\pi : \mathbb{A}_X \to A$ be the homomorphism from Proposition [3.6.](#page-5-0) We have $\pi(a_u x) =$ b_u for any $u, v \in X^n$ and $n \geq 1$. For each $x \in X$ define a homomorphism $\tilde{\rho}_x : A \to A$ by

$$
\psi(1\otimes a)=\sum_{x\in X}\tilde{\rho_x}(a)\otimes p_x,
$$

where $a \in A$. For any $u \in X^n$ we have

$$
\alpha_{n+1}(1\otimes p_u)=\sum_{y\in X}\alpha_{n+1}(p_{yu})=\sum_{v\in X^n}\sum_{x\in X\atop y\in X}b_{yu}\underline{y}_v\otimes p_x\otimes p_v.
$$

On the other hand, we know $\alpha_{n+1} = (\psi \otimes id_n)(id_1 \otimes \alpha_n)$ and

$$
(\psi \otimes id_n)(id_1 \otimes \alpha_n)(1 \otimes p_u) = \sum_{v \in X^n} \psi(1 \otimes b_u x) \otimes p_v = \sum_{v \in X^n} \sum_{x \in X} \tilde{\rho}_x(b_u x) \otimes p_x \otimes p_v,
$$

and by comparing tensor factors we see that $\tilde{\rho_x}(b_u x) = \sum_{y \in X} b_{y} x_y$. Hence, the diagram

$$
\begin{array}{ccc}\n\mathbb{A}_X & \xrightarrow{x} & \mathbb{A}_X \\
\downarrow \nearrow & & \downarrow \nearrow \\
\pi(\mathbb{A}_X) & \xrightarrow{\tilde{x}} & \pi(\mathbb{A}_X)\n\end{array}
$$

commutes, and so $\pi(\mathbb{A}_X) \subseteq A$ is a self-similar quantum group.

Proposition 4.6. The following are equivalent

- (1) (A, Φ) is a quantum self-similar group, and
- (2) (A, Φ) is a quantum subgroup of (A_X, Δ) and there is a homomorphism $\psi : C(X) \otimes$ $A \to A \otimes C(X)$ satisfying the hypotheses of Theorem [4.5.](#page-10-2)

Proof. Theorem [4.5](#page-10-2) is the implication $(2) \implies (1)$. To see $(1) \implies (2)$ suppose (A, Φ) is a quantum self-similar group. By definition there is a surjective quantum group morphism $q : A_X \to A$. It is routine to check that there is a homomorphism $\psi : C(X) \otimes A \to$ $A \otimes C(X)$ satisfying

$$
\psi(p_x \otimes q(a_u x)) = \sum_{y \in X} q(a_{xu} x_y) \otimes p_y.
$$

Given $u, v \in X^n$ we have

$$
(\Phi \otimes id_1)\psi(p_x \otimes q(a_u\mathbf{y})) = \sum_{y \in X} \Phi(q(a_{xu}\mathbf{y}_v)) \otimes p_y
$$

\n
$$
= \sum_{w \in X^n} \sum_{y \neq \in X} q(a_{xu}\mathbf{y}_w) \otimes q(a_{zw}\mathbf{y}_v) \otimes p_y
$$

\n
$$
= (id_A \otimes \psi) \left(\sum_{w \in X^n} \sum_{z \in X} q(a_{xu}\mathbf{y}_w) \otimes p_z \otimes q(a_w\mathbf{y}) \right)
$$

\n
$$
= (id_A \otimes \psi)(\psi \otimes id_A) \left(\sum_{w \in X^n} p_x \otimes q(a_u\mathbf{y}) \otimes q(a_w\mathbf{y}) \right)
$$

\n
$$
= (id_A \otimes \psi)(\psi \otimes id_A)(id_1 \otimes \Phi)(p_x \otimes q(a_u\mathbf{y})),
$$

and so ψ satisfies [\(4.2\)](#page-10-0). For [\(4.3\)](#page-10-1) notice that for any $q(a) \in A$ and $z \in X$ we have $q(a) \otimes p_z = (1 \otimes p_z)(q(a) \otimes 1)$

= \left(\sum_{x \in X} q(a_x \mathbf{x}) \otimes p_z)\right) (q(a) \otimes 1)
$$

=
$$
\left(\sum_{x \in X} q(a_x \mathbf{x}) \otimes p_w)(q(a_x \mathbf{x}) \otimes 1)\right) (q(a) \otimes 1)
$$

=
$$
\sum_{x \in X} \psi(p_x \otimes 1)(q(a_x \mathbf{x}) \otimes 1).
$$

Example 4.7. If G is a closed subgroup of $Aut(X^*)$ which is self-similar, then $C(G)$ is a commutative self-similar quantum group. The quotient map $\mathbb{A}_X \to C(Aut(X^*))$ takes a generator $a_u x$ to the indicator function $f_u x$ defined in Remark [3.8.](#page-8-2) For a function $f \in C(\text{Aut}(X^*))$ and $x \in X$ the restriction homomorphism $\tilde{\rho}_x$ satisfies $\tilde{\rho}_x(f)(g) = f(g|x)$, for any $q \in G$.

5. Finitely constrained self-similar quantum groups

5.1. Classical finitely constrained self-similar groups. Fix $d \ge 1$, and let $X^{[d]} = \bigcup_{\le d} X$ be the finite subtree of X^* of depth d. The group of automorphism $\text{Aut}(X^{[d]})$ is a quotient of $Aut(X^*)$, and the quotient map is given by restriction to the finite subtree. We write $r_d : \text{Aut}(X^*) \to \text{Aut}(X^{[d]})$ for this restriction map.

Fix a subgroup $P \leq \text{Aut}(X^{[d]})$. Define

$$
G_P := \{ g \in \text{Aut}(X^*) : r_d(g|_w) \in P \text{ for all } w \in X^* \}.
$$

By the properties of restriction, if $g, h \in G_P$, then for any $w \in X^*$

$$
r_d((gh)|_w) = r_d(g|_{\mathcal{L}^w}h|_w) = r_d(g|_{\mathcal{L}^w})r_d(h|_w) \in P.
$$

Likewise, $r_d(g^{-1}|_w) = r_d(g|\mathcal{L}_{1\cdot w})^{-1} \in P$. Hence G_P is a self-similar group, called a *finitely* constrained self-similar group. More details for these groups can be found in [\[9\]](#page-23-2).

5.2. Finitely constrained self-similar quantum groups. Consider the subalgebra $\mathbb{A}_d \subseteq \mathbb{A}_X$ generated by the elements $\{a_u x : |u| = |v| \leq d\}$. Since $\Delta : \mathbb{A}_d \to \mathbb{A}_d \otimes \mathbb{A}_d$ the subalgebra \mathbb{A}_d is a quotient quantum group. The abelianisation of \mathbb{A}_d is the algebra $C(\text{Aut}(X^{[d]})$ of continuous functions on the finite group $\text{Aut}(X^{[d]})$.

Definition 5.1. Suppose \mathbb{P} is a quantum subgroup of \mathbb{A}_d , where $\mathbb{P} = \mathbb{A}_d / I$. Denote by $q_I : \mathbb{A}_d \to \mathbb{P}$ the quotient map; so $I = \text{ker}(q_I)$. We denote by J the smallest closed 2-sided ideal of \mathbb{A}_X generated by $\{\rho_w(I) : w \in X^*\}$, and by $A_{\mathbb{P}}$ the quotient $A_{\mathbb{P}} := \mathbb{A}_X / J$. In the next result we prove that $A_{\mathbb{P}}$ is a self-similar quantum group, and we call it a *finitely* constrained self-similar quantum group.

Proposition 5.2. Each $A_{\mathbb{P}}$ is a self-similar quantum group.

To prove Proposition [5.2](#page-14-1) we need two lemmas. Recall that for $g, h \in Aut(X^*)$, $w \in X^*$ we have

$$
(gh)|_w = g|_{\mathcal{L}^{\cdot w}}h|_w.
$$

In the first lemma, we establish an analogous relationship between the comultiplication Δ on \mathbb{A}_X and the restriction maps ρ_w .

Lemma 5.3. For any $n \geq 1, w \in X^n$ and $a \in A_X$ we have

$$
(\Delta \circ \rho_w)(a) = \sum_{y \in X^n} (1 \otimes a_y \mathbf{1}_y)(\rho_y \otimes \rho_w)(\Delta(a)).
$$

Proof. Let $a_u x$ be a generator of \mathbb{A}_X , with $|u| = |v| = k \geq 0$. Then

$$
(\Delta \circ \rho_w)(a_u x) = \Delta \left(\sum_{\in X^n} a_{u} x_{\nu} \right)
$$

\n
$$
= \sum_{y \in X^n} \sum_{\in X^k} \sum_{\in X^n} a_{u} x_{\nu} \otimes a_{y} x_{\nu}
$$

\n
$$
= \sum_{y \in X^n} \sum_{\in X^k} \rho_y(a_{u} x) \otimes a_{y} x_{\nu}
$$

\n
$$
= \sum_{y \in X^n} \sum_{\in X^k} \rho_y(a_{u} x) \otimes a_{y} x_{\nu} \rho_w(a x_{\nu})
$$

\n
$$
= \sum_{y \in X^n} (1 \otimes a_{y} x) (\rho_y \otimes \rho_w) \left(\sum_{\in X^k} a_{u} x \otimes a x_{\nu} \right)
$$

\n
$$
= \sum_{y \in X^n} (1 \otimes a_{y} x) (\rho_y \otimes \rho_w(\Delta(a_{u} x))).
$$

To see that this formula extends to \mathbb{A}_X it's enough to show that for any $w \in X^*$ the map

$$
a \mapsto \sum_{y \in X^n} (1 \otimes a_y \mathbf{X}) (\rho_y \otimes \rho_w) (\Delta(a))
$$

is linear and multiplicative. Linearity is clear, and multiplicativity follows from the orthogonality of the projections $1 \otimes a_y x$ and $1 \otimes a_z x$ for $y \neq z$.

Lemma 5.4. Consider the quotient maps $q_I : \mathbb{A}_d \to \mathbb{A}_d/I$ and $q_J : \mathbb{A}_X \to \mathbb{A}_X/J$. Then for any $n \geq 1$ and $y, w \in X^n$

$$
\ker(q_I \otimes q_I) \subseteq \ker((q_J \circ \rho_y) \otimes (q_J \circ \rho_w)).
$$

Proof. By definition of J we have $I \subseteq J \circ \rho_w$ for any $w \in X^*$. Therefore there is a commuting diagram

$$
\begin{array}{ccc}\n\mathbb{A}_{d} & \xrightarrow{\sim} & \mathbb{A}_{X} \\
\downarrow^{q_{I}} & & \downarrow^{q_{J} \circ w} \\
\mathbb{A}_{d}/I & \xrightarrow{\sim} & \mathbb{A}_{X}/\ker(q_{J} \circ \rho_{w})\n\end{array}
$$

Then if $c \in \ker(q_I \otimes q_I)$ we have

$$
(q_J \circ \rho_y) \otimes (q_J \circ \rho_w)(c) = (\pi_y \circ q_I) \otimes (\pi_w \circ q_I)(c) = \pi_y \otimes \pi_w) \circ (q_I \otimes q_I)(c) = 0,
$$

as required.

Proof of Proposition [5.2.](#page-14-1) To see that $A_{\mathbb{P}}$ is a compact quantum group, it suffices to show that J is a Woronowicz ideal. In other words, we need to show that $\Delta(J) \subset \text{ker}(q_J \otimes q_J)$ where $q_J : \mathbb{A}_X \to \mathbb{A}_X / J =: A_{\mathbb{P}}$ is the quotient map. Since J is generated as an ideal by $\bigcup_{w\in X^*} \rho_w(I)$ it's enough to show that

$$
(q_J \otimes q_J)(\Delta \circ \rho_w(i)) = 0
$$

for any $i \in I$ and $w \in X^*$. Because I is a Woronowicz ideal we know that $\Delta(i) \in$ $\ker(q_I \otimes q_I)$. Then by Lemmas [5.3](#page-15-0) and [5.4](#page-15-1) we have

$$
(q_J \otimes q_J)(\Delta \circ \rho_w(i)) = (q_J \otimes q_J) \left(\sum_{y \in X^n} (1 \otimes a_y \mathbf{X})(\rho_y \otimes \rho_w)(\Delta(i)) \right)
$$

=
$$
\sum_{y \in X^n} (1 \otimes q_J(a_y \mathbf{X})) (q_J \circ \rho_y \otimes q_J \circ \rho_w)(\Delta(i))
$$

= 0.

Finally, $A_{\mathbb{P}}$ is self-similar since by definition of J we have $\rho_w(J) \subset J$ for any $w \in X^*$. \Box

5.3. Free wreath products. It is well known that for any $d \geq 1$ the group $\text{Aut}(X^{[d+1]})$ is isomorphic to the wreath product $\text{Aut}(X^{[d]}) \wr \text{Sym}(X)$. Since $\text{Aut}(X^*)$ is the inverse limit over d of the groups $Aut(X^{[d]})$, it can be thought as the infinitely iterated wreath product $\ldots \wr \text{Sym}(X) \wr \text{Sym}(X)$. It follows that $\text{Aut}(X^*) \cong \text{Aut}(X^*) \wr \text{Sym}(X)$. More generally, it is shown in [\[4\]](#page-23-6) that if $P \le Sym(X) = \text{Aut}(X^{[1]})$, then the finitely constrained self-similar group G_P is the infinitely iterated wreath product ... *\P \P.* In this section we prove in Theorem [5.7](#page-19-0) an analogue of this result for finitely constrained self-similar quantum groups.

In [\[3\]](#page-23-7), Bichon constructs a free wreath product of a compact quantum group by the quantum permutation group $A_s(n)$. Bichon also comments in Remark 2.4 of [\[3\]](#page-23-7) that there is a natural analogue of this construction for free wreath products by quantum subgroups of $\mathbb{A}_{s}(n)$. In this section we formally extend this definition to take free wreath products by any quantum subgroup of $\mathbb{A}_s(n)$, and we prove that the finitely constrained self-similar quantum group $A_{\mathbb{P}}$ induced from a quantum subgroup \mathbb{P} of $A_s(n)$ is a free wreath product by P. We begin by recalling the definition of the free wreath product from [\[3\]](#page-23-7); note that we use our notation \mathbb{A}_1 instead of $A_s(|X|)$.

Definition 5.5. Let X be a set of at least two elements. Let (A, Φ) be a compact quantum group, and P a quantum subgroup of \mathbb{A}_1 . For each $x \in X$, we denote by ν_x the inclusion of A in the free product C^{*}-algebra $(*_{x\in X}A)*\mathbb{P}$. The *free wreath product* of A by $\mathbb P$ is the quotient of $(*_{x\in X}A) * \mathbb{P}$ by the two-sided ideal generated by the elements

$$
\nu_x(a)q_I(a_x y) - q_I(a_x y)\nu_x(a), \ x, y \in X, a \in A.
$$

The resulting C^{*}-algebra is denoted by $A *_{X} \mathcal{F}$, and the quotient map is denoted by q_w . If X is understood, we typically just write $\tilde{A} *_{w} \mathbb{P}$.

Theorem 5.6. Let (A, Φ) be a compact quantum group, and \mathbb{P} a quantum subgroup of \mathbb{A}_1 . The free wreath product $A *_{w} \mathbb{P}$ from Definition [5.5](#page-16-0) is a compact quantum group with comultiplication Φ_w satisfying

(5.1)
$$
\Phi_w(q_w(q_I(a_x\mathbf{x}))) = \sum_{z \in X} q_w(q_I(a_x\mathbf{x})) \otimes q_w(q_I(a_z\mathbf{x}))
$$

(5.2)
$$
\Phi_w(q_w(\nu_x(a))) = \sum_{z \in X} (q_w \otimes q_w) ((\nu_x \otimes \nu_z)(\Phi(a))(q_I(a_x)) \otimes 1)),
$$

for each $x, y \in X$ and $a \in A$.

Proof. Since I is a Woronowicz ideal, we have $\Delta|_I \subseteq \text{ker}(q_I \otimes q_I)$, and so the map $(q_I \otimes q_I)$ q_I) \circ $\Delta_{\mathbb{A}_1}$ descends to a map

$$
\phi \colon \mathbb{P} \to \mathbb{P} \otimes \mathbb{P} \subseteq ((*_{x \in X} A) * \mathbb{P})^{\otimes 2}.
$$

Then $(q_w \otimes q_w) \circ \phi \colon \mathbb{P} \to (A *_{w} \mathbb{P})^{\otimes 2}$ satisfies

$$
(q_w \otimes q_w) \circ \phi(q_I(a_{x\bullet y})) = \sum_{z \in X} q_w(q_I(a_{x\bullet y})) \otimes q_w(q_I(a_{z\bullet y})) \text{ for all } x, y \in X.
$$

For each $x \in X$, consider the continuous linear map $\phi_x \colon A \to (A \ast_w \mathbb{P})^{\otimes 2}$ given by

$$
\phi_x(a)=(q_w\otimes q_w)\left(\sum_{z\in X}(\nu_x\otimes \nu_z)(\Phi(a))(q_I(a_x\cdot x)\otimes 1)\right).
$$

We claim that ϕ_x is a homomorphism. To see this, let $\{a = (a_{\mathcal{X}}) \in M_{d_\lambda}(A) : \lambda \in \Lambda\}$ is be a family of matrices satisfying (1) – (3) of Definition [2.2,](#page-2-4) and \mathcal{A} be the ∗-subalgebra of A spanned by the entries $a_i x$. Let $a, b \in \mathcal{A}$ and use Sweedler's notation to write $\Phi(a) = a_{(1)} \otimes a_{(2)}$ and $\Phi(b) = b_{(1)} \otimes b_{(2)}$. We have

$$
\phi_x(a)\phi_x(b) = \sum_{z \in X} q_w \left(\nu_x(a_{(1)}) q_I(a_x x) \nu_x(b_{(1)}) q_I(a_x x) \right) \otimes q_w(\nu_z(a_{(2)}) \nu_{z'}(b_{(2)})),
$$

and then since

$$
q_w \left(\nu_x(a_{(1)}) q_I(a_x \mathbf{x}) \nu_x(b_{(1)}) q_I(a_x \mathbf{x}) \right) = q_w \left(\nu_x(a_{(1)} b_{(1)}) q_I(a_x \mathbf{x} a_x \mathbf{x}) \right)
$$

= $\delta_z \mathbf{x} q_w \left(\nu_x(a_{(1)} b_{(1)}) q_I(a_x \mathbf{x}) \right),$

we have

$$
\phi_x(a)\phi_x(b) = \sum_{z \in X} q_w \left(\nu_x(a_{(1)}b_{(1)})q_I(a_x \mathbf{x}) \right) \otimes q_w(\nu_z(a_{(2)})\nu_z(b_{(2)}))
$$

$$
= (q_w \otimes q_w) \left(\sum_{z \in X} (\nu_x \otimes \nu_z)(a_{(1)}b_{(1)} \otimes a_{(2)}b_{(2)})(q_I(a_x \mathbf{x}) \otimes 1) \right)
$$

$$
= (q_w \otimes q_w) \left(\sum_{z \in X} (\nu_x \otimes \nu_z)(\Phi(ab))(q_I(a_x \mathbf{x}) \otimes 1) \right)
$$

$$
= \phi_x(ab).
$$

Since A is dense in A, it follows that ϕ_x is a homomorphism on A.

The universal property of $(*_{x\in X}A) * \mathbb{P}$ now gives a homomorphism $\widetilde{\Phi}$: $(*_{x\in X}A) * \mathbb{P} \to$ $(A *_{w} \mathbb{P})^{\otimes 2}$ satisfying

$$
\widetilde{\Phi}(q_I(a_x \mathbf{x})) = \sum_{z \in X} q_w(q_I(a_x \mathbf{x})) \otimes q_w(q_{\mathbb{P}}(a_z \mathbf{x})),
$$

$$
\widetilde{\Phi}(\nu_x(a)) = \sum_{z \in X} (q_w \otimes q_w) ((\nu_x \otimes \nu_z)(\Phi(a))(q_I(a_x \mathbf{x}) \otimes 1)).
$$

For each $a \in \mathcal{A}, x, y \in X$ we have

$$
\widetilde{\Phi}(\nu_x(a)q_I(a_x\mathbf{y})) = \sum_{z \in \mathcal{X} \in X} q_w\left(\nu_x(a_{(1)})q_I(a_x\mathbf{y})q_I(a_x\mathbf{y})\right) \otimes q_w(\nu_z(a_{(2)})q_I(a_{z'\mathbf{y}}))
$$

$$
= \sum_{z \atop \sigma \in \widetilde{\Phi}} q_w \left(q_I(a_x \xi) \nu_x(a_{(1)}) q_I(a_x \xi) \right) \otimes q_w(q_I(a_{z'_{\sigma}} \xi) \nu_z(a_{(2)}))
$$

= $\widetilde{\Phi}(q_I(a_x \xi) \nu_x(a)).$

It follows that $\Phi(\nu_x(a)q_I(a_x\mathbf{x})) = \Phi(q_I(a_x\mathbf{x})\nu_x(a))$ for each $a \in A, x, y \in X$, and hence Φ descends to the desired Φ_w : $A *_{w} \mathbb{P} \to (A *_{w} \mathbb{P})^{\otimes 2}$.

We now claim that $(id \otimes \Phi_w) \circ \Phi_w = (\Phi_w \otimes id) \circ \Phi_w$. Since A is dense in A, to see that $(id \otimes \Phi_w) \circ \Phi_w$ and $(\Phi_w \otimes id) \circ \Phi_w$ agree on each $q_w(\nu_x(A))$, it suffices to show that

$$
(\mathrm{id}\otimes \Phi_w)\circ \Phi_w(q_w(\nu_x(a_\mathbf{\mathcal{X}})))=(\Phi_w\otimes \mathrm{id})\circ \Phi_w(q_w(\nu_x(a_\mathbf{\mathcal{X}})))\text{, for all }\lambda\in\Lambda, 1\leq i,j\leq d\enspace .
$$

Routine calculations using (5.1) and (5.2) show that both sides of this equation are equal to

$$
\sum_{z_{\bullet}^{X'}\in X}\sum_{1\leq\bullet X\leq d_{\lambda}}q_{w}^{\otimes3}\big(\nu_{x}(a_{\bullet X})q_{I}(a_{x_{\bullet}^{X}})\otimes\nu_{z}(a_{\bullet X})q_{I}(a_{z_{\bullet}^{X'}})\otimes\nu_{z'}(a_{\bullet X})\big),
$$

and hence are equal. So we have $(id \otimes \Phi_w) \circ \Phi_w(q_q(\nu_x(A))) = (\Phi_w \otimes id) \circ \Phi_w(q_q(\nu_x(A)))$ for each $x \in X$. It is straightforward to check that evaluating both $(id \otimes \Phi_w) \circ \Phi_w$ and $(\Phi_w \otimes id) \circ \Phi_w$ at $q_I(a_x, y)$ gives

$$
\sum_{z \cdot \mathbf{X}' \in X} q_w^{\otimes 3} \left(q_I^{\otimes 3} \left(a_{x} \mathbf{X} \otimes a_{z} \mathbf{X}' \otimes a_{z'} \mathbf{X} \right) \right).
$$

Hence we have $(id \otimes \Phi_w) \circ \Phi_w = (\Phi_w \otimes id) \circ \Phi_w$.

We now define the matrix a^X by $a^X_{x,y} := q_w(q_I(a_x,y))$, for $x, y \in X$; and for each $\lambda \in \Lambda$, $1 \leq i, j \leq d$, $x, y \in X$, the elements

$$
a(\mathbf{x})_{\mathbf{y}}(X) = q_w(\nu_x(a_\mathbf{x})q_I(a_\mathbf{x})) \in A \ast_w \mathbb{P},
$$

define matrices $a(\mathbf{x}) = (a(\mathbf{x}_{\lambda})^X)$ $(\mathbf{x}, \mathbf{x}, \mathbf{y})$. To finish the proof we have to show that these matrices satisfy (1) – (3) of Definition [2.2.](#page-2-4)

We have

$$
\Phi_w(a_{\mathbf{w}}(\mathbf{x}_i, \mathbf{x}_j, \mathbf{x}_j)) = \Big(\sum_{z \in X} (q_w \otimes q_w) \big((\nu_x \otimes \nu_z) (\Phi(a_{\mathbf{w}})) (q_I(a_{\mathbf{x}} \otimes z) \otimes 1) \big) \Big) (q_w \circ q_I)^{\otimes 2} (\Delta(a_{\mathbf{x}} \mathbf{x})).
$$

We know that (1) is satisfied for the matrix a^X . For each $z \in X$ we have

$$
(q_w \otimes q_w) ((\nu_x \otimes \nu_z)(\Phi(a, x))(q_I(a, x, y \otimes 1))(q_w \circ q_I)^{\otimes 2}(\Delta(a, x, y))
$$

\n
$$
= (q_w \otimes q_w) ((\nu_x \otimes \nu_z)(\sum_{1 \leq \leq d_{\lambda}} a_x \otimes a_x)(q_I(a, x, y \otimes 1))(q_w \circ q_I)^{\otimes 2}(\Delta(a, x, y)))
$$

\n
$$
= \sum_{1 \leq \leq d_{\lambda}} (q_w(\nu_x(a, x)) \otimes q_w(\nu_z(a, x))) (q_w(q_I(a, x, y \otimes 1))(q_w \circ q_I)^{\otimes 2}(\Delta(a, x, y)))
$$

\n
$$
= \sum_{1 \leq \leq d_{\lambda}} (q_w(\nu_x(a, x)) \otimes q_w(\nu_z(a, x))) \sum_{z' \in X} q_w(q_I(a_x, x, y \otimes q_w(q_I(a_z, x, y)))
$$

\n
$$
= \sum_{1 \leq \leq d_{\lambda}} (q_w(\nu_x(a, x)) \otimes q_w(\nu_z(a, x)))(q_w(q_I(a, x, y \otimes q_w(q_I(a, x, y)))
$$

\n
$$
= \sum_{1 \leq \leq d_{\lambda}} q_w(\nu_x(a, x)q_I(a, x, y \otimes q_w(\nu_z(a, x)q_I(a, x, y)))
$$

It follows that

Φw(a (λ,X) (i,x),(j,y)) = X z∈X X 1≤ ≤d^λ qw(νx(ai,k)q^I (ax,z)) ⊗ qw(νz(ak,j)q^I (az,y)) = X z∈X X 1≤ ≤d^λ a (λ,X) (i,x),(k,z) ⊗ a (λ,X) (k,z),(j,y) ,

and so (1) holds for all matrices $a(\cdot^X)$. To see that $a(\cdot^X)$ is invertible, we define $b(\cdot^X)$ by

$$
b(\mathbf{x}^{(X)}_{\mathbf{y}}\mathbf{y}_{\mathbf{y}}) := q_w(q_I(a_{\mathbf{y}}\mathbf{x})\nu_y((a_{\mathbf{y}}\mathbf{x}^{(X)}_{\mathbf{y}})).
$$

Then we have

$$
(a^{(\mathbf{X})}b^{(\mathbf{X})})(\mathbf{X})\mathbf{X}\mathbf{X} = \sum_{z \in X} \sum_{1 \leq \leq d_{\lambda}} a^{(\mathbf{X})}_{z} \mathbf{X} \mathbf{X} b^{(\mathbf{X})}_{z} \mathbf{X} \mathbf{X} \mathbf{Y}
$$
\n
$$
= q_{w} \Big(\sum_{z \in X} \sum_{1 \leq \leq d_{\lambda}} \nu_{x}(a_{\mathbf{X}}) q_{I}(a_{x} \mathbf{X}) q_{I}(a_{y} \mathbf{X}) \nu_{y}((a \quad)^{-1}_{\mathbf{X}}) \Big)
$$
\n
$$
= \delta_{x} \mathbf{X} q_{w} \Big(\sum_{1 \leq \leq d_{\lambda}} \nu_{x}(a_{\mathbf{X}}) \Big(\sum_{z \in X} q_{I}(a_{x} \mathbf{X}) \Big) \nu_{x}((a \quad)^{-1}_{\mathbf{X}}) \Big)
$$
\n
$$
= \delta_{x} \mathbf{X} q_{w} \Big(\nu_{x} \Big(\sum_{1 \leq \leq d_{\lambda}} a_{\mathbf{X}}(a \quad)^{-1}_{\mathbf{X}} \Big) \Big)
$$
\n
$$
= \delta_{x} \mathbf{X} q_{w} \big(\nu_{x}((a \ (a \ ^{-1})_{\mathbf{X}}) \big)
$$
\n
$$
= \delta_{x} \mathbf{X} \mathbf{X} \mathbf{X} \mathbf{X} \mathbf{X} \mathbf{X} \mathbf{X} \mathbf{X} \mathbf{X} \mathbf{X})
$$

A similar calculation shows that $(b^{(.X)}a^{(.X)})_{(.X)}\mathcal{X}\mathcal{Y} = \delta_x\mathcal{Y}\delta_X\mathcal{X}$, and so $a^{(.X)}$ is invertible. Similar calculations also show that $c(\lambda^X)$ with entries

$$
c\left(\underset{\mathbf{w}}{\mathbf{X}}\right)_{\mathbf{y}}\mathbf{X}_{\mathbf{y}}\mathbf{y}_{\mathbf{y}} := q_w(q_I(a_x\mathbf{y})\nu_x(((a))^\mathbf{T})^{-1}_{\mathbf{y}}))
$$

is the inverse of $(a^{\langle X \rangle})^{\mathbf{F}}$.

We also have

$$
(a^X(a^X)^T)_{x*Y} = \sum_{z \in X} a_{x*Y}^X a_{y*Y}^X = q_w \left(q_I \left(\sum_{z \in X} a_{x*Y} a_{y*Y} \right) \right) = \delta_{x*Y} 1.
$$

Similarly, $(a^X)^{\blacktriangledown} a^X$ is the identity. So a^X and $(a^X)^{\blacktriangledown}$ are mutually inverse, and (2) is satisfied.

We now claim that the entries of the matrices $\{a^{(\cdot,X)}: \lambda \in \Lambda\} \cup \{a^X\}$ span a dense subset of $A *_{X} \mathcal{F}$. For each $x, y \in X$ we obviously have $q_w(q_I(a_x \mathcal{F}))$ in this span since they are the entries of a^X . For each $x \in X$, $\lambda \in \Lambda$ and $1 \leq i, j \leq d'$ we have

$$
\sum_{y\in X}a(\underset{\mathbf{w}}{\overset{X}{\sum}}\underset{\mathbf{w}}{\underset{\mathbf{w}}{\sum}}q_{w}\left(\nu_{x}(a_{\underset{\mathbf{w}}{\sum}})q_{I}\left(\sum_{y\in X}a_{x}\underset{\mathbf{w}}{\sum}\right)\right)=q_{w}(\nu_{x}(a_{\underset{\mathbf{w}}{\sum}})) ,
$$

and so each $q_w(\nu_x(a,x))$ is in the span of the entries. The claim follows, and so (3) holds. \Box

Theorem 5.7. Let $A_{\mathbb{P}}$ be a finitely-constrained self-similar quantum group in the sense of Definition [5.1.](#page-14-2) There is a unital quantum group isomorphism $\pi: A_{\mathbb{P}} \to A_{\mathbb{P}} *_{w} \mathbb{P}$ satisfying

(5.3)
$$
\pi(q_J(a_{xy}y_v)) = q_w(q_I(a_{xy}y)v_x(q_J(a_{yz}y)))
$$

for all $x, y \in X$, $u, v \in X$, $m \geq 0$.

Proof. We define b_{\emptyset} to be the identity of $A_{\mathbb{P}} *_{w} \mathbb{P}$, and for each $x, y \in X$, $u, v \in X$, $m \geq$ 0,

$$
b_{xu}y_v := q_w(q_I(a_x y)v_x(q_J(a_u x))).
$$

We claim that this gives a family of projections satisfying (1) – (3) of Definition [3.2.](#page-3-2) Condition (1) holds by definition. We have

$$
b_{xy}^* y_v = q_w \big(\nu_x (q_J(a_{xy}^* \chi)) q_I(a_{xy}^* \chi)\big)
$$

= $q_w \big(\nu_x (q_J(a_{xy} \chi)) q_I(a_{xy} \chi)\big)$
= $q_w \big(q_I(a_{xy} \chi) \nu_x (q_J(a_{xy} \chi))\big)$
= $b_{xy} y_v$

and

 $b_{xu}^2 y_v = q_w(q_I(a_x y)\nu_x(q_J(a_u y))q_I(a_x y)\nu_x(q_J(a_u y))) = q_w(q_I(a_x^2 y)\nu_x(q_J(a_u^2 y))) = b_{xu} y_v.$ So (2) holds. For each $w \in X$ we have

$$
\sum_{z \in X} b_{xuw} \mathbf{y}_{vz} = \sum_{z \in X} q_w (q_I(a_x \mathbf{y}) \nu_x(q_J(a_{uw} \mathbf{y}_z)))
$$

= $q_w (q_I(a_x \mathbf{y}) \nu_x(q_J(\sum_{z \in X} a_{uw} \mathbf{y}_z)))$
= $q_w (q_I(a_x \mathbf{y}) \nu_x(q_J(a_u \mathbf{y})))$
= $b_{xu} \mathbf{y}_v$,

and

$$
\sum_{z \in X} b_{xuz} \mathbf{y}_{vw} = \sum_{z \in X} q_w (q_I(a_x \mathbf{y}) \nu_x (q_J(a_{uz} \mathbf{y}_w)))
$$

= $q_w (q_I(a_x \mathbf{y}) \nu_x (q_J(\sum_{z \in X} a_{uz} \mathbf{y}_w)))$
= $q_w (q_I(a_x \mathbf{y}) \nu_x (q_J(a_u \mathbf{y})))$
= $b_{xu} \mathbf{y}_v$,

and hence (3) holds. This proves the claim, and hence the universal property of \mathbb{A}_X now gives a homomorphism $\widetilde{\pi}$: $\mathbb{A}_X \to A_{\mathbb{P}} *_{w} \mathbb{P}$ satisfying

$$
\widetilde{\pi}(a_{xy} \mathbf{x}_v) = q_w(q_I(a_x \mathbf{x})) \nu_x(q_J(a_y \mathbf{x}))),
$$

for all $x, y \in X$, $u, v \in X$, $m \geq 0$.

We now claim that J is contained in ker $\tilde{\pi}$. To see this, fix $w \in X^n$, with $w = w_1w'$ for $\tilde{\pi} \in X$ and π , $X_n \in X^{n-1}$. We first prove the claim that for each π , i.e., $X_n \in X$ where $w_1 \in X, w' \in X^{n-1}$. We first prove the claim that for each $x := a_{u_1} x_1 \cdots a_{u_k} x_k$, where $k \geq 1$ and each pair $u, v \in X_i$ if or some $m \geq 0$, we have

(5.4)
$$
\widetilde{\pi}(\rho_w(x)) = \sum_{y \in X} q_w \big(q_I(a_y \mathbf{x}_1) \nu_y(q_J(\rho_{w'}(x))) \big).
$$

Let $k = 1$. Then

$$
\widetilde{\pi}(\rho_w(a_{u_1},\mathbf{X}_1)) = \sum_{y \in X} \sum_{\in X^{n-1}} \widetilde{\pi}(a_{y} \mathbf{u}_1, \mathbf{X}_{v_1})
$$

$$
= \sum_{y \in X} \sum_{\substack{\in X^{n-1}}} q_w (q_I(a_{y}x_1) \nu_y(q_J(a_{u_1}x_2 \cdots)))
$$

$$
= \sum_{y \in X} q_w (q_I(a_{y}x_1) \nu_y(q_J(\sum_{\substack{\in X^{n-1}}} a_{u_1}x_2 \cdots)))
$$

$$
= \sum_{y \in X} q_w (q_I(a_{y}x_1) \nu_y(q_J(\rho_{w'}(a_{u_1}x_1)))) ,
$$

and so (5.4) holds for $k = 1$. We now assume true for x, and prove for x_{+1} . Note that for $y, y' \in X$ we have $q_I(a_y \mathbf{x}_1) q_I(a_{y'} \mathbf{x}_1) = \delta_{y} y q_I(a_y \mathbf{x}_1)$, and hence

$$
q_w(q_I(a_{y}x_1)\nu_y(q_J(\rho_{w'}(x')))q_I(a_{y'}x_1)\nu_{y'}(q_J(\rho_{w'}(a_{u_{k+1}}x_{k+1})))))
$$

\n
$$
= q_w(\nu_y(q_J(\rho_{w'}(x')))q_I(a_{y}x_1)q_I(a_{y'}x_1)\nu_{y'}(q_J(\rho_{w'}(a_{u_{k+1}}x_{k+1})))))
$$

\n
$$
= \delta_{y}y'q_w(\nu_y(q_J(\rho_{w'}(x')))q_I(a_{y}x_1)\nu_y(q_J(\rho_{w'}(a_{u_{k+1}}x_{k+1})))))
$$

\n
$$
= \delta_{y}y'q_w(q_I(a_{y'}x_1)\nu_y(q_J(\rho_{w'}(x')))\nu_y(q_J(\rho_{w'}(a_{u_{k+1}}x_{k+1})))))
$$

\n
$$
= \delta_{y}y'q_w(q_I(a_{y'}x_1)\nu_y(q_J(\rho_{w'}(x\ a_{u_{k+1}}x_{k+1}))))).
$$

It follows that

$$
\widetilde{\pi}(\rho_w(x_{+1})) = \widetilde{\pi}(\rho_w(x_{-}))\widetilde{\pi}(\rho_w(a_{u_{k+1}}x_{k+1})) = \sum_{y \in X} q_w(q_I(a_{y'_\bullet x_1})\nu_y(q_J(\rho_{w'}(x_{-}a_{u_{k+1}}x_{k+1})))),
$$

and it follows that (5.4) holds for all k. Since linear combinations of products of the form x is a dense subalgebra of \mathbb{A}_X , it follows that

$$
\widetilde{\pi}(\rho_w(a)) = \sum_{y \in X} q_w \big(q_I(a_{y\bullet w} \omega_1) \nu_y(q_J(\rho_{w'}(a))) \big)
$$

for all $a \in A_X$. Now, if $a \in I$, then $\rho_{w'}(a) \in J = \text{ker } q_J$, and hence the above equations shows that $\tilde{\pi}(\rho_w(a)) = 0$. Hence $\rho_w(a) \in \text{ker } \tilde{\pi}$ for all $w \in X^n$ and $a \in I$, and hence $J \subseteq \text{ker } \widetilde{\pi}$. This means $\widetilde{\pi}$ descends to a homomorphism $\pi: A_{\mathbb{P}} \to A_{\mathbb{P}} *_{w} \mathbb{P}$ satisfying

$$
\pi(q_J(a_{xy}y_v))=q_w\big(q_I(a_xy)\nu_x(q_J(a_yy))\big)
$$

for all $x, y \in X$, $u, v \in X$, $m > 0$.

We now show that π is an isomorphism by finding an inverse. For each $x \in X$ consider the homomorphism $q_J \circ \sigma_x : \mathbb{A}_X \to A_{\mathbb{P}}$, where σ_x is the homomorphism from Remark [4.3.](#page-9-0) Since $\sigma_x = \kappa \circ \rho_x \circ \kappa$, and we know from [\[10,](#page-23-9) Remark 2.10] that $\kappa(J) \subseteq J$, it follows that $q_J \circ \sigma_x$ descends to a homomorphism $\phi_x \colon A_{\mathbb{P}} \to A_{\mathbb{P}}$ satisfying

$$
\phi_x(q_J(a_u\mathbf{x})) = q_J(\sigma_x(a_u\mathbf{x})) = \sum_{y \in X} q_J(a_{xy}\mathbf{x}_v),
$$

for all $u, v \in X_i$, $m \geq 0$.

Each ϕ_x , and the map $q_I(a) \mapsto q_J(a)$ from $\mathbb P$ to $A_{\mathbb P}$, now allow us to apply the universal property of the free product $(*_{x\in X}A_{\mathbb{P}})*\mathbb{P}$ to get a homomorphism $\widetilde{\phi}: (*_{x\in X}A_{\mathbb{P}})*\mathbb{P} \to A_{\mathbb{P}}$ satisfying $\widetilde{\phi} \circ \nu_x = \phi_x$ for each $x \in X$, and $\widetilde{\phi}(q_I(a)) = q_J(a)$ for all $a \in \mathbb{A}_1 \subseteq \mathbb{A}_X$. We claim that

$$
\widetilde{\phi}\big(\nu_x(q_J(a_u x))q_I(a_x y) - q_I(a_x y)\nu_x(q_J(a_u x)\big) = 0,
$$

 $v \in X, \quad m \in \mathbb{N}$ We have

for each $x \in X$, $u, v \in X$, $m \in \mathbb{N}$. We have

$$
\widetilde{\phi}\big(\nu_x(q_J(a_{u_\bullet}\!{\mathbf x}))q_I(a_{x_\bullet}\!{\mathbf y})-q_I(a_{x_\bullet}\!{\mathbf y})\nu_x(q_J(a_{u_\bullet}\!{\mathbf x})\big)
$$

$$
= \phi_x(q_J(a_y\mathbf{x}))q_J(a_x\mathbf{y}) - q_G(a_x\mathbf{y})\phi_x(q_J(a_y\mathbf{x}))
$$

\n
$$
= \sum_{y \in X} q_J(a_{xy}\mathbf{y}_v)q_J(a_x\mathbf{y}) - \sum_{y' \in X} q_J(a_x\mathbf{y})q_J(a_{xy}\mathbf{y}_v)
$$

\n
$$
= q_J(a_{xy}\mathbf{y}_v) - q_J(a_{xy}\mathbf{y}_v)
$$

\n
$$
= 0.
$$

It follows that $\widetilde{\phi}$ descends to a homomorphism $\phi: A_{\mathbb{P}} *_{w} \mathbb{P} \to A_{\mathbb{P}}$ satisfying

$$
\phi(q_w(\nu_x(q_J(a_u\mathbf{x})))) = q_J(\sigma_x(a_u\mathbf{x})) = \sum_{y \in X} q_J(a_{xy}\mathbf{x}_v)
$$

for all $x \in X$, $u, v \in X$, $m \geq 0$, and

$$
\phi(q_w(q_I(a_x \mathbf{x}))) = q_J(a_x \mathbf{x})
$$

for all $x, y \in X$.

We claim that π and ϕ are mutually inverse. For $x, y \in X$, $u, v \in X$, $m \geq 0$, we have

$$
\phi(\pi(q_J(a_{xy}x_{y}))) = \phi(q_w(q_I(a_x x_{y})\nu_x(q_J(a_y x)))) = q_J(a_x x_{y}) \sum_{y \in X} q_J(a_{xy}x_{y}y_{y}) = q_J(a_{xy}x_{y}y_{y}),
$$

and it follows that $\phi \circ \pi$ is the identity on $A_{\mathbb{P}}$. For $x \in X$, $u, v \in X$, $m \geq 0$, we have

$$
\pi(\phi(q_w(\nu_x(q_J(a_y\mathbf{X})))) = \pi\Big(\sum_{y \in X} q_J(a_{xy}\mathbf{y}_v)\Big)
$$

\n
$$
= \sum_{y \in X} q_w(q_I(a_{xy}\mathbf{y})\nu_x(q_J(a_y\mathbf{y})))
$$

\n
$$
= q_w\Big(q_I\Big(\sum_{y \in X} a_{xy}\mathbf{y}\Big)\nu_x(q_J(a_y\mathbf{y}))\Big)
$$

\n
$$
= q_w(\nu_x(q_J(a_y\mathbf{y}))),
$$

and for all $x, w \in X$ we have

$$
\pi(\phi(q_w(q_I(a_x\mathbf{x}))) = \pi(q_J(a_x\mathbf{x})) = q_w(q_I(a_x\mathbf{x})).
$$

Hence $\pi \circ \phi$ is the identity on $A_{\mathbb{P}} *_{w} \mathbb{P}$, and so π is an isomorphism.

We now need to show that π is a homomorphism of compact quantum groups, which means that $\Delta_w \circ \pi = (\pi \otimes \pi) \circ \Delta_J$, where Δ_J is the comultiplication on $A_{\mathbb{P}}$. For $x, y \in X$, $u, v \in X_l$, $m \geq 0$, we have

$$
(\pi \otimes \pi) \circ \Delta_J(q_J(a_{xy}y_v))
$$

=
$$
\sum_{m+1} \pi(q_J(a_{xy}x)) \otimes \pi(q_J(a_{xy}y_v))
$$

=
$$
\sum_{z \in X} \sum_{\in X^m} \pi(q_J(a_{xy}y)) \otimes \pi(q_J(a_{z,y}y_v))
$$

=
$$
\sum_{z \in X} \sum_{\in X^m} q_w(q_I(a_{xy}y)v_x(q_J(a_{yy}x))) \otimes q_w(q_I(a_{zy}y)v_x(q_J(a_{zy}y))).
$$

We have

$$
\Delta_w \circ \pi(q_J(a_{xy}g_v)) = \Delta_w(q_w(q_I(a_xg))) \Delta_w(q_w(\nu_x(q_J(a_yg))),
$$

where

(5.5)
$$
\Delta_w(q_w(q_I(a_x\mathbf{x}))) = \sum_{z \in X} q_w(q_I(a_x\mathbf{x})) \otimes q_w(q_{\mathbb{P}}(a_z\mathbf{x})),
$$

and

$$
\Delta_w(q_w(\nu_x(q_J(a_u\mathbf{x}))) = \sum_{z' \in X} (q_w \otimes q_w) ((\nu_x \otimes \nu_{z'})(\Delta_J(q_J(a_u\mathbf{x}))) (q_I(a_x\mathbf{x})) \otimes 1))
$$

(5.6)

$$
= \sum_{z' \in X} \sum_{\in X'''} q_w(\nu_x(q_J(a_u\mathbf{x})) q_I(a_x\mathbf{x})) \otimes q_w(\nu_{z'}(q_J(a_x\mathbf{x}))).
$$

A typical summand in the product of the expressions in [\(5.5\)](#page-23-10) and [\(5.6\)](#page-23-11) is

$$
q_w(q_I(a_{x\cdot y})\nu_x(q_J(a_{y\cdot x}))q_I(a_{x\cdot y})) \otimes q_w(q_{\mathbb{P}}(a_{z\cdot y})\nu_{z'}(q_J(a_{\cdot y})))
$$

\n
$$
= q_w(\nu_x(q_J(a_{y\cdot x}))q_I(a_{x\cdot y})q_I(a_{x\cdot y})) \otimes q_w(q_{\mathbb{P}}(a_{z\cdot y})\nu_{z'}(q_J(a_{\cdot y})))
$$

\n
$$
= \delta_{z\cdot y}q_w(\nu_x(q_J(a_{y\cdot x}))q_I(a_{x\cdot y})) \otimes q_w(q_{\mathbb{P}}(a_{z\cdot y})\nu_z(q_J(a_{\cdot y})))
$$

\n
$$
= \delta_{z\cdot y}q_w(q_I(a_{x\cdot y})\nu_x(q_J(a_{y\cdot x}))) \otimes q_w(q_{\mathbb{P}}(a_{z\cdot y})\nu_z(q_J(a_{\cdot y})))
$$
.

Hence

$$
\Delta_w \circ \pi(q_J(a_{xy}y_v)) = \sum_{z \in X} q_w(q_I(a_xy)) \otimes q_w(q_{\mathbb{P}}(a_zy))
$$

=
$$
\sum_{z \in X} \sum_{z \in X^m} q_w(q_I(a_xy)v_x(q_J(a_yx))) \otimes q_w(q_I(a_zy)v_x(q_J(a_yy)))
$$

=
$$
(\pi \otimes \pi) \circ \Delta_J(q_J(a_{xy}y_v)),
$$

and it follows that $\Delta_w \circ \pi = (\pi \otimes \pi) \circ \Delta_J$.

Example 5.8. An immediate consequence of Theorem [5.7](#page-19-0) is that $A_{\mathbb{P}}$ is noncommutative whenever $\mathbb P$ is a noncommutative quantum subgroup of $\mathbb A_1$. A class of such examples comes from Banica and Bichon's [\[1,](#page-23-4) Theorem 1.1], in which they classify all the quantum subgroups $\mathbb P$ of $\mathbb A_1$ for $|X|=4$; the corresponding list of quantum groups $A_{\mathbb P}$ gives us a list of potentially interesting self-similar quantum groups for further study.
