Finite Field Multiple Access for Sourced Massive Random Access with Finite Blocklength

Abstract—For binary source transmission, this paper proposes an element-pair (EP) coding scheme for supporting sourced massive random access, which is used to solve the finite blocklength (FBL) of multiuser reliability transmission problem. In this paper, we first give the definition of an EP, which is used as a virtual resource. If the Cartesian product of J distinct EPs satisfies the unique sum-pattern mapping (USPM) structural property, the J distinct EPs can form an uniquely-decodable EP (UD-EP) code. Then, we introduce a type of orthogonal EP code $\Psi_{o,B}$ constructed over an extension field $GF(2^m)$. Based on the proposed EP code, we present finite-field multiple-access (FFMA) systems, including both the sparse-form-based and diagonalform-based forms. Simulation results show that, for the massive random access scenario, the error performance of the proposed FFMA systems over a Gaussian multiple-access channel can provide much better error performance than that of a slotted ALOHA system.

Index Terms—Massive multiple access, sourced random access, slotted ALOHA, binary source transmission, element pair (EP), finite-field multi-access (FFMA), finite blocklength (FBL), Gaussian multiple-access channel (GMAC).

I. INTRODUCTION

For the next generation of wireless communication, ultra massive machine type communication (um-MTC) is required to serve a huge number of users (or devices) simultaneously, e.g., the connection density of an um-MTC system is around $10^6 \sim 10^8$ devices/km² [1]–[3]. The required multiple-access (MA) technique should simultaneously support massive users with short packet traffic, and achieve an acceptable *per-user probability of error (PUPE)* [4].

In general, grant-free random access (RA) is considered as a promising MA scheme for supporting um-MTC communications [5], [6]. A grant-free random access can be classified into sourced and unsourced RA schemes, which can be applied in different scenarios [7]–[9]. In this paper, we focus on the sourced RA, which is used to serve device-oriented scenarios, e.g., monitoring the status of sensors, enabling the base station (BS) to be aware of both the messages and users (or devices) identities [5]. For a sourced RA system, each user is assigned a unique signature to identify the active user(s) at the BS. Typically, we can use different resources, sequences and/or codebooks to identity different users. The classical sourced RA system utilizes time slots to distinguish users, operating in a *slotted ALOHA* scheme, which simplifies both the active user detection and multiuser detection algorithms [10].

Nevertheless, for the massive random access scenario, the reliable performance of the slotted ALOHA scheme is limited by the blocklength of each time slot [11]–[13]. Let the blocklength (or the number of degrees of freedom) be a constant denoted by N, which is also called finite blocklength (FBL) constraint. Suppose there are totally J users. To separate users without ambiguity, the number of time slots is set to be equal to the number of users J. Thus, the blocklength of each time slot is equal to N/J. According to [12], we know that the maximal rate of each time slot is equal to

$$C(P) - \sqrt{\frac{V(P)}{(N/J)}}Q^{-1}(\epsilon) + \frac{1}{2}\frac{\log(N/J)}{(N/J)} + \mathcal{O}(\frac{1}{(N/J)})$$

where C(P) is the channel capacity, P is the maximal power constraint and the noise variance is set to be 1. $Q(\cdot)$ is the Q-function, and ϵ is the average error probability. $V(P) = \frac{P(P+2)}{2(1+P)^2}$ is the dispersion of the Gaussian channel. Obviously, the maximal rate of each time slot decreases with the increased number of users J, especially J is a large value. Hence, it is challenging to design suitable schemes for solving the FBL of massive users reliability transmission problem.

In this paper, an MA coding is devised based on the *element*pair (EP) code constructed over finite fields (FFs) [15]. We refer the proposed MA technique based on EP-coding as *finite*field MA (FFMA) technique (or coding). An MA communication system using FFMA-coding is referred to as an FFMA system for simplicity. Unlike the slotted ALOHA scheme whose blocklength is N/J, the proposed FFMA system can achieve error correction ability from all the degrees of freedom (DoF), i.e., using the entire blocklength N. At the receiving end, we can recover the superposition multiuser information by a simple detector. In addition, for the proposed sparseform-based FFMA system, it can naturally obtain the active users' information from the finite-field, thereby avoiding the need to address the active user detection issue.

The rest of this paper is organized as follows. Section II introduces the concept of EP-coding and presents an orthogonal EP code constructed over $GF(2^m)$. The encoding of the orthogonal EP code is introduced in Section III. Section IV presents an FFMA system for a massive MA transmission. In Section V, simulations of the error performances of the proposed FFMA systems are given. Section VI concludes the paper with some remarks.

In this paper, the symbol $\mathbb{B} = \{0, 1\}$ and \mathbb{C} are used to denote the binary-field and complex-field. The notation $(a)_q$ stands for modulo-q, and/or an element in GF(q).

II. ORTHOGONAL EP CODE OVER $GF(2^m)$

Suppose GF(q) is a finite-field with q elements, where q is a prime number or a power of the prime number. Let α denote a

primitive element of GF(q), and the powers of α , i.e., $\alpha^{-\infty} =$ $0, \alpha^0 = 1, \alpha, \alpha^2, \dots, \alpha^{(q-2)}$, give all the q elements of GF(q). For binary source transmission, a transmit bit is either $(0)_2$ or $(1)_2$. We utilize two different elements in a finite-field GF(q)to express the bit information, i.e., $(0)_2 \mapsto \alpha^{l_{j,0}}$ and $(1)_2 \mapsto$ $\alpha^{l_{j,1}}$, where $\alpha^{l_{j,0}}, \alpha^{l_{j,1}} \in GF(q)$ and $l_{j,0} \neq l_{j,1}$. We define the selected two elements $(\alpha^{l_{j,0}}, \alpha^{l_{j,1}})$ as an *element pair (EP*).

In this paper, we construct orthogonal element pair (EP) codes over $GF(2^m)$, where $q = 2^m$ and m is a positive integer with $m \ge 2$. Let α be a primitive element in $GF(2^m)$. Then, each element α^{l_j} , with $l_j = -\infty, 0, \dots, 2^m - 2$, in GF(2^m) can be expressed as a linear sum of $\alpha^0 = 1, \alpha, \alpha^2, \dots, \alpha^{(m-1)}$ with coefficients from GF(2) as follows:

$$\alpha^{l_j} = a_{j,0} + a_{j,1}\alpha + a_{j,2}\alpha^2 + \ldots + a_{j,m-1}\alpha^{(m-1)}.$$

From (1), we see that the element α^{l_j} can be uniquely represented by the *m*-tuple $(a_{j,0}, a_{j,1}, \ldots, a_{j,m-1})$ over GF(2), which is a linear combination of $\alpha^0, \alpha^1, \ldots, \alpha^{m-1}$, i.e., $\alpha^{l_j} = \oplus_{i=0}^{m-1} a_{j,i} \alpha^i$. For $0 \leq i < m$, it is known that $\alpha^i = (0, 0, \dots, 1, 0, \dots, 0)$ is an *m*-tuple with a 1-component at the *i*-th location and 0s elsewhere.

Based on the finite-field $GF(2^m)$, we define m EPs as 0

$$C_{1} = (0, \alpha^{0}) = \alpha^{0} \cdot C_{B} = \{\mathbf{0}, (1, 0, \dots, 0)\}, C_{2} = (0, \alpha^{1}) = \alpha^{1} \cdot C_{B} = \{\mathbf{0}, (0, 1, \dots, 0)\}, \vdots C_{m} = (0, \alpha^{m-1}) = \alpha^{m-1} \cdot C_{B} = \{\mathbf{0}, (0, 0, \dots, 1)\},$$

where **0** is an *m*-tuple of zeros, and $C_{\rm B} = (0, 1)$. The subscript "B" stands for "binary". Hence, for $1 \le j \le m$, the *j*-th EP C_i is given as $C_i = \alpha^{j-1} \cdot C_{\rm B}$. Then, the *m* EPs together can form an EP set, defined by $\Psi_{o,B}$, i.e.,

$$\Psi_{o,B} = \{C_1, C_2, \dots, C_m\}, = \{\alpha^0 \cdot C_B, \alpha^1 \cdot C_B, \dots, \alpha^{m-1} \cdot C_B\}.$$

With $0 \le i \le m$, it is found that $\alpha^0, \alpha^1, \ldots, \alpha^{m-1}$ are *mutu*ally disjoint, i.e., $\alpha^i \cap \alpha^k = \emptyset$ for $i \neq k$ and $0 \leq i, k < m$. In this case, any two different EPs in $\Psi_{o,B}$, e.g., C_i and $C_{i'}$ where $j \neq j'$, are *orthogonal* to each other.

Let $(u_1, u_2, \ldots, u_j, \ldots, u_J)$ be a *J*-tuple over $GF(2^m)$ in which the *j*-th component u_i is an element from the EP C_i , where $1 \leq j \leq J$ and $J \leq m$. The J-tuple (u_1, u_2, \ldots, u_J) is an element in the Cartesian product $C_1 \times C_2 \times \ldots \times C_J$ of the EPs in the EP set $\Psi_{o,B}$. We view each J-tuple $\mathbf{u} =$ $(u_1, u_2, \ldots, u_j, \ldots, u_J)$ in $C_1 \times C_2 \times \ldots \times C_J$ as a J-user EP codeword. In our paper, $\Psi_{o,B}$ stands for an EP set and also an EP code. Hence, the Cartesian product

$$\Psi_{\mathbf{o},\mathbf{B}} \triangleq (\alpha^0 \cdot C_{\mathbf{B}}) \times (\alpha^1 \cdot C_{\mathbf{B}}) \times \ldots \times (\alpha^{m-1} \cdot C_{\mathbf{B}}),$$

of the *m* EPs in $\Psi_{o,B}$ can form an *m*-user EP code over $GF(2^m)$ with 2^m codewords.

Let (u_1, u_2, \ldots, u_J) and $(u'_1, u'_2, \ldots, u'_J)$ be any two Jtuples in $C_1 \times C_2 \times \ldots \times C_J$ of the EP code $\Psi_{o,B}$. If $\bigoplus_{j=1}^J u_j \neq j$ $\bigoplus_{i=1}^{J} u'_{i}$, then an finite-field sum-pattern (FFSP) w uniquely specifies a J-tuple in $C_1 \times C_2 \times \ldots \times C_J$. That is to say the mapping

$$(u_1, u_2, \dots, u_J) \iff w = \bigoplus_{j=1}^{n} u_j,$$
 (3)

is a one-to-one mapping. In this case, given the FFSP $w = \bigoplus_{j=1}^{J} u_j$, we can uniquely recover the J-tuple (u_1, u_2, \ldots, u_J) without ambiguity. We say that the Cartesian product $C_1 \times C_2 \times \ldots \times C_J$ has a unique sum-pattern mapping (USPM) structural property, and form an uniquely-decodable EP (UD-EP) code.

Because of the orthogonality between any two EPs in $\Psi_{0,B}$, it is easy to know the EP codeword in $\Psi_{o,B}$ has USPM structural property. We call $\Psi_{o,B}$ a J-user orthogonal uniquely decodable EP (UD-EP) code over $GF(2^m)$, simply a J-user orthogonal UD-EP code. When this code is used for an MA communication system with J users, the j-th component u_j in a codeword (u_1, u_2, \ldots, u_J) is the element to be transmitted by the *j*-th user.

III. ENCODING OF ORTHOGONAL EP CODES

In this section, we first introduce the encoder of an EP code $\Psi_{o,B}$. Then, we investigate the orthogonal UD-EP codes $\Psi_{o,B}$ encoded by a channel encoder C_{gc} . The subscript "gc" of C_{gc} stands for "globe code", since the channel code C_{qc} is used through the MA transmission.

A. Binary to Finite-field GF(q) Transform Function

Let the bit-sequence at the output of the *j*-th user be $\mathbf{b}_{j} = (b_{j,0}, b_{j,1}, \dots, b_{j,k}, \dots, b_{j,K-1})$, where K is a positive integer, $1 \le j \le J$ and $0 \le k < K$. The EP encoder is to map each bit-sequence \mathbf{b}_j uniquely into an element-sequence $\mathbf{u}_{j} = (u_{j,0}, u_{j,1}, \dots, u_{j,k}, \dots, u_{j,K-1})$ by a binary to finitefield GF(q) transform function F_{B2q} , i.e., $u_{j,k} = F_{B2q}(b_{j,k})$.

Assume each user is assigned an EP, e.g., the EP of $C_i =$ $(\alpha^{l_{j,0}}, \alpha^{l_{j,1}})$ is assigned to the *j*-th user for $1 \leq j \leq J$. The subscript "j" of " $l_{j,0}$ " and " $l_{j,1}$ " stands for the j-th EP, and the subscripts "0" and "1" of " $l_{i,0}$ " and " $l_{i,1}$ " represent the input bits are $(0)_2$ and $(1)_2$, respectively. For $1 \le j \le J$, we can set the k-th component $u_{j,k}$ of \mathbf{u}_j as

$$u_{j,k} = \mathcal{F}_{B2q}(b_{j,k}) \triangleq b_{j,k} \odot C_j = \begin{cases} \alpha^{l_{j,0}}, & b_{j,k} = 0\\ \alpha^{l_{j,1}}, & b_{j,k} = 1 \end{cases}$$

where $b_{j,k} \odot C_j$ is defined as a switching function. If the input bit is $b_{j,k} = 0$, the transformed element is $u_{j,k} = \alpha^{l_{j,0}}$; otherwise, $u_{j,k}$ is equal to $u_{j,k} = \alpha^{l_{j,1}}$.

Let the input *bit-block* of J users at the k-th component denote by $\mathbf{b}[k]$, i.e., $\mathbf{b}[k] = (b_{1,k}, b_{2,k}, \dots, b_{J,k})$, where $0 \leq 0$ k < K. We also call the EP codeword $(u_{1,k}, u_{2,k}, \ldots, u_{J,k})$ in $\Psi_{o,B}$ as the output *element-block* of the k-th component of J users, i.e., $\mathbf{u}[k] = (u_{1,k}, u_{2,k}, \dots, u_{J,k}).$

We assign the UD-EP C_j in $\Psi_{o,B}$ to the *j*-th user for $1 \leq j$ $j \leq J = m$. Then, the multiplexing of the k-th components of m users, i.e., $u_{1,k}, u_{2,k}, \ldots, u_{m,k}$, is calculated as

$$w_{k} = u_{1,k} + u_{2,k} + \dots + u_{m,k}$$

$$\stackrel{(a)}{=} b_{1,k}\alpha^{0} + b_{2,k}\alpha^{1} + \dots + b_{m,k}\alpha^{m-1} = \mathbf{b}[k] \cdot \mathbf{G}_{\mathbf{M}}^{1},$$

where (a) is deduced based on the orthogonal UD-EP code $\Psi_{o,B}$ given by (2) and Eq. (4). We call G_{M}^{1} the generator matrix, given as

$$\mathbf{G}_{\mathrm{M}}^{\mathbf{1}} = \begin{bmatrix} \alpha^{0} \\ \alpha^{1} \\ \vdots \\ \alpha^{m-1} \end{bmatrix} = \begin{bmatrix} 1 & 0 & \dots & 0 \\ 0 & 1 & \dots & 0 \\ \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & \dots & 1 \end{bmatrix},$$

which is an $m \times m$ identity matrix. Thus, based on the orthogonal UD-EP code $\Psi_{o,B}$, the proposed system is *a type of time division multiple-access in finite-field (FF-TDMA)*, in which the outputs of the *m* users completely occupy *m* locations in an *m*-tuple.

B. Orthogonal Encoding of an Error-Correcting Code

For $0 \leq j < m$, we form the following element-sequence $\mathbf{u}_j = (u_{j,0}, u_{j,1}, \dots, u_{j,k}, \dots, u_{j,K-1})$, which is then multiplied α^j , given by

$$\mathbf{u}_j \cdot \alpha^j \triangleq (u_{j,0}\alpha^j, u_{j,1}\alpha^j, \dots, u_{j,k}\alpha^j, \dots, u_{j,K-1}\alpha^j).$$

Next, the *m* element-sequences, i.e., $\mathbf{u}_0 \cdot \alpha^0, \mathbf{u}_1 \cdot \alpha^1, \dots, \mathbf{u}_{m-1} \cdot \alpha^{m-1}$, can form an FFSP sequence as follows:

$$\mathbf{w} = \mathbf{u}_0 \cdot \alpha^0 + \mathbf{u}_1 \cdot \alpha^1 + \ldots + \mathbf{u}_j \cdot \alpha^j + \ldots + \mathbf{u}_{m-1} \cdot \alpha^{m-1},$$

where $\mathbf{w} = (w_0, w_1, \dots, w_{K-1})$, and w_k is an *m*-tuple. It indicates that a sequence \mathbf{w} over $GF(2^m)$ can be decomposed into *m* element-sequences $\mathbf{u}_0, \mathbf{u}_1, \dots, \mathbf{u}_{m-1}$.

Let \mathbf{G}_{gc} be the generator matrix of a binary (N, Km)linear block code \mathcal{C}_{gc} . Then, we encode w into a codeword v in \mathcal{C}_{gc} using the generator \mathbf{G}_{gc} , i.e., $\mathbf{v} = \mathbf{w} \cdot \mathbf{G}_{gc} = (v_0, v_1, v_2, \dots, v_{N-1})$. It is able to derive that

$$\mathbf{v} = \mathbf{w} \cdot \mathbf{G}_{gc}$$

= $(\mathbf{u}_0 \cdot \mathbf{G}_{gc}) \alpha^0 \oplus (\mathbf{u}_1 \cdot \mathbf{G}_{gc}) \alpha^1 \oplus \ldots \oplus (\mathbf{u}_{m-1} \cdot \mathbf{G}_{gc}) \alpha^{m-1}$
= $\mathbf{v}_0 \alpha^0 \oplus \mathbf{v}_1 \alpha^1 \oplus \ldots \oplus \mathbf{v}_{m-1} \alpha^{m-1}$.

where $\mathbf{v}_j = \mathbf{u}_j \mathbf{G}_{gc}$ is the codeword of \mathbf{u}_j for $0 \le j < m$. The codeword \mathbf{v} in orthogonal form is referred to as *orthogonal encoding* of the message \mathbf{w} , indicating the codeword \mathbf{v} is the FFSP of the codewords $\mathbf{v}_0, \mathbf{v}_1, \dots, \mathbf{v}_{m-1}$.

IV. AN FFMA SYSTEM IN A GMAC

This section presents an FFMA system over a GMAC, based on the orthogonal UD-EP code $\Psi_{o,B}$, i.e., $\Psi_{o,B} = \{C_1, C_2, \ldots, C_j, \ldots, C_J\}$, where $C_j = \alpha^{j-1} \cdot C_B$ for $1 \le j \le J \le m$. The UD-EP C_j is assigned to the *j*-th user.

The block diagram for such a system is shown in Fig. 1. At the transmitter, there are three modules, which are the EP code encoder denoted by F_{B2q} , the channel code encoder, and the modulation denoted by F_{F2C} , where F_{F2C} stands for finite-field to complex-field transform function. In fact, the combination of EP code and channel code can be regarded

as a *cascade code*, which is used to implement *mulituser* channel code. At the receiving end, it explores the reverse operations, which are demodulation denoted by F_{C2F} , channel code decoding, and EP code decoding denoted by F_{q2B} .

A. Transmitter of a Sparse-form-based FFMA System

Let $\mathbf{b}_j = (b_{j,0}, b_{j,1}, \dots, b_{j,k}, \dots, b_{j,K-1})$ be the bitsequence of the *j*-th user, where $1 \leq j \leq J$ and $0 \leq k < K$. The transmitter maps each bit-sequence \mathbf{b}_j uniquely into an element-sequence $\mathbf{u}_j = (u_{j,0}, u_{j,1}, \dots, u_{j,k}, \dots, u_{j,K-1})$ by F_{B2q} , i.e., $u_{j,k} = F_{B2q}(b_{j,k})$, which is determined by the EP $C_j = \alpha^{j-1} \cdot C_B$. For $0 \leq k < K$, the *k*-th element $u_{j,k}$ of \mathbf{u}_j is represented by its corresponding *m*-tuple representation over GF(2), i.e., $u_{j,k} = (u_{j,k,0}, u_{j,k,1}, \dots, u_{j,k,i}, \dots, u_{j,k,m-1})$, where $0 \leq i < m$. Then, the *m*-tuple form of $u_{j,k}$ is

$$u_{j,k} = F_{B2q}(b_{j,k}) = (0, \dots, 0, b_{j,k}, 0, \dots, 0),$$
 (14)

and the *i*-th component of $u_{j,k}$ is

$$u_{j,k,i} = \begin{cases} b_{j,k}, & i = j - 1\\ 0, & i \neq j - 1 \end{cases}$$
(15)

For a large m, $u_{j,k}$ is a sparse vector with only one element at the (j-1)-th location, and the other locations are all 0s. For the binary form of the element-sequence **u**, its length is equal to Km.

Next, the element-sequence \mathbf{u}_j of the *j*-th user is encoded into a codeword \mathbf{v}_j of a binary (N, Km) linear block code C_{gc} . Suppose the $Km \times N$ generator matrix of C_{gc} is in systematic form, defined by $\mathbf{G}_{gc,sym}$. Then, the codeword \mathbf{v}_j is of the following form

$$\mathbf{v}_j = \mathbf{u}_j \cdot \mathbf{G}_{gc,sym} = (\mathbf{u}_j, \mathbf{v}_{j,red}),$$

where $\mathbf{v}_{j,red}$ is the parity-check (or called redundancy) block, and the subscript "red" stands for "redundancy". In the systematic form, the codewords of m users can be arranged in an $m \times N$ codeword matrix $\mathbf{V} = [\mathbf{v}_1, \mathbf{v}_2, \dots, \mathbf{v}_j, \dots, \mathbf{v}_m]^T$, where $1 \le j \le m$ and J = m. The codeword matrix \mathbf{V} can be divided into two sub-matrices, \mathbf{U} and \mathbf{E} , given as

$$\mathbf{V} = \begin{bmatrix} \mathbf{V}_{1} \\ \mathbf{V}_{2} \\ \vdots \\ \mathbf{V}_{J} \end{bmatrix} = [\mathbf{U}, \mathbf{E}] = \begin{bmatrix} u_{1,0} & u_{1,1} & \dots & u_{1,K-1} & \mathbf{V}_{1,red} \\ u_{2,0} & u_{2,1} & \dots & u_{2,K-1} & \mathbf{V}_{2,red} \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ u_{J,0} & u_{J,1} & \dots & u_{J,K-1} & \mathbf{V}_{J,red} \end{bmatrix}$$
(16)

The sub-matrix **U** of **V** is a $1 \times K$ information array, i.e., $\mathbf{U} = [\mathbf{U}_0, \mathbf{U}_1, \dots, \mathbf{U}_k, \dots, \mathbf{U}_{K-1}]$, and \mathbf{U}_k for $0 \le k < K$ is an $m \times m$ matrix. For the sub-matrix **U**, J information bits $b_{1,k}, b_{2,k}, \dots, b_{J,k}$ from the J users are lying on the main diagonal of \mathbf{U}_k . The sub-matrix **E** of **V** is a $J \times (N - Km)$ matrix which consists of all the parity-check bits formed based on the generator matrix. To support massive users with short packet transmission scenario, m may be very large. In this case, V is a sparse matrix, and we call V a *sparse codeword matrix*.

Then, each codeword \mathbf{v}_j is modulated by BPSK signaling and mapped to a complex-field signal sequence $\mathbf{x}_j \in \mathbb{C}^{1 \times N}$, i.e., $\mathbf{x}_j = (x_{j,1}, x_{j,2}, \dots, x_{j,n}, \dots, x_{j,N-1})$. For $0 \le n < N$, the *n*-th component $x_{j,n}$ is given by

$$x_{j,n} = 2v_{j,n} - 1, (17)$$

where $x_{j,n} \in \{-1, +1\}$. The mapping from \mathbf{v}_j to \mathbf{x}_j is regarded as *finite-field to complex-field transform*, denoted by F_{F2C} , i.e., $x_{j,n} = F_{F2C}(v_{j,n})$. Then \mathbf{x}_j is sent to a GMAC.

B. Receiver of a Sparse-form-based FFMA System

At the receiving end, the received signal sequence $\mathbf{y} \in \mathbb{C}^{1 \times N}$ is the combined outputs of the *J* users plus noise, i.e.,

$$\mathbf{y} = \sum_{j=1}^{J} \mathbf{x}_j + \mathbf{z} = \mathbf{r} + \mathbf{z},$$
(18)

where $\mathbf{z} \in \mathbb{C}^{1 \times N}$ is an AWGN vector with $\mathcal{N}(0, N_0/2)$. The sum in \mathbf{y} is called *complex-field sum-pattern (CFSP)* signal sequence, i.e., $\mathbf{r} = (r_0, r_1, \dots, r_n, \dots, r_{N-1}) \in \mathbb{C}^{1 \times N}$, which is the sum of the J modulated signal sequences $\mathbf{x}_1, \mathbf{x}_2, \dots, \mathbf{x}_J$, i.e., $r_n = \sum_{j=1}^J x_{j,n}$.

To separate the superposition signals, the classical method is to utilize *multiuser interference cancellation* algorithms, e.g., successive interference cancellation (SIC). In our paper, we present another solution based on the USPM structural property of the orthogonal UD-EP code $\Psi_{o,B}$. We only need to map each CFSP signal r_n to an FFSP symbol v_n , i.e., $r_n \mapsto v_n$, and then the bit-sequences of J-user can be recovered by decoding the EP codeword.

Thus, the first step of the detection process is to transform the received CFSP signal sequence $\mathbf{r} = (r_0, r_1, \ldots, r_n, \ldots, r_{N-1})$ into its corresponding FFSP codeword sequence $\mathbf{v} = (v_0, v_1, \ldots, v_n, \ldots, v_{N-1})$ by a *complex*field to finite-field (C2F) transform function F_{C2F} , i.e., $v_n = F_{C2F}(r_n)$ for $0 \le n < N$. We find the following facts of the CFSP r_n and FFSP v_n .

- The value of CFSP r_n is determined by the number of users who send "+1" and the number of users who send "-1". Thus, the set of r_n's values in ascendant order is Ω_r = {-J, -J+2, ..., J-2, J}, in which the difference between two adjacent values is 2. The total number of Ω_r is equal to |Ω_r| = J + 1.
- 2) The value of v_n is uniquely determined by the number of $(1)_2$ bits coming from the *J* users. If there are odd number of bits $(1)_2$ from the *J* users, then $v_n = (1)_2$; otherwise, $v_n = (0)_2$. The corresponding FFSP set Ω_v of Ω_r is $\Omega_v = \{0, 1, 0, 1, ...\}$, in which $(0)_2$ and $(1)_2$ appear alternatively.
- Let C^ι_J denote the number of users which send "+1". The values of ι are from 0 to J. When ι = 0, it indicates that all the J users send (0)₂. If ι increases by one, the number of (1)₂ bits coming from J users increases by one accordingly.

Assume that $v_n = (0)_2$ and $v_n = (1)_2$ are equally likely, i.e., $\Pr(v_n = 0) = \Pr(v_n = 1) = 0.5$. Then, the probabilities of the elements in Ω_r are

$$\mathcal{P}_r = \left\{ C_J^0 / 2^J, C_J^1 / 2^J, \dots, C_J^{J-1} / 2^J, C_J^J / 2^J \right\}.$$

Based on the relationship between r_n and v_n , we can calculate the posterior probabilities $Pr(v_n = 0|y_n)$ and $Pr(v_n = 1|y_n)$ for decoding y [15].

When the generator matrix $\mathbf{G}_{gc,sym}$ in systematic form is utilized, the decoded FFSP codeword sequence $\hat{\mathbf{v}}$ can be expressed as $\hat{\mathbf{v}} = (\hat{\mathbf{w}}, \hat{\mathbf{v}}_{red})$, where $\hat{\mathbf{w}}$ and $\hat{\mathbf{v}}_{red}$ are the detected FFSP sequence and parity-check block, respectively.

After removing the parity-check block $\hat{\mathbf{v}}_{red}$ from $\hat{\mathbf{v}}$, the detected FFSP sequence $\hat{\mathbf{w}}$ can be divided into K FFSP blocks, and each block consists of m bits formed an m-tuple, i.e., $\hat{\mathbf{w}} = (\hat{w}_0, \hat{w}_1, \dots, \hat{w}_k, \dots, \hat{w}_{K-1})$, where $\hat{w}_k = (\hat{w}_{k,0}, \hat{w}_{k,1}, \dots, \hat{w}_{k,i}, \dots, \hat{w}_{k,m-1})$, with $0 \leq k < K$ and $0 \leq i < m$. Finally, we separate the detected FFSP block \hat{w}_k into J bits as $\hat{b}_{1,k}, \hat{b}_{2,k}, \dots, \hat{b}_{j,k}, \dots, \hat{b}_{J,k}$ by using an inverse transform function $\mathbf{F}_{q2\mathbf{B}}$. According to (5), we know that the j-th user is assigned the EP $C_j = \alpha^{j-1} \cdot C_{\mathbf{B}}$. Thus, to recover the transmit bit information of the j-th user, the inverse transform function $\mathbf{F}_{q2\mathbf{B}}$ is given as

$$\hat{b}_{j,k} = \mathbf{F}_{q2B}(\hat{w}_k) = \hat{w}_{k,j-1},$$
(19)

where $\hat{w}_{k,j-1}$ is the (j-1)-th component of \hat{w}_k .

After recovering the transmit bit information, we can directly obtain the active users' information from the field-field. For instance, if $\hat{b}_{j,k} = 0$ for $0 \le k < K$, it can be inferred that the *j*-th user is not active. This phenomenon is appealing for the sourced massive RA, since it avoids the necessity of addressing the active user detection issue.

C. A Diagonal-form-based FFMA System

Recall the sparse form codeword matrix V given by (16), for the $1 \times K$ information array U of V, each entry U_k of U is an $m \times m$ matrix, and the m information bits $b_{1,k}, b_{2,k}, \ldots, b_{j,k}, \ldots, b_{m,k}$ are located on the main diagonal of U_k , and the other locations are all 0s, where $0 \le k < K$ and $1 \le j \le J \le m$.

Permuting the columns of the $1 \times K$ information array U of V and rearranging the bit sequences, we can obtain an $m \times m$ information array U_D , in which $\mathbf{b}_1, \mathbf{b}_2, \ldots, \mathbf{b}_j, \ldots, \mathbf{b}_m$ are lying on the main diagonal of U_D and the other entries are all 0s, given by

$$\mathbf{U}_{\mathrm{D}} = \begin{bmatrix} \mathbf{u}_{1,\mathrm{D}} \\ \mathbf{u}_{2,\mathrm{D}} \\ \vdots \\ \mathbf{u}_{m,\mathrm{D}} \end{bmatrix} = \begin{bmatrix} \mathbf{b}_1 & & \\ & \mathbf{b}_2 & \\ & & \ddots & \\ & & & \mathbf{b}_m \end{bmatrix}, \quad (20)$$

where $\mathbf{b}_1, \mathbf{b}_2, \ldots, \mathbf{b}_j, \ldots, \mathbf{b}_m$ are $1 \times K$ vectors, and the subscript "D" stands for "diagonal". Let $\mathbf{u}_{j,D}$ denote as a $1 \times mK$ information sequence of the *j*-th user, i.e., $\mathbf{u}_{j,D} = (\mathbf{0}, \ldots, \mathbf{0}, \mathbf{b}_j, \mathbf{0}, \ldots, \mathbf{0})$, in which the $1 \times K$ bit-sequence of the *j*-th user \mathbf{b}_j is located at the (j-1)-th entry of $\mathbf{u}_{j,D}$ and $\mathbf{0}$ is a $1 \times K$ zero vector. Note that, if J < m, the (m-J) rightmost entries of \mathbf{U}_D are all zeros, forming an $(m-J) \times (m-J)K$ zero matrix.

Then, we encode $\mathbf{u}_{j,D}$ by the generator matrix $\mathbf{G}_{gc,sym}$ in systemic form, and obtain the codeword $\mathbf{v}_{j,D}$ of $\mathbf{u}_{j,D}$, i.e., $\mathbf{v}_{j,D} = (\mathbf{u}_{j,D}, \mathbf{v}_{j,red,D})$, where $\mathbf{v}_{j,red,D}$ is the parity-check block of $\mathbf{v}_{j,D}$, which is a (N - mK)-tuple. The codewords of $\mathbf{v}_{1,D}, \mathbf{v}_{2,D}, \dots, \mathbf{v}_{J,D}$ together can form a *diagonal form* codeword matrix \mathbf{V}_D , given as follows:

$$\mathbf{V}_{\mathrm{D}} = \begin{bmatrix} \mathbf{v}_{1,\mathrm{D}} \\ \mathbf{v}_{2,\mathrm{D}} \\ \vdots \\ \mathbf{v}_{m,\mathrm{D}} \end{bmatrix} = \begin{bmatrix} \mathbf{b}_{1} & & | \mathbf{v}_{1,red,\mathrm{D}} \\ & \mathbf{b}_{2} & & | \mathbf{v}_{2,red,\mathrm{D}} \\ & & \ddots & | & \vdots \\ & & & \mathbf{b}_{m} & | \mathbf{v}_{m,red,\mathrm{D}} \end{bmatrix},$$
(21)

consisting of an $m \times m$ information array \mathbf{U}_{D} and an $m \times 1$ parity-check array \mathbf{E}_{D} , where $\mathbf{E}_{\mathrm{D}} = [\mathbf{v}_{1,red,\mathrm{D}}, \mathbf{v}_{2,red,\mathrm{D}}, \dots, \mathbf{v}_{m,red,\mathrm{D}}]^{\mathrm{T}}$.

From the codeword $\mathbf{v}_{j,D}$, it is found that the useful vectors (i.e., \mathbf{b}_j and $\mathbf{v}_{j,red,D}$) are only located at the (j - 1)-th entry of $\mathbf{u}_{j,D}$ and the parity-check entry $\mathbf{v}_{j,red,D}$, and the other entries are all zeros. Thus, for the diagonal-form-based codeword $\mathbf{v}_{j,D}$, we can directly modulate and transmit the shorten codeword, defined by $\mathbf{v}_{j,D,S} = [\mathbf{b}_j, \mathbf{v}_{j,red,D}]$, instead of $\mathbf{v}_{j,D}$, to reduce the transmit power. The subscript "S" indicates "shorten". The codeword length of $\mathbf{v}_{j,D,S}$ is equal to N - (m - 1)K. For a short packet transmission, e.g., K is an extremely small number, the length of $\mathbf{v}_{j,D,S}$ is approximately equal to the length of parity-check block $\mathbf{v}_{j,red,D}$.

The permuting and rearranging operations do not affect the properties of FFMA system. Hence, the diagonal-formbased FFMA system can be decoded like the aforementioned sparse-form-based FFMA system. For an FFMA system in diagonal form, the bit-sequences of J users are transmitted in orthogonal mode and the J parity-check sequences are appended to them. Obviously, the diagonal-form-based FFMA system is appealing for the massive users with short data packet transmission scenario, which can obtain a large coding gain from all the massive users with a low-complexity decoder.

V. SIMULATION RESULTS

In the following, we show the error performances of different systems over a GMAC, where the horizontal coordinateaxis is set to be signal-to-noise power ratio (SNR). Suppose the frame size (or DoF) is N = 6000, each user transmits K = 10 bits, and the numbers of total users are J = 1,100and 300, respectively.

We construct a binary (6000, 3000) LDPC code C_{gc} for the proposed FFMA systems, and decoding is carried out with 50 iterations of the MSA (min-sum algorithm). For the sparseform-based form FFMA system, we construct an orthogonal UD-EP code $\Psi_{o,B}$ over GF(2^J). After the cascading of EP encoder and channel encoder, each user will occupy the entire frame (or DoF). For the diagonal-form-based form FFMA system, the frame structure is the same as V_D given by (21), consisting of *J information blocks* and one *parity-check block*.

For the slotted ALOHA scheme, we assume that the number of time slots is equal to the number of total users, and repetition code is used for error control. Hence, the blocklength of each time slot is $\frac{N}{T}$, and each bit is repeated $\frac{N}{TK}$ times.

In fact, the structure of information blocks in the diagonalform-based FFMA is similarly to the frame structure of slotted

ALOHA. Thus, the numbers of active users of the slotted ALOHA and diagonal-form-based FFMA systems can be achieved by using the algorithm proposed in [7].

From Fig. 2, we see that the PUPE of the system goes down as the number of users increases. For the sparse-form-based FFMA systems, the PUPEs of the J = 100 and 300 cases are almost the same. When the PUPE is $P_b = 10^{-5}$, the gap between the PUPEs of J = 1 and 300 is only 1.5 dB, verifying the efficiency of the proposed FFMA system. Then, we investigate the PUPE between sparse-form-based and diagonal-formbased FFMA systems. Under the same simulation conditions, the diagonal-form-based FFMA provides better PUPE than that of the sparse-form-based FFMA, since the default bits are 0s which are available at the receiving end. However, with the increased number of users, the differences between the sparse-form-based and diagonal-form-based FFMA systems become smaller. When J = 300, both the sparse-form-based and diagonal-form-based FFMA systems have the same PUPE.

Finally, we compare our proposed FFMA systems with the slotted ALOHA system. When the number of users is small, e.g., J = 1, the slotted ALOHA with repetition code can provide much better PUER performance, since the coding gain is around $10 \log_{10}(\frac{N}{JK}) \approx 27.78$ dB. However, for a large number of users, e.g., $J \ge 100$, our proposed FFMA systems provide much better PUPE performance. When $P_b = 10^{-5}$ and J = 300, the FFMA systems can provide about 6 dB coding gain than the slotted ALOHA system, verifying the proposed FFMA system can improve the PUPE performance for a massive users scenario.

VI. CONCLUSIONS

In this paper, we proposed an FFMA technique to support sourced massive random access, for solving the FBL of multiuser reliability transmission problem. We presented a type of orthogonal UD-EP codes $\Psi_{o,B}$ constructed over GF(2^m), and introduced their encoding in conjunction with a channel error-control code. Based on the orthogonal UD-EP code $\Psi_{o,B}$, we presented both sparse-form-based and diagonal-form-based FFMA systems. Compared to the slotted ALOHA scheme, our proposed FFMA system can support massive users with wellbehaved PUPE performance.
