# Fibre homogenisation for time-dependent problems

#### Abstract

In this article we provide a method for establishing operator-type error estimates between solutions to rapidly oscillating evolutionary equations and their homogenised counter parts. This method is exemplified by applications to the wave, heat and finally thermoelastic evolutionary systems.


## 1 Introduction

This article is concerned with the quantitative homogenisation of evolutionary equations with rapidly oscillating periodic spatial coefficients

$$
\left(\partial_{t} M(\dot{\bar{\varepsilon}})+N(\dot{\bar{\varepsilon}})+A\right) U_{\varepsilon}=F,
$$

where $M$ and $N$ are bounded and positivity coefficient matrices, the small parameter $\varepsilon$ is the spatial period and $A$ is some first order differential operator. The usual, now classical, 'qualitative' homogenisation theory states that the solution $U_{\varepsilon}$ converges (in some function space), as $\varepsilon$ tends to zero, to $U_{0}$ the solution to a evolutionary equations with constant coefficients

$$
\left(\partial_{t} M_{0}+N_{0}+A\right) U_{\varepsilon}=F .
$$

where $M_{0}$ and $N_{0}$ are the appropriate homogenisation limits of $M(\dot{\bar{\varepsilon}})$ and $N(\dot{\bar{\varepsilon}})$. The qualitative homogenisation literature needs no introduction as it is now long standing, rich and ubiquitous. That said, for an example of qualititative homogenisation of evolutionary systems, see [7]. Recent developments, in homogenisation theory, have included establishing error estimates between solutions and their homogenised limits in various function spaces; with a priority focused on establishing so-called 'operator-type' estimates; that is, estimates
uniform with respect to the right-hand-side is certain natural norms. Such activity has come to be coined 'quantitative' homogenisation.
In [2], [10] the so-called spectral method was developed to establish quantitative homogenisation results for differential problems with rapidly oscillating periodic coefficients defined in the whole space. This method relies on utilising the Gelfand transform to replace the differential operator with a family of operators, i.e. to represent the operator as a fibre decomposition, and then performing an asymptotic analysis on each fibre operator that is uniform with respect to the fibre decomposition parameter. In [3], the spectral method was extended to the context of 'stationary' evolutionary problems that admitted a fibre decomposition via the Gelfand transform. Here, we developed the spectal method further to cover the case of time-dependent evolutionary problems. The key distinction is that the timedependent operators admit a two parameter fibre decomposition, a spatial decomposition (due to the Gelfand transform) and a temporal decomposition (due to the Laplace transform); we shall perform an asymptotic analysis of the decomposed operators that is uniform in the both the Gelfand and Laplace transform to arrive at operator-type homogenisation error estimates in temporally-weighted function spaces. We shall apply this method to the quintessential hyperbolic and parabolic systems, i.e. the wave and heat system respectively, then demonstrate the method on a thermo-elastic system of equations, which is an example of a coupled wave-heat system.

## Structure of the article

In Section 2, we study the wave equation

which is reformulated as the evolutionary wave system

for $U^{\varepsilon}(t, x)=\left(\partial_{\mathrm{t}} u_{\varepsilon}(t, x), a\left(\frac{x}{\varepsilon}\right) \nabla u_{\varepsilon}(t, x)\right)^{\top}$. By the spectral method, we establish the following estimate

$$

for some constant $C>0$ independent of $\varepsilon$ and $f$. Here, $U_{0}$ is the solution to the homogenised evolutionary wave system

$$

for $a_{0}$ the homogenised matrix associated to $a$. As $U^{0}=\left(\partial_{\mathrm{t}} u_{0}, a_{0} \nabla u_{0}\right)^{\top}$, for $u_{0}$ the solution to the homogenised wave equation

\partial_{t}^{2} u_{0}-\operatorname{div}\left(a_{0} \nabla u_{0}\right)=f, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d},
$$

these estimates can be rewritten as

&\left\|\partial_{\mathrm{t}} u_{\varepsilon}-\partial_{\mathrm{t}} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}, \\
&\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a_{0} \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}
\end{aligned}
$$

However, a closer look at our approach shows that we additionally establish a corrector estimate

\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a(\dot{\bar{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)},
$$

for some constant $C>0$ independent of $\varepsilon$ and $f$; here, $N_{0}$ is the classical homogenised corrector.
In Section 3, we study the heat equation

\partial_{t} u_{\varepsilon}-\operatorname{div}_{x}\left(b\left(\frac{x}{\varepsilon}\right) \nabla_{x} u_{\varepsilon}\right)=f, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d}
$$

which is reformulated as the evolutionary heat system

\end{array}\right)\right) U^{\varepsilon}=\binom{f}{0} \quad t \in \mathbb{R}, x \in \mathbb{R}^{d} .
$$

for $U^{\varepsilon}(t, x)=\left(u_{\varepsilon}(t, x), b\left(\frac{x}{\varepsilon}\right) \nabla u_{\varepsilon}(t, x)\right)^{\top}$. We establish the following estimate

\left(\left\|U_{1}^{\varepsilon}-U_{1}^{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}^{2}+\left\|U_{2}^{\varepsilon}-U_{2}^{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)}^{2}\right)^{1 / 2} \leq C \varepsilon\|f\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}

for $U_{0}$ the solution to the homogenised evolutionary wave system

for $b_{0}$ the homogenised matrix associated to $b$. Again, as $U^{0}=\left(u_{0}, b_{0} \nabla u_{0}\right)^{\top}$, these estimates can be rewrriten as

&\left\|b(\dot{\varepsilon}) \nabla u_{\varepsilon}-b_{0} \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\|f\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} d\right)\right)},
\end{aligned}

for $u_{0}$ the solution to the homogenised heat equation

\partial_{t} u_{0}-\operatorname{div}\left(b_{0} \nabla u_{0}\right)=f, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d}
$$

where $b_{0}$ is the homogenised matrix (associated to $a$ ). As in Section 2, we additionally have the corrector estimate

\left\|b(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-b(\dot{\dot{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\dot{\varepsilon}}) \cdot \nabla u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\|f\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} .
$$

Finally, in Section 4, we study a coupled wave-heat type equation; namely the thermo-eslastic system of equations

\partial_{t} v_{\varepsilon}-\operatorname{div}_{x}\left(b\left(\frac{x}{\varepsilon}\right) \nabla_{x} v_{\varepsilon}\right)-\bar{\gamma}\left(\frac{x}{\varepsilon}\right) \partial_{t} u_{\varepsilon}=g, & & t \in \mathbb{R}, x \in \mathbb{R}^{d}
\end{aligned}\right.

Here, we rewrite the thermo-elastic system as the following evolutionary system

\end{equation*}

where $U^{\varepsilon}=\left(\partial_{t} u_{\varepsilon}, a\left(\frac{x}{\varepsilon}\right) \nabla_{x} u_{\varepsilon}, v_{\varepsilon}, b\left(\frac{x}{\varepsilon}\right) \nabla_{x} v_{\varepsilon}\right)^{\top}, F=(f, 0, g, 0)^{\top}$,

Utilising the results of Section 2 and 3, we establish evolutionary system homogenisation estimates and corrector estimates, which we combine as follows:

& +\left\|a(\dot{\bar{q}}) \nabla u_{\varepsilon}-a(\dot{\bar{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \\
& +\left\|b(\dot{\bar{\varepsilon}}) \nabla v_{\varepsilon}-b(\dot{\bar{\varepsilon}}) \nabla\left(v_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla v_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)}+\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a_{0} \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \\
& +\left\|b(\dot{\bar{\varepsilon}}) \nabla v_{\varepsilon}-b_{0} \nabla v_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right),

for some constant $C>0$ independent of $\varepsilon$ and $f$, and $u_{0}, v_{0}$ solving the coupled homogenised thermo-elastic system

for $\langle h\rangle$ denoting the integral of a periodic function $h$ over its period.

## Notation

For a given Hilbert space $H$ with inner product $\langle\cdot, \cdot\rangle_{H}$ and norm $\|\cdot\|_{H}:=\langle\cdot, \cdot\rangle^{1 / 2}$, we denote: $L(H)$ to be the space of bounded linear operators in $H$,

L_{\nu}^{2}(\mathbb{R} ; H):=\left\{f \in L_{\mathrm{loc}}^{2}(\mathbb{R} ; H) ; \int_{\mathbb{R}}\|f(t)\|_{H}^{2} \exp (-2 \nu t) \mathrm{d} t<\infty\right\}, \quad \nu>0

and $H_{\nu}^{1}(\mathbb{R} ; H)$ is the space of $H$-valued, weakly differentiable $L_{2, \nu}(\mathbb{R} ; H)$-functions with distributional derivative representable as an $L_{\nu}^{2}(\mathbb{R} ; H)$-function. $L_{\nu}^{2}(\mathbb{R} ; H)$ and $H_{\nu}^{1}(\mathbb{R} ; H)$ are Hilbert spaces with the standard inner products. For a given function space $X$, the $X_{\text {per }}$ denotes the space of periodic functions that locally belong to $X$, for example: $W_{\mathrm{per}}^{1, p}(\square):=$ $\left\{f \in W_{\mathrm{loc}}^{1, p}\left(\mathbb{R}^{d}\right): f\right.$ is periodic with periodicity cell $\left.\square\right\}$.
Throughout $\lesssim$ denotes less than or equal to up to some constant that is independent of the underlying parameters.

## 2 Wave equation

Consider the heterogeneous wave equation with rapidly oscillating coefficients:

\partial_{t}^{2} u_{\varepsilon}-\operatorname{div}_{x}\left(a\left(\frac{x}{\varepsilon}\right) \nabla_{x} u_{\varepsilon}\right)=f, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d} \tag{2.1}
\end{equation*}
$$

where $\varepsilon>0$ is a fixed parameter (the small period), $a$ is a periodic function with periodicity cell $\square:=\left[-\frac{1}{2}, \frac{1}{2}\right)^{d}, f \in L_{\nu}^{2}\left(\mathbb{R} ; L_{2}\left(\mathbb{R}^{d}\right)\right)$ is given for some $\nu>0$ and $u_{\varepsilon}$ is the unknown; div and $\nabla$ are the usual divergence and gradient differential operators (with respect to the spatial variable).
We shall determine the leading-order asymptotics of $u^{\varepsilon}$ by using an appropriate modification, given in [3], of the so-called spectral method (c.f. [10, 2]) to 'evolutionary equations' of Picard, see [4] for the seminal research article and [6] for an (easily) accessible monograph on the subject matter.
We begin by following $[6, \mathrm{pp} 92]$ and noting that if $u_{\varepsilon}$ satisfies (2.1) then the vector $U^{\varepsilon}(t, x)=$ $\left(\partial_{\mathrm{t}} u_{\varepsilon}(t, x), a\left(\frac{x}{\varepsilon}\right) \nabla u_{\varepsilon}(t, x)\right)^{\top}$ solves the evolutionary wave system

\end{array}\right)\right) U^{\varepsilon}=\binom{f}{0} \in L_{\nu}^{2}\left(\mathbb{R} ; L_{2}\left(\mathbb{R}^{d}\right)^{1+d}\right) .
$$

Conversely, if $U^{\varepsilon}$ solves (2.2) then $u_{\varepsilon}:=\partial_{\mathrm{t}}^{-1} U_{1}^{\varepsilon} \in H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ solves the wave equation (2.1) in a distributional sense.

Considering solutions of (2.2), in the Bochner space $L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$, for $\nu>0$, with time $t$ being the Bochner variable, we apply Picard's theorem as in [6, Theorem 6.2.6] and obtain the following result.

Proposition 2.1. Let $\nu>0, f \in L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$. Assume $a \in L^{\infty}\left(\square ; L\left(\mathbb{C}^{d}\right)\right)$ with $a=a^{*}$ pointwise a.e. and that there exists $\kappa>0$ such that

Then there exists a unique solution $U^{\varepsilon} \in L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)^{1+d}$ of (2.2). If, in addition, $f \in$ $H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$, then

Remark 2.2. It is clear that (cf. [6, Proposition 6.2.3 (b)]), $a \in L^{\infty}\left(\square ; L\left(\mathbb{C}^{d}\right)\right)$ with

To apply the spectral method for determining the quantitative asymptotics of $U^{\varepsilon}$ we apply a series of invertible transformations. First, an application of the (bilateral) Laplace transform

To identify the $\varepsilon$-leading-order asymptotics for $U_{\lambda, \theta}^{\varepsilon}$, with error estimates that are uniform in $\theta, \lambda$ and $f$, we build upon the method of [3], in Section 2.1. For this, we introduce $N_{0}$, the so-called homogenised corrector, whose $j$-th component is the unique solution $N_{0}^{j} \in$ $H_{\mathrm{per}, 0}^{1}(\square):=\left\{p \in H_{\mathrm{per}}^{1}(\square) \mid\langle p, 1\rangle_{L^{2}(\square)}=0\right\}$ to

Indeed, by the unitary properties of $\mathcal{L}_{\nu}, \mathcal{G}$, the fact $\Gamma^{\varepsilon}$ is a change of variables, (2.4) and (2.11) implies

We emphasise that $\Gamma_{\varepsilon}$ and $\mathcal{G}$ are transformations with respect to the spatial variables, whereas $\mathcal{L}_{\nu}$ acts on the temporal variable and $\mathcal{L}_{\nu}^{-1}$ on the frequency variable $\lambda=\nu+k$, $k \in \mathbb{R}$. Let us determine

For this, we shall use the following known (and readily verifiable) relations between the Gelfand transform, $\mathcal{G}$, and Fourier transform F:

Indeed, the left-hand-side used (2.4), (2.6) with $\nabla_{y} c_{0}=0$ and (2.5); the right-hand-side used (2.13) and then (2.14).

Remark 2.4. Direct calculation shows $\mathcal{P}_{\varepsilon}=\mathrm{F}^{-1}\left(\Gamma_{\varepsilon} \chi\right) \mathrm{F}$; that is $\mathcal{P}_{\varepsilon}$ is a self-adjoint smoothing operator, given by truncating a function to the region $\varepsilon^{-1} \square^{*}=\left[\varepsilon^{-1} \pi, \varepsilon^{-1} \pi\right)^{d}$ in Fourier space, that also appears in error estimates in homogenisation theory in the work [2].
As (2.15) is a constant coefficient equation then

\leq C \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \tag{2.17}

It is desirable to remove the smoothing operator $\mathcal{P}_{\varepsilon}$ in the inequality (2.17) and arrive at estimates between $U^{\varepsilon}=\left(\partial_{\mathrm{t}} u_{\varepsilon}, a\left(\frac{x}{\varepsilon}\right) \nabla u_{\varepsilon}\right)^{\top}$ and $U^{0}=\left(\partial_{\mathrm{t}} u_{0}, a_{0} \nabla u_{0}\right)^{\top}$ the solution to the homogenised evolutionary wave equation

For this, we rely on the properties of $\mathcal{P}_{\varepsilon}$, the properties of the corrector $N_{0}$ and the following standard regularity results for $u_{0}$ :

Indeed, the following result, proved in Section 2.2, holds:

&\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a(\dot{\bar{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)},  \tag{2.21}\\
&\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a_{0} \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}, \tag{2.22}
\end{align*}

for some $C>0$ independent of $\varepsilon$ and $f$.
Notice that, since $\partial_{\mathrm{t}}$ is boundedly invertible in $L_{\nu}^{2}\left(\mathbb{R}^{d} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ for $\nu>0,(2.20)$ implies an error estimate for the homogenisation of the wave equation. In turn, the uniform positivity of $a(\dot{\varepsilon})$ along with (2.21) imply the so-called corrector estimate. The estimates (2.20) and (2.22) provide an error estimate for the homogenisation of the evolutionary wave system. That is, the following inequalities hold:

&\left(\left\|U_{1}^{\varepsilon}-U_{1}^{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}^{2}+\left\|U_{2}^{\varepsilon}-U_{2}^{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)}^{2}\right)^{1 / 2} \leq C \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} .

### 2.1 Proof of Theorem 2.3

The main step is to identify a reducing subspace $E_{\theta}$ of (the closed linear skew-self-adjoint operator in $\left.L^{2}\left(\square ; \mathbb{C} \times \mathbb{C}^{d}\right)\right) A_{\theta}:=\left(\begin{array}{cc}0 & -(\operatorname{div}+\mathrm{i} \theta \cdot) \\ -(\nabla+\mathrm{i} \theta) & 0\end{array}\right)$ that has the additional property that $A_{\theta}$ restricted to the complement of $E_{\theta}$ is uniformly invertible. In this example, it is easy to determine such an $E_{\theta}$. Indeed, one readily has the orthogonal decompositions:

L^{2}(\square)=\mathbb{C} \oplus\left\{f \in L^{2}(\square) \mid\langle f, 1\rangle_{L^{2}(\square)}=0\right\} \quad \text { and } \quad L^{2}\left(\square ; \mathbb{C}^{d}\right)=L_{\mathrm{pot}, \theta}^{2}(\square) \oplus L_{\mathrm{sol}, \theta}^{2}(\square) \tag{2.23}
\end{equation*}
$$

where

$$
L_{\mathrm{pot}, \theta}^{2}(\square):= \begin{cases}\left\{(\nabla+\mathrm{i} \theta) p \mid p \in H_{\mathrm{per}}^{1}(\square)\right\} & \theta \neq 0 \\ \left\{c+\nabla p \mid c \in \mathbb{C}^{d} \text { and } p \in H_{\mathrm{per}}^{1}(\square),\langle p, 1\rangle_{L^{2}(\square)}=0\right\} & \theta=0\end{cases}
$$

and

$$
L_{\mathrm{sol}, \theta}^{2}(\square):= \begin{cases}\left\{s \in L^{2}\left(\square ; \mathbb{C}^{d}\right) \mid \operatorname{div} s+\mathrm{i} \theta \cdot s=0 \text { in }\left(H_{\mathrm{per}}^{1}(\square)\right)^{*}\right\} & \theta \neq 0, \\ \left\{s \in L^{2}\left(\square ; \mathbb{C}^{d}\right) \mid \operatorname{div} s=0 \text { in }\left(H_{\mathrm{per}}^{1}(\square)\right)^{*} \text { and }\langle s, 1\rangle_{L^{2}(\square)}=0\right\} & \theta=0 .\end{cases}
$$

Furthermore, it is clear from $(2.23)_{1}$ that

$$
\begin{equation*}
L_{\mathrm{pot}, \theta}^{2}(\square) \subseteq\left\{\xi+(\nabla+\mathrm{i} \theta) p \mid \xi \in \mathbb{C}^{d}, p \in H_{\mathrm{per}, 0}^{1}(\square)\right\} \tag{2.24}
\end{equation*}
$$

where

$$
H_{\mathrm{per}, 0}^{1}(\square):=\left\{p \in H_{\mathrm{per}}^{1}(\square) \mid\langle p, 1\rangle_{L^{2}(\square)}=0\right\} .
$$

This identification along with another application of (2.23) gives the following orthogonal decomposition:

\begin{equation*}
L^{2}\left(\square ; \mathbb{C} \times \mathbb{C}^{d}\right)=E_{\theta} \oplus E_{\theta}^{\perp}, \quad \theta \in \square^{*} \tag{2.25}
\end{equation*}
$$

where

$$
\begin{align*}
& E_{\theta}:=\left\{c+(0, s)^{\top} \mid c \in \mathbb{C} \times \mathbb{C}^{d}, s \in L_{\mathrm{sol}, \theta}^{2}(\square)\right\}  \tag{2.26}\\
& E_{\theta}^{\perp}:=\left\{\left(p_{1},(\nabla+\mathrm{i} \theta) p_{2}\right)^{\top} \mid p_{1} \in L^{2}(\square), p_{2} \in H_{\mathrm{per}}^{1}(\square),\left\langle p_{i}, 1\right\rangle_{L^{2}(\square)}=0, i \in\{1,2\}\right\}
\end{align*}
$$

Remark 2.7. Notice that for $P_{\theta}: L^{2}\left(\square ; \mathbb{C} \times \mathbb{C}^{d}\right) \rightarrow E_{\theta}$ the orthogonal projection, one has $P_{\theta}\left(u_{1}, u_{2}\right)^{\top}=\left(P_{1} u_{1}, P_{2} u_{2}\right)^{\top}$ where $P_{1}: L^{2}(\square) \rightarrow \mathbb{C}$ and $P_{2}: L^{2}\left(\square ; \mathbb{C}^{d}\right) \rightarrow \mathbb{C}^{d} \oplus L_{\mathrm{sol}, \theta}^{2}(\square)$ are the orthogonal projections. Observe that $P_{1}$ is independent of $\theta$.

The following result was proved in [3, Section 3]:
Proposition 2.8. The closed subspace $E_{\theta}$ reduces $A_{\theta}$; namely,

P_{\theta} A_{\theta} \subseteq A_{\theta} P_{\theta}
$$

Moreover, $A_{\theta} P_{\theta}^{\perp}$ is uniformly invertible; i.e.,

\sup _{\theta \in \square^{*}}\left\|\left(A_{\theta} P_{\theta}^{\perp}\right)^{-1}\right\|_{L\left(E_{\theta}^{\perp}\right)}<\infty \tag{2.27}
\end{equation*}
$$

Equipped with the above diagonalisation of $A_{\theta}$ we can readily provide our first approximation for $U_{\lambda, \theta}^{\ell}$.
Proposition 2.9. Consider $U_{\lambda, \theta}^{\varepsilon}$ the solution to (2.8) and $V_{\lambda, \theta}^{\varepsilon} \in E_{\theta}$ the solution to

0 & a^{-1}
\end{array}\right)+\varepsilon^{-1}\left(\begin{array}{cc}
0 & -(\operatorname{div}+\mathrm{i} \theta \cdot) \\
-(\nabla+\mathrm{i} \theta) & 0
\end{array}\right)\right) V_{\lambda, \theta}^{\varepsilon}=P_{\theta}\binom{F}{0} .
$$

Then, the following estimate holds: there exists $C>0$ independent of $\varepsilon, \lambda, \theta$ and $F$ such that

\begin{equation*}
\left\|U_{\lambda, \theta}^{\varepsilon}-V_{\lambda, \theta}^{\varepsilon}\right\|_{L^{2}\left(\square ; \mathbb{C}^{d+1}\right)} \leq C \varepsilon|\lambda|^{2}\|F\|_{L^{2}(\square)} . \tag{2.29}
\end{equation*}
$$

Proof. Let us drop super and subscripts and $\|\cdot\|$ shall denote the appropriate $L^{2}$ norm. Since $A_{\theta}$ and $P_{\theta}$ commute (cf. Proposition 2.8), then it is known (see for example [1, Chapter 3, Section 6]) that $A_{\theta}=A_{\theta}^{(1)}+A_{\theta}^{(2)}$, for the linear operators $A_{\theta}^{(1)}:=A_{\theta} P_{\theta}$ and $A_{\theta}^{(2)}:=A_{\theta} P_{\theta}^{\perp}$. Consequently, it follows from (2.8) that

\left(\lambda P_{\theta}^{\perp} M+\varepsilon^{-1} A_{\theta}^{(2)}\right) U^{(2)}=P_{\theta}^{\perp}(F, 0)^{\top}-P_{\theta}^{\perp} \lambda M U^{(1)} \tag{2.31}
\end{gather*}
$$

where $M=\operatorname{diag}\left(1, a^{-1}\right)$ and $U=U^{(1)}+U^{(2)}$ is decomposed according to $I=P_{\theta}+P_{\theta}^{\perp}$. Now, from (2.28) and (2.30) (see Remark 2.7) we find

\left(\lambda P_{\theta} M+\varepsilon^{-1} A_{\theta}^{(1)}\right)\left(U^{(1)}-V\right)=-P_{\theta} \lambda M U^{(2)}=P_{\theta}\left(0,-\lambda a^{-1} U_{2}^{(2)}\right)^{\top} .

By noting that $U^{(1)}-V \in E_{\theta}$ and $A_{\theta}^{(1)}$ is skew-adjoint, one arrives at

& \left.\operatorname{Re}\left\langle\lambda M\left(U^{(1)}-V\right), U^{(1)}-V\right)\right\rangle \\
& =\operatorname{Re}\left(\left\langle\lambda P_{\theta} M\left(U^{(1)}-V\right), U^{(1)}-V\right\rangle+\varepsilon^{-1}\left\langle A_{\theta}^{(1)}\left(U^{(1)}-V\right), U^{(1)}-V\right\rangle\right) \\
& =\operatorname{Re}\left\langle P_{\theta}\left(0,-\lambda a^{-1} U_{2}^{(2)}\right)^{\top}, U^{(1)}-V\right\rangle \\
& =\operatorname{Re}\left\langle\left(0,-\lambda a^{-1} U_{2}^{(2)}\right)^{\top}, U^{(1)}-V\right\rangle
\end{aligned}
$$

which along with the positivity of the real part of $M=\operatorname{diag}\left(1, a^{-1}\right)$ and the boundedness of $a^{-1}$ (see (2.3)) implies

$$
\left\|U^{(1)}-V\right\| \lesssim\left\|P_{\theta}\left(0,-\lambda a^{-1} U_{2}^{(2)}\right)^{\top}\right\| \lesssim|\lambda|\left\|U_{2}^{(2)}\right\| .
$$

To prove (2.29) it remains to show

$$
\begin{equation*}
\left\|U^{(2)}\right\| \lesssim \varepsilon|\lambda|\|F\| . \tag{2.32}
\end{equation*}
$$

From (2.31) one has $U^{(2)}=\varepsilon\left(A_{\theta}^{(2)}\right)^{-1}\left(P_{\theta}^{\perp}(F, 0)^{\top}-P_{\theta}^{\perp} \lambda M U\right)$ which along with (2.27) and the bound $\|U\| \lesssim\|F\|$ (which readily follows from considering the real part of (2.8), also cf. (2.3)) implies (2.32). The proof is complete.

The next step in determining the leading-order asymptotics for $U_{\lambda, \theta}^{\varepsilon}$ is to simplify the $\theta$ dependence of $V_{\lambda, \theta}^{\varepsilon}$ further. For this, we shall utilise the following alternative representation.

Proposition 2.10. The solution $V_{\lambda, \theta}^{\varepsilon}$ to (2.28) has the form

V_{\lambda, \theta}^{\varepsilon}=c\binom{\lambda}{a\left(I+\nabla N_{\theta}+\mathrm{i} \theta \otimes N_{\theta}\right) \frac{\mathrm{i} \theta}{\varepsilon}}, \quad c=\left(\lambda^{2}+a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right)^{-1}\langle F, 1\rangle_{L^{2}(\square)}, \tag{2.33}
\end{equation*}
$$

where $a_{\theta}$ is the constant coefficient $d \times d$-matrix given by

$$
\begin{equation*}
\left(a_{\theta}\right)_{p q}:=\left\langle a\left(I+\nabla N_{\theta}+\mathrm{i} \theta \otimes N_{\theta}\right) e_{p}, e_{q}\right\rangle_{L^{2}(\square)}, \quad p, q \in\{1,2, \ldots, d\} \tag{2.34}
\end{equation*}
$$

for $e_{j}$ the $j$-th Euclidean basis vector and $N_{\theta}$ the vector whose $j$-th component is the solution $N_{\theta}^{j} \in H_{\mathrm{per}, 0}^{1}(\square)$ to

$$
\begin{equation*}
\left\langle a(\nabla+\mathrm{i} \theta) N_{\theta}^{j},(\nabla+\mathrm{i} \theta) \phi\right\rangle_{L^{2}(\square)}=-\left\langle a e_{j},(\nabla+\mathrm{i} \theta) \phi\right\rangle_{L^{2}(\square)}, \quad\left(\phi \in H_{\mathrm{per}, 0}^{1}(\square)\right) . \tag{2.35}
\end{equation*}
$$

Remark 2.11. Notice that $N_{0}$ and $a_{0}$ are respectively the classical corrector and homogenised matrix for $a$.

Proof of Proposition 2.10. From the definition of $E_{\theta}$, see (2.26), one has

V_{\lambda, \theta}^{\varepsilon}=\binom{c_{1}}{c_{2}+s}
$$

for some $c_{1} \in \mathbb{C}, c_{2} \in \mathbb{C}^{d}$ and $s \in L_{\text {sol }, \theta}^{2}(\square)$. Moreover, (2.28) (cf. Remark 2.7) states $c_{1}, c_{2}$ and $s$ solve the system

\begin{gather*}
\lambda c_{1}-\varepsilon^{-1} \mathrm{i} \theta \cdot c_{2}=\langle F, 1\rangle_{L^{2}(\square)},  \tag{2.36}\\
\lambda\left\langle a^{-1}\left(c_{2}+s\right), \tilde{c}\right\rangle_{L^{2}\left(\square ; \mathbb{C}^{d}\right)}-\mathrm{i} \frac{\theta}{\varepsilon}\left\langle c_{1}, \tilde{c}\right\rangle_{L^{2}\left(\square ; \mathbb{C}^{d}\right)}=0, \quad\left(\tilde{c} \in \mathbb{C}^{d}\right)  \tag{2.37}\\
\left\langle a^{-1}\left(c_{2}+s\right), \tilde{s}\right\rangle_{L^{2}(\square)}=0, \quad\left(\tilde{s} \in L_{\mathrm{sol}, \theta}^{2},\right. \tag{2.38}
\end{gather*}
$$

where the third equation used the fact that $\left\langle\mathrm{i} \theta c_{1}, \tilde{s}\right\rangle_{L^{2}(\square)}=0$ (since $\operatorname{div} \tilde{s}+\mathrm{i} \theta \cdot \tilde{s}=0$ in $\left.\left(H_{\text {per }}^{1}(\square)\right)^{*}\right)$. From (2.38), (2.23) $)_{2}$ and (2.24), it follows that

\begin{equation*}
a^{-1}\left(c_{2}+s\right)=\xi+(\nabla+\mathrm{i} \theta) p_{2} \tag{2.39}
\end{equation*}
$$

for some $\xi \in \mathbb{C}^{d}, p_{2} \in H_{\text {per }, 0}^{1}(\square)$. Now, from (2.39), one has

$$
\langle\xi, \tilde{c}\rangle_{L^{2}\left(\square ; \mathbb{C}^{d}\right)}=\left\langle a^{-1}\left(c_{2}+s\right), \tilde{c}\right\rangle_{L^{2}\left(\square ; \mathbb{C}^{d}\right)}, \quad\left(\tilde{c} \in \mathbb{C}^{d}\right),
$$

which, along with (2.37), gives $\xi=\mathrm{i} \frac{\theta}{\varepsilon \lambda} c_{1}$. Furthermore, from (2.39), one has

$$
\left.\left\langle a \xi+a(\nabla+\mathrm{i} \theta) p_{2}\right),(\nabla+\mathrm{i} \theta) \phi_{0}\right\rangle_{L^{2}\left(\square ; \mathbb{C}^{d}\right)}=0, \quad\left(\phi_{0} \in H_{\mathrm{per}, 0}^{1}(\square)\right),
$$

that is $p_{2}=N_{\theta} \cdot \xi$ (cf. (2.35)). Thus, the above considerations show that

$$
V_{\lambda, \theta}^{\varepsilon}=\binom{c_{1}}{c_{2}+s}=\binom{c_{1}}{\xi+(\nabla+\mathrm{i} \theta) p_{2}}=\frac{c_{1}}{\lambda}\binom{\lambda}{\mathrm{i} \frac{\theta}{\varepsilon}+(\nabla+\mathrm{i} \theta) N_{\theta} \cdot \mathrm{i} \frac{\theta}{\varepsilon}}
$$

It remains to show that $c=c_{1} / \lambda$ satisfies

$$
\begin{equation*}
\left(\lambda^{2}+a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right) c=\langle F, 1\rangle_{L^{2}(\square)} . \tag{2.40}
\end{equation*}
$$

To that end, note that (2.39) implies

\left.\left\langle a \xi+a(\nabla+\mathrm{i} \theta) p_{2}\right), \mathrm{i} \theta \tilde{c}\right\rangle_{L^{2}\left(\square ; \mathbb{C}^{d}\right)}=\left\langle c_{2}, \mathrm{i} \theta \tilde{c}\right\rangle_{L^{2}\left(\square ; \mathbb{C}^{d}\right)}, \quad\left(\tilde{c} \in \mathbb{C}^{d}\right)
$$

This equation and (2.34) imply that

c_{2} \cdot \mathrm{i} \theta=a_{\theta} \xi \cdot \mathrm{i} \theta
$$

which, in turn, along with (2.36), and the identity $\xi=\mathrm{i} \frac{\theta}{\varepsilon \lambda} c_{1}$, gives (2.40).
The dependence of $V_{\lambda, \theta}^{\varepsilon}$ on $\theta$ can be further simplified, for small $\varepsilon$, by utilising the following properties of $a_{\theta}$ and $N_{\theta}$ (established in [3, Section 4]):

Proposition 2.12. Assume a satisfies (2.3). Then, there exists $K>0$ such that

K|\xi|^{2} \leq a_{\theta} \xi \cdot \bar{\xi} \leq K^{-1}|\xi|^{2}, \quad\left(\xi \in \mathbb{R}^{d}, \theta \in \square^{*}\right)
$$

Furthermore, there exists $C>0$ such that

\left\|N_{\theta} \xi\right\| \leq C|\xi|, \quad\left\|N_{\theta} \cdot \xi-N_{0} \cdot \xi\right\|_{H^{1}(\square)} \leq C|\theta \| \xi|, \quad\left(\xi \in \mathbb{C}^{d}, \theta \in \square^{*}\right)
$$

and

$$
\left|a_{\theta} \xi \cdot \bar{\eta}-a_{0} \xi \cdot \bar{\eta}\right| \leq C|\theta||\xi||\eta|, \quad\left(\xi, \eta \in \mathbb{C}^{d}, \theta \in \square^{*}\right)
$$

Now, we are ready for the final step.

Proposition 2.13. For fixed $\varepsilon, \theta, \lambda$ and $F$, consider the solution $V_{\lambda, \theta}^{\varepsilon}$ to (2.28) and

\begin{equation*}
W_{\lambda, \xi}=c_{0}\binom{\lambda}{a\left(I+\nabla N_{0}\right) \mathrm{i} \xi}, \quad c_{0}=\left(\lambda^{2}+a_{0} \xi \cdot \xi\right)^{-1}\langle F, 1\rangle_{L^{2}(\square)}, \quad \xi \in \mathbb{R}^{d} . \tag{2.41}
\end{equation*}
$$

Then, there is $C>0$ independent of $\varepsilon, \lambda, \theta$ and $F$ such that

$$
\begin{equation*}
\left\|V_{\lambda, \theta}^{\varepsilon}-W_{\lambda, \theta / \varepsilon}\right\|_{L^{2}\left(\square ; \mathbb{C}^{d+1}\right)} \leq C \varepsilon|\lambda|^{2}\|F\|_{L^{2}(\square)} . \tag{2.42}
\end{equation*}
$$

Proof. By (2.33) and (2.41) one has

\left(V_{\lambda, \theta}^{\varepsilon}\right)_{1}-\left(W_{\lambda, \theta / \varepsilon}\right)_{1}=\lambda\left(c-c_{0}\right),
$$

and

\left(V_{\lambda, \theta}^{\varepsilon}\right)_{2}-\left(W_{\lambda, \theta / \varepsilon}\right)_{2}=a \mathrm{i} \frac{\theta}{\varepsilon}\left(c-c_{0}\right)+a \nabla N_{0} i \frac{\theta}{\varepsilon}\left(c-c_{0}\right)+\left(a \nabla N_{\theta} \mathrm{i} \frac{\theta}{\varepsilon} c-a \nabla N_{0} \frac{\mathrm{i} \theta}{\varepsilon} c\right)+\mathrm{i} \theta \otimes N_{\theta} \frac{\mathrm{i} \theta}{\varepsilon} c .
$$

The above identities and Proposition 2.12 imply that
tilhere $\left\|\left(V_{\lambda, \theta}^{\varepsilon}\right)_{1}-\left(W_{\lambda, \theta / \varepsilon}\right)_{1}\right\|_{L^{2}(\square)} \leq|\lambda|\left|c-c_{0}\right|, \quad$ and $\quad\left\|\left(V_{\lambda, \theta}^{\varepsilon}\right)_{2}-\left(W_{\lambda, \theta / \varepsilon}\right)_{2}\right\|_{L^{2}\left(\square ; \mathbb{C}^{d}\right)} \lesssim \frac{|\theta|}{\varepsilon}\left|c-c_{0}\right|+\frac{|\theta|^{2}}{\varepsilon}|c|$.
By the definitions of $c$, (2.33), and $c_{0}$, (2.41), and Proposition 2.12 we compute

\begin{gathered}
\frac{|\theta|^{2}}{\varepsilon}|c| \lesssim \varepsilon \frac{a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}}{\left|\lambda^{2}+a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|}\|F\|_{L^{2}(\square)}=\varepsilon d\left(a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right)\|F\|_{L^{2}(\square)}, \\
\left|c-c_{0}\right|=\frac{\left|a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}-a_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|}{\left|\lambda^{2}+a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|\left|\lambda^{2}+a_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|}\left|\langle F, 1\rangle_{L^{2}(\square)}\right| \lesssim \frac{\frac{\mid \theta 3^{3}}{\varepsilon^{2}}}{\left|\lambda^{2}+a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|\left|\lambda^{2}+a_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|}\|F\|_{L^{2}(\square)} \\
\lesssim \varepsilon d\left(a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right) e\left(\sqrt{a_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}}\right)\|F\|_{L^{2}(\square)},
\end{gathered}
$$

and, similarly,

\frac{|\theta|}{\varepsilon}\left|c-c_{0}\right| \lesssim \varepsilon d\left(a_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right) d\left(a_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right)\|F\|_{L^{2}(\square)},
$$

where $d(t):=\frac{t}{\left|\lambda^{2}+t\right|}$, and $e(t):=\frac{t}{\left|\lambda^{2}+t^{2}\right|}$, for $t \in[0, \infty)$. Direct calculation shows that if $\operatorname{Re}\left(\lambda^{2}\right)>0$ then for $t \in[0, \infty)$, we obtain

and, if $\operatorname{Re}\left(\lambda^{2}\right)<0$ then $d$ has a positive maximum at $t^{*}=\frac{-\left|\lambda^{2}\right|^{2}}{\operatorname{Re}\left(\lambda^{2}\right)}$ and, so for all $t \in[0, \infty)$, $d(t) \leq d\left(t^{*}\right)=\frac{|\lambda|^{2}}{\left|\operatorname{Im} \lambda^{2}\right|} \lesssim|\lambda|$. Similarly, one can show that

$$
e(t) \leq e(|\lambda|)=\frac{1}{2 \nu} \quad(t \in[0, \infty))
$$

The above results put together yield $\left\|\left(V_{\lambda, \theta}^{\varepsilon}\right)_{1}-\left(W_{\lambda, \theta / \varepsilon}\right)_{1}\right\|_{L^{2}(\square)} \leq \varepsilon|\lambda|^{2}\|F\|_{L^{2}(\square)}$, and $\left\|\left(V_{\lambda, \theta}^{\varepsilon}\right)_{2}-\left(W_{\lambda, \theta / \varepsilon}\right)_{2}\right\|_{L^{2}\left(\square ; \mathbb{C}^{d}\right)} \lesssim \varepsilon|\lambda|^{2}\|F\|_{L^{2}(\square)}$.

Now, the proof of Theorem 2.3 follows from the triangle inequality and Propositions 2.9 and 2.13.

### 2.2 Proof of Theorem 2.5

Proof of (2.20). For this, we simply use the following elementary estimate for $\mathcal{P}_{\varepsilon}$ : there exists $C \geq 0$ such that

for all $h \in H^{1}\left(\mathbb{R}^{d}\right)$ and all $\varepsilon>0$.
Now, the identity $\partial_{\mathrm{t}} \mathcal{P}_{\varepsilon} u_{0}=\mathcal{P}_{\varepsilon} \partial_{\mathrm{t}} u_{0}$, the above estimate and (2.19) gives

$$
\left\|\partial_{\mathrm{t}} \mathcal{P}_{\varepsilon} u_{0}-\partial_{\mathrm{t}} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left\|\nabla_{x} \partial_{\mathrm{t}} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}
$$

which, along with (2.17), implies (2.20).
Proof of (2.21). First note that

$$
\varepsilon \nabla\left(N_{0}(\dot{\dot{\varepsilon}}) \cdot \nabla \mathcal{P}_{\varepsilon} u_{0}\right)=\nabla N_{0}(\dot{\bar{\varepsilon}}) \nabla \mathcal{P}_{\varepsilon} u_{0}+\varepsilon N_{0}(\dot{\dot{\varepsilon}}) \nabla^{2} \mathcal{P}_{\varepsilon} u_{0} .
$$

Thus,

$$
a\left(\frac{x}{\varepsilon}\right)\left(I+\nabla N_{0}\left(\frac{x}{\varepsilon}\right)\right) \nabla \mathcal{P}_{\varepsilon} u_{0}=a\left(\frac{x}{\varepsilon}\right) \nabla\left(\mathcal{P}_{\varepsilon} u_{0}+\varepsilon N_{0}(\dot{\dot{\varepsilon}}) \cdot \nabla \mathcal{P}_{\varepsilon} u_{0}\right)-a\left(\frac{x}{\varepsilon}\right) \varepsilon N_{0}(\dot{\dot{\varepsilon}}) \nabla^{2} \mathcal{P}_{\varepsilon} u_{0},
$$

which, along with the boundedness of $a$ and $N_{0}$ (due to the De Giorgi-Nash elliptic regularity theorem) gives
$\left\|a\left(\frac{x}{\varepsilon}\right)\left(I+\nabla N_{0}\left(\frac{x}{\varepsilon}\right)\right) \nabla \mathcal{P}_{\varepsilon} u_{0}-a(\dot{\bar{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla \mathcal{P}_{\varepsilon} u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left\|\nabla^{2} \mathcal{P}_{\varepsilon} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)}$.
Furthermore more, by the properties of the Fourier transform

$$
\left\|\nabla^{2} \mathcal{P}_{\varepsilon} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}=\left\|\mathcal{P}_{\varepsilon} \nabla^{2} u_{0}\right\| \leq\left\|\nabla^{2} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}
$$

These above observations, along with (2.17) and (2.19), imply

$$
\left\|a(\dot{\dot{\varepsilon}}) \nabla u_{\varepsilon}-a(\dot{\bar{\varepsilon}}) \nabla\left(\mathcal{P}_{\varepsilon} u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla \mathcal{P}_{\varepsilon} u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} .
$$

Arguing in the same manner as above, we can readily replace $\nabla \mathcal{P}_{\varepsilon} u_{0}$ with $\nabla u_{0}$ in the above inequality (cf. (2.43) and (2.19)) to get

$$
\begin{equation*}
\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a(\dot{\bar{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla \mathcal{P}_{\varepsilon} u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \tag{2.44}
\end{equation*}
$$

In the same manner, changing $\varepsilon \nabla^{2} \mathcal{P}_{\varepsilon} u_{0}$ by $\varepsilon \nabla^{2} u_{0}$ creates a controlled error of order $\epsilon$. However, to replace $\nabla N_{0}(\dot{\bar{\varepsilon}}) \nabla \mathcal{P}_{\varepsilon} u_{0}$ with $\nabla N_{0}(\dot{\bar{\varepsilon}}) \nabla u_{0}$ is more challenging and relies on the fact that the corrector $N_{0}$ is a multiplier in $H^{1}$ (first shown in [8, Proposition 8.2]):

Lemma 2.14 (Lemma 1.2 of [11]). There is $C \geq 0$ such that, for each $j \in\{1, \ldots, d\}$,

\begin{equation*}
\int_{\mathbb{R}^{d}}\left|\nabla N_{0}^{j}\left(\frac{x}{\varepsilon}\right) \phi(x)\right|^{2} \mathrm{~d} x \leq C \int_{\mathbb{R}^{d}}\left(|\phi(x)|^{2}+\varepsilon^{2}|\nabla \phi(x)|^{2}\right) \mathrm{d} x, \quad\left(\phi \in H^{1}\left(\mathbb{R}^{d}\right)\right) \tag{2.45}
\end{equation*}
$$

Thus,

$$
\left\|\nabla N_{0}(\dot{\bar{\varepsilon}}) \nabla \mathcal{P}_{\varepsilon} u_{0}-\nabla N_{0}(\dot{\bar{\varepsilon}}) \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left\|u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{2}\left(\mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}
$$

Hence, (2.44) yields

$$
\begin{equation*}
\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a(\dot{\dot{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\dot{\varepsilon}}) \cdot \nabla u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \tag{2.46}
\end{equation*}
$$

i.e. (2.21) holds.

Proof of (2.22). For this we utilise the following result.
Proposition 2.15. Let $\varepsilon>0, \gamma \in L_{\mathrm{per}}^{2}(\square), \phi \in L^{2}\left(\mathbb{R}^{d}\right)$ and assume $\gamma(\dot{\bar{\varepsilon}}) \mathcal{P}_{\varepsilon} \phi \in L^{2}\left(\mathbb{R}^{d}\right)$. Then

$$
\mathcal{P}_{\varepsilon}\left(\gamma(\dot{\bar{\varepsilon}}) \mathcal{P}_{\varepsilon} \phi\right)=\langle\gamma\rangle \mathcal{P}_{\varepsilon} \phi
$$

where $\langle\phi\rangle=\int_{\square} \phi(y) \mathrm{d} y$. In particular, if, in addition, supp $\mathrm{F} \phi \subseteq \varepsilon^{-1} \square^{*}$, then

$$
\mathcal{P}_{\varepsilon}(\gamma(\dot{\bar{\varepsilon}}) \phi)=\langle\gamma\rangle \phi
$$

Proof. By the Fourier series representation for $L_{\text {per }}^{2}(\square)$ functions, $\gamma=\langle\gamma\rangle+\sum_{n \neq 0} \gamma_{n} e^{\mathrm{i} 2 \pi n \cdot y}$ for some constants $\gamma_{n}$. Now, since $\mathcal{P}_{\varepsilon} \phi=: \psi \in L^{2}\left(\mathbb{R}^{d}\right)$ and $\gamma(\dot{\bar{\varepsilon}}) \psi \in L^{2}\left(\mathbb{R}^{d}\right)$ then $\Psi \sum_{n \neq 0} \gamma_{n} e^{\mathrm{i} 2 \pi n \cdot \frac{x}{\varepsilon}} \in$ $L^{2}\left(\mathbb{R}^{d}\right)$ and, consequently,

$$
\mathcal{F}(\gamma(\dot{\bar{\varepsilon}}) \psi))=\langle\gamma\rangle \mathcal{F} \psi+\mathcal{F}\left(\psi \sum_{n \neq 0} \gamma_{n} e^{\mathrm{i} 2 \pi n \cdot \frac{\dot{\bar{\varepsilon}}}{}}\right)
$$

Furthermore, by the properties of the Fourier transform

$$
\mathcal{F}\left(\psi \sum_{n \neq 0} \gamma_{n} e^{\mathrm{i} 2 \pi n \cdot \dot{\bar{\varepsilon}}}\right)=\sum_{n \neq 0} \gamma_{n} \mathcal{F}\left(\psi e^{\mathrm{i} 2 \pi n \cdot \cdot \dot{\bar{\varepsilon}}}\right)=\sum_{n \neq 0} \gamma_{n} \mathcal{F}(\psi)(\cdot-2 \pi n / \varepsilon) .
$$

Now, since $\mathcal{F} \psi$ has support in $\varepsilon^{-1} \square^{*}$ then $(\mathcal{F} \phi)(\cdot-2 \pi n / \varepsilon) \equiv 0$ in $\varepsilon^{-1} \square^{*}$, for all $n \neq 0$, and one has

$$
\chi(\varepsilon \cdot) \mathcal{F}\left(\psi \sum_{n \neq 0} \gamma_{n} e^{\mathrm{i} 2 \pi n \cdot \stackrel{\dot{\varepsilon}}{\varepsilon}}\right) \equiv 0
$$

where we recall that $\chi$ is the characteristic function of $\square^{*}$. Additionally,

$$
\chi(\varepsilon \cdot) \mathcal{F} \psi=\mathcal{F} \psi
$$

Hence,

$$
\chi(\varepsilon \cdot) \mathcal{F}(\gamma(\dot{\bar{\varepsilon}}) \psi))=\langle\gamma\rangle \mathcal{F} \psi=\mathcal{F}(\langle\gamma\rangle \psi),
$$

and (recalling that $\mathcal{P}_{\varepsilon}=\mathcal{F}^{-1} \chi(\varepsilon \cdot) \mathcal{F}$ ) taking the inverse Fourier transform completes the proof.

For each $j \in\{1, \ldots, d\}$, the function $\gamma=a\left(e_{j}+\nabla N_{0}^{j}\right)$ gives $\langle\gamma\rangle=a_{0} e_{j}$ and consequently, by Proposition 2.15 with $\phi=\partial_{x_{j}} u_{0}$, gives

\mathcal{P}_{\varepsilon}\left(a(\dot{\bar{\varepsilon}})\left(I+\nabla N_{0}(\dot{\dot{\varepsilon}})\right) \nabla \mathcal{P}_{\varepsilon} u_{0}\right)=a_{0} \nabla \mathcal{P}_{\varepsilon} u_{0} .
$$

Furthermore, (2.43) and (2.19) imply

$$
\left\|a_{0} \nabla u_{0}-a_{0} \nabla \mathcal{P}_{\varepsilon} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\left(\mathbb{R}^{d}\right) ; \mathbb{C}^{d}\right)\right)} \lesssim\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}
$$

thus

$$
\begin{equation*}
\left\|\mathcal{P}_{\varepsilon}\left(a(\dot{\bar{\varepsilon}})\left(I+\nabla N_{0}(\dot{\dot{\varepsilon}})\right) \nabla \mathcal{P}_{\varepsilon} u_{0}\right)-a_{0} \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\left(\mathbb{R}^{d}\right) ; \mathbb{C}^{d}\right)\right)} \lesssim\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\left(\mathbb{R}^{d}\right)\right)\right)} . \tag{2.47}
\end{equation*}
$$

Since $a(\dot{\bar{\varepsilon}})\left(I+\nabla N_{0}(\dot{\bar{\varepsilon}})\right) \nabla \mathcal{P}_{\varepsilon} u_{0}$ only belongs to $L^{2}$ with the bound

$$
\begin{equation*}
\left\|a(\dot{\bar{\varepsilon}})\left(I+\nabla N_{0}(\dot{\bar{\varepsilon}})\right) \nabla \mathcal{P}_{\varepsilon} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\left(\mathbb{R}^{d}\right) ; \mathbb{C}^{d}\right)\right)} \lesssim \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\left(\mathbb{R}^{d}\right)\right)\right)} \tag{2.48}
\end{equation*}
$$

(see (2.45) and (2.19)), we must estimate $I-\mathcal{P}_{\varepsilon}$ in a weaker norm. Indeed, using the Fourier transform and (2.43) one readily has

\left\|h-\mathcal{P}_{\varepsilon} h\right\|_{\left.H^{-1}\left(\left(\mathbb{R}^{d}\right)\right)\right)} \lesssim \varepsilon\|h\|_{L^{2}\left(\mathbb{R}^{d}\right)} \quad\left(h \in L^{2}\left(\mathbb{R}^{d}\right)\right),
$$

which, along with (2.48), gives

$$
\begin{align*}
& \|\left(a(\dot{\dot{\varepsilon}})\left(I+\nabla N_{0}(\dot{\bar{\varepsilon}})\right) \nabla \mathcal{P}_{\varepsilon} u_{0}-\mathcal{P}_{\varepsilon}\left(a(\dot{\dot{\varepsilon}})\left(I+\nabla N_{0}(\dot{\bar{\varepsilon}})\right) \nabla \mathcal{P}_{\varepsilon} u_{0}\right) \|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{C}^{d}\right)\right)}\right. \\
& \lesssim \varepsilon\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\left(\mathbb{R}^{d}\right)\right)\right)} . \tag{2.49}
\end{align*}
$$

Now, (2.17), (2.49) and (2.47) imply (2.22).

## 3 Heat equation

In this section, we explore the techniques just developed in the context of the heat equation. Thus, we consider the heterogeneous heat equation with rapidly oscillating coefficients:

$$
\begin{equation*}
\partial_{t} u_{\varepsilon}-\operatorname{div}_{x}\left(b\left(\frac{x}{\varepsilon}\right) \nabla_{x} u_{\varepsilon}\right)=f, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d} \tag{3.1}
\end{equation*}
$$

where $\varepsilon>0$ is a fixed parameter (the small period), $b$ is a periodic function with periodicity cell $\square:=\left[-\frac{1}{2}, \frac{1}{2}\right)^{d}, f$ is given and $u_{\varepsilon}$ is the unknown.
Similar to Section 2, we follow [6, p 91], to observe that if $u_{\varepsilon}$ satisfies (3.1) the vector $U^{\varepsilon}=\left(u_{\varepsilon}, b\left(\frac{x}{\varepsilon}\right) \nabla u_{\varepsilon}\right)^{\top}$ equivalently solves the evolutionary heat system

$$
\left(\left(\begin{array}{cc}
\partial_{\mathrm{t}} & 0  \tag{3.2}\\
0 & b^{-1}\left(\frac{x}{\varepsilon}\right)
\end{array}\right)+\left(\begin{array}{cc}
0 & -\operatorname{div}_{x} \\
-\nabla_{x} & 0
\end{array}\right)\right) U^{\varepsilon}=\binom{f}{0} \quad t \in \mathbb{R}, x \in \mathbb{R}^{d} .
$$

Also, as in Section 2, we assume for the rapidly oscillating coefficient $b \in L^{\infty}\left(\square ; L\left(\mathbb{C}^{d}\right)\right.$ with $\operatorname{Re} b(y) \xi \cdot \bar{\xi} \geq \kappa|\xi|^{2}$ for some $\kappa>0$ and all $\xi \in \mathbb{R}^{d}$ and (almost all) $y \in \square$ or, equivalently, the same estimates for $b(\cdot)^{-1}$, see Remark 2.2.
If $f \in L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ then by $[6$, Theorem 6.2.4] for each $\nu>0$, there exists a unique solution ${ }^{2} U^{\varepsilon} \in H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right) \cap L_{\nu}^{2}\left(\mathbb{R} ; \operatorname{dom}\left(\begin{array}{cc}0 & -\operatorname{div} \\ -\nabla & 0\end{array}\right)\right)$ to the evolutionary heat system (3.2).

We shall argue as in Section 2.1 to prove, below, the following homogenisation theorem.
Theorem 3.1. Let $\varepsilon>0, \theta \in \square^{*}, \lambda=\nu+i k, k \in \mathbb{R}$, and $F \in L_{\text {per }}^{2}\left(\square ; \mathbb{C} \times \mathbb{C}^{d}\right)$. Consider the solution $U_{\lambda, \theta}^{\varepsilon}$ to

$$
\left(\left(\begin{array}{cc}
\lambda & 0  \tag{3.3}\\
0 & b^{-1}
\end{array}\right)+\varepsilon^{-1}\left(\begin{array}{cc}
0 & -(\operatorname{div}+\mathrm{i} \theta \cdot) \\
-(\nabla+\mathrm{i} \theta) & 0
\end{array}\right)\right) U_{\lambda, \theta}^{\varepsilon}=\binom{F}{0}
$$

and

$$
\begin{equation*}
W_{\lambda, \xi}=c_{0}\binom{1}{b\left(I+\nabla N_{0}\right) \mathrm{i} \xi}, \quad c_{0}=\left(\lambda+b_{0} \xi \cdot \xi\right)^{-1}\langle F, 1\rangle_{L^{2} \text { (ロ) }}, \quad \xi \in \mathbb{R} . \tag{3.4}
\end{equation*}
$$

Then, there exists $C>0$ uniformly in $\varepsilon, \lambda, \theta$ and $F$ such that

$$
\begin{equation*}
\left\|\lambda^{1 / 2}\left(U_{\lambda, \theta}^{\varepsilon}\right)_{1}-\lambda^{1 / 2}\left(W_{\lambda, \theta / \varepsilon}\right)_{1}\right\|_{L^{2}(\square)}+\left\|\left(U_{\lambda, \theta}^{\varepsilon}\right)_{2}-\left(W_{\lambda, \theta / \varepsilon}\right)_{2}\right\|_{L^{2}\left(\square ; \mathbb{C}^{d}\right)} \leq C \varepsilon\|F\|_{L^{2}(\square)} \tag{3.5}
\end{equation*}
$$

Upon setting $F:=\mathcal{G} \Gamma_{\varepsilon} \mathcal{L}_{\nu} f$ in Theorem 3.1, one has $U^{\varepsilon}:=\mathcal{L}_{\nu}^{-1} \Gamma_{\varepsilon}^{-1} \mathcal{G}^{-1} U_{\lambda, \theta}^{\varepsilon}$ (see Section 2 for details) and, arguing exactly as in Section 2.2, we establish that

$$
\mathcal{L}_{\nu}^{-1} \Gamma_{\varepsilon}^{-1} \mathcal{G}^{-1} W_{\lambda, \theta / \varepsilon}=\binom{\mathcal{P}_{\varepsilon} u_{0}}{b(\dot{\bar{\varepsilon}})\left(I+\nabla N_{0}(\dot{\bar{\varepsilon}})\right) \nabla \mathcal{P}_{\varepsilon} u_{0}}
$$

for $u_{0}$ being the solution to the homogenised heat equation

$$
\begin{equation*}
\partial_{\mathrm{t}} u_{0}-\operatorname{div}_{x} b_{0} \nabla_{x} u_{0}=f \tag{3.6}
\end{equation*}
$$

where $b_{0}$ is the homogenised coefficients for $b$. Then, via the properties of $\mathcal{P}_{\varepsilon}, N_{0}$ and $u_{0}$ we readily establish Theorem 3.2.

Theorem 3.2. Fix $\varepsilon>0$ and $f \in L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$, and suppose $b$ satisfies (2.3) replacing $a$. Then $u_{\varepsilon}$ the solution to (3.1) and $u_{0}$ the solution to (3.6) satisfy:

&\left\|b(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-b(\dot{\bar{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla u_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\|f\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)},  \tag{3.8}\\
&\left\|b(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-b_{0} \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\|f\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}, \tag{3.9}
\end{align*}
$$

for some $C>0$ independent of $\varepsilon$ and $f$.

[^1]Similarly to the case of the wave equation, we employ that $\partial_{\mathrm{t}}$ is boundedly invertible in $L_{\nu}^{2}\left(\mathbb{R}^{d} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ for $\nu>0,(3.7)$, that $b$ is uniformly positivity with (3.8) as well as (3.7) and (3.9) to deduce the following set of estimates.

Corollary 3.3. Under the assumptions of Theorem 3.2,

\left(\left\|U_{1}^{\varepsilon}-U_{1}^{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}^{2}+\left\|U_{2}^{\varepsilon}-U_{2}^{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)}^{2}\right)^{1 / 2} & \leq C \varepsilon\|f\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)},
\end{aligned}

with $C \geq 0$ independent of $\varepsilon$ and $f$.
Next, we turn to the proofs of the main results of this section.

### 3.1 Proof of Theorem 3.1

The proof of Theorem 3.1, in essence, goes as in Section 2.1 with the only difference being that one has better estimates in $\lambda$ due to the improved regularity of the solution to the evolutionary heat system compared to that of the evolutionary wave system. Indeed, these better estimates will rely on the following maximal regularity result for evolutionary parabolic equations, first established and proved in [9, Section 3.1]; see also [6, Example 15.24.4] or [5] for a first account on maximal regularity for evolutionary equations in the sense of [6].

Lemma 3.4. Let $H_{1}, H_{2}$ be Hilbert spaces, suppose $C$ : dom $C \subseteq H_{2} \rightarrow H_{1}$ be a densely defined linear operator, and $\mathfrak{n} \in L\left(H_{2}\right)$ satisfy

Let us prove Theorem 3.1. For this recall $E_{\theta}$ from (2.26). The analogue of Proposition 2.9 is as follows:

Proof. Dropping super and subscripts; from the assumptions on $b$, it follows from Lemma 3.4 that the solution $U$ to (3.3) satisfies

Notice that (3.17) is a well-posed evolutionary problem on $E_{\theta}$ and an application of Lemma 3.4 (for $H^{1}=\mathbb{C}, H^{2}=\mathbb{C}^{d} \oplus L_{\text {sol }, \theta}^{2}(\square), \mathfrak{n}=P_{2} b^{-1}$ and $C=-\varepsilon^{-1}(\operatorname{div}+\mathrm{i} \theta \cdot) P_{1}$ with $C^{*}=$ $-\varepsilon^{-1}(\operatorname{grad}+\mathrm{i} \theta) P_{2}$, see Remark 2.7) gives

Similarly, (3.16) is a well-posed evolutionary problem on $E_{\theta}^{\perp}$ and Lemma 3.4, along with the bound (3.14) and the fact $P_{\theta}^{\perp} M U^{(1)}=P_{\theta}^{\perp}\left(0, b^{-1} U_{2}^{(1)}\right)^{\top}$, gives

Consequently, by utilising (2.27) and the above inequality, it follows that

\end{equation*}

Proof. One has

The above identities and (2.3) imply that

By the definitions of $c$ and $c_{0}$, and Proposition 2.12 we compute

\left|c-c_{0}\right|=\frac{\left|b_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}-b_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|}{\left|\lambda+b_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|\left|\lambda+b_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right|}\left|\langle F, 1\rangle_{L^{2}(\square)}\right| \lesssim \frac{|\theta|^{3}}{\varepsilon^{2}} \\
\lesssim \varepsilon d\left(b_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right) e\left(\sqrt{\left.b_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}| | \lambda+b_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon} \right\rvert\,}\|F\|_{L^{2}(\square)}\right)\|F\|_{L^{2}(\square)},
\end{gathered}
$$

and, similarly,

\frac{|\theta|}{\varepsilon}\left|c-c_{0}\right| \lesssim \varepsilon d\left(b_{\theta} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right) d\left(b_{0} \frac{\theta}{\varepsilon} \cdot \frac{\theta}{\varepsilon}\right)\|F\|_{L^{2}(\square)},
$$

where $d(t):=\frac{t}{|\lambda+t|}$, and $e(t):=\frac{t}{\left|\lambda+t^{2}\right|}$, for $t \in[0, \infty)$. With $\lambda=\mathrm{i} t+k$ it is straightforward to see that $d(t)=t\left((\nu+t)^{2}+k^{2}\right)^{-1 / 2} \leq 1$ for all $t \in[0, \infty)$. One can readily show that $e(t)=t\left(\left(\nu+t^{2}\right)^{2}+k^{2}\right)^{-1 / 2} \leq e\left(|\lambda|^{-1 / 2}\right) \lesssim|\lambda|^{-1 / 2}$ for all $t \in[0, \infty)$. Putting the above results together gives

which implies (3.20) and completes the proof.
The remaining claims of Section 3 can be shown in a completely analogous manner as the respective ones for the wave system.

## 4 Thermo-elastic system of equations

The final application of our methods to show estimates in homogenisation employing the framework of evolutionary equations concerns thermo-elasticity. In fact, we combine our results for the wave system and the heat system provided earlier.
Consider the system of thermo-elastic equations with rapidly oscillating coefficients

here, $\varepsilon>0, u_{\varepsilon}, v_{\varepsilon}$ are the unknown solutions to be determined, $f, g$ are given, the coefficients $a, b$, are matrix-value periodic functions and $\gamma$ is a scalar-valued periodic function; all with fundamental periodicity cell $\square:=\left[-\frac{1}{2}, \frac{1}{2}\right)^{d}$. We additionally assume $x \mapsto \gamma\left(\frac{x}{\varepsilon}\right)$ (and therefore $\left.x \mapsto \bar{\gamma}\left(\frac{x}{\varepsilon}\right)\right)$ is a multiplier in $H^{1}$, i.e., there is $C \geq 0$ such that

For $\varepsilon=0, U^{0}=\left(\partial_{\mathrm{t}} u_{0}, a_{0} \nabla_{x} u_{0}, v_{0}, b_{0} \nabla_{x} v_{0}\right)^{\top}$ solves (4.4) with

$$
M_{0}=\left(\begin{array}{cccc}
1 & 0 & 0 & 0 \\
0 & a_{0}^{-1} & 0 & 0 \\
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 0
\end{array}\right) \quad \text { and } \quad N_{0}=\left(\begin{array}{cccc}
0 & 0 & \langle\gamma\rangle & 0 \\
0 & 0 & 0 & 0 \\
-\langle\gamma\rangle & 0 & 0 & 0 \\
0 & 0 & 0 & b_{0}^{-1}
\end{array}\right) .
$$

The following well-posedness result for (4.4) is well-known (see [4] or [6, 7]).

Theorem 4.1. Fix $\varepsilon \geq 0$. Suppose, $a, b, \gamma \in L^{\infty}\left(\mathbb{R}^{d} ; L\left(\mathbb{C}^{d}\right)\right)$ be such that

$$
a(x)=a(x)^{*} \text { and } a(x) \geq \kappa_{1} \text { and } \operatorname{Re} b(x) \geq \kappa_{2}
$$

in the sense of positive definiteness for a.e. $x \in \mathbb{R}^{d}$ for some $\kappa_{1}, \kappa_{2}>0$.
Then, for all $\nu>0$ and for all $f \in H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ and $g \in L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ there exists a unique solution $U^{\varepsilon}$ to (4.4) with $U_{1}^{\varepsilon}, U_{3}^{\varepsilon} \in H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right) \cap L_{\nu}^{2}\left(\mathbb{R} ; H^{1}\left(\mathbb{R}^{d}\right)\right) ; U_{2}^{\varepsilon} \in H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{C}^{d}\right)\right) \cap$ $L_{\nu}^{2}\left(\mathbb{R} ; H_{\mathrm{div}}\left(\mathbb{R}^{d}\right)\right)$ and $U_{4}^{\varepsilon} \in L_{\nu}^{2}\left(\mathbb{R} ; H_{\mathrm{div}}\left(\mathbb{R}^{d}\right)\right)$. Furthermore, the following inequalities hold:

$$
\begin{align*}
&\left\|U_{1}^{\varepsilon}\right\|_{H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|U_{2}^{\varepsilon}\right\|_{H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{C}^{d}\right)\right) \cap L_{\nu}^{2}\left(\mathbb{R} ; H_{\text {div }}\left(\mathbb{R}^{d}\right)\right)}+\left\|U_{3}^{\varepsilon}\right\|_{H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|U_{4}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H_{\text {div }}\left(\mathbb{R}^{d}\right)\right)} \\
& \lesssim\|f\|_{H_{\nu}^{1}\left(\mathbb{R} ; L^{( }\left(\mathbb{R}^{d}\right)\right)}+\|g\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} . \tag{4.5}
\end{align*}
$$

In this section, we shall prove the following homogenisation theorem:
Theorem 4.2. Fix $\varepsilon>0$ and $f \in H_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ and $g \in H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$. suppose (4.1) holds. Then, the following inequalities hold:

$$
\begin{align*}
& \left\|\partial_{\mathrm{t}} u_{\varepsilon}-\partial_{\mathrm{t}} u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}}^{1 / 2} v_{\varepsilon}-\partial_{\mathrm{t}}^{1 / 2} v_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \\
& +\| a\left(\dot{\overline{\dot{c}}) \nabla u_{\varepsilon}-a(\dot{\bar{\varepsilon}}) \nabla\left(u_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla u_{0}\right) \|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)}} \begin{array}{l}
+\left\|b(\dot{\bar{\varepsilon}}) \nabla v_{\varepsilon}-b(\dot{\bar{\varepsilon}}) \nabla\left(v_{0}+\varepsilon N_{0}(\dot{\bar{\varepsilon}}) \cdot \nabla v_{0}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)}+\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a_{0} \nabla u_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \\
+\left\|b(\dot{\bar{\varepsilon}}) \nabla v_{\varepsilon}-b_{0} \nabla v_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right),
\end{array}\right. \text { (4.6)}
\end{align*}
$$

for some $C>0$ independent of $\varepsilon, f$ and $g$.
Proof of Theorem 4.2. Note that $u_{\varepsilon}$ solves the wave equation

$$
\begin{equation*}
\partial_{t t} u_{\varepsilon}-\operatorname{div}_{x}\left(a\left(\frac{x}{\varepsilon}\right) \nabla_{x} u_{\varepsilon}\right)=f-\gamma\left(\frac{x}{\varepsilon}\right) v_{\varepsilon}, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d} \tag{4.7}
\end{equation*}
$$

By Theorem 4.1, one has

$$
\left\|\partial_{\mathrm{t}}^{2} v_{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \lesssim\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}
$$

which, along with the boundedness of $\gamma$, implies

$$
\left\|\partial_{\mathrm{t}}^{2}\left(f-\gamma\left(\frac{x}{\varepsilon}\right) v_{\varepsilon}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \lesssim\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} .
$$

From this observation, along with Theorem 2.5, one has

$$
\begin{align*}
&\left\|\partial_{\mathrm{t}} u_{\varepsilon}-\partial_{\mathrm{t}} u_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} d\right)\right)}\right)  \tag{4.8}\\
&\left\|a(\dot{\dot{\varepsilon}}) \nabla u_{\varepsilon}-a(\dot{\dot{\varepsilon}}) \nabla\left(u_{0}^{\varepsilon}+\varepsilon N_{0}(\dot{\dot{\varepsilon}}) \cdot \nabla u_{0}^{\varepsilon}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right) \\
&\left\|a(\dot{\bar{\varepsilon}}) \nabla u_{\varepsilon}-a_{0} \nabla u_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right) \tag{4.10}
\end{align*}
$$

for $u_{0}^{\varepsilon}$ the solution to

$$
\begin{equation*}
\partial_{t t} u_{0}^{\varepsilon}+\operatorname{div}_{x} a_{0} \nabla_{x} u_{0}^{\varepsilon}=f-\gamma\left(\frac{x}{\varepsilon}\right) v_{\varepsilon}, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d} . \tag{4.11}
\end{equation*}
$$

Similarly, $v_{\varepsilon}$ solves the heat equation

$$
\begin{equation*}
\partial_{t} v_{\varepsilon}-\operatorname{div}_{x}\left(b\left(\frac{x}{\varepsilon}\right) \nabla_{x} v_{\varepsilon}\right)=g+\bar{\gamma}\left(\frac{x}{\varepsilon}\right) \partial_{t} u_{\varepsilon}, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d}, \tag{4.12}
\end{equation*}
$$

and Theorem 4.1 gives

$$
\left\|\partial_{\mathrm{t}} u_{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \lesssim\left\|\partial_{\mathrm{t}} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\|g\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}
$$

So, by Theorem 3.2, one has

$$
\begin{align*}
\left\|\partial_{\mathrm{t}}^{1 / 2} v_{\varepsilon}-\partial_{\mathrm{t}}^{1 / 2} v_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} & \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\|g\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right)  \tag{4.13}\\
\left\|b(\dot{\bar{\varepsilon}}) \nabla v_{\varepsilon}-b(\dot{\bar{\varepsilon}}) \nabla\left(v_{0}^{\varepsilon}+\varepsilon N_{0}(\dot{\dot{\varepsilon}}) \cdot \nabla v_{0}^{\varepsilon}\right)\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} & \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\|g\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right)  \tag{4.14}\\
\left\|b(\dot{\bar{\varepsilon}}) \nabla v_{\varepsilon}-b_{0} \nabla v_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H^{-1}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)} & \leq C \varepsilon\left(\left\|\partial_{\mathrm{t}} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\|g\|_{\left.L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)\right)}\right) \tag{4.15}
\end{align*}
$$

for $v_{0}^{\varepsilon}$ the solution to

$$
\begin{equation*}
\partial_{t} v_{0}^{\varepsilon}-\operatorname{div}_{x} b_{0} \nabla_{x} v_{0}^{\varepsilon}=g+\bar{\gamma}\left(\frac{x}{\varepsilon}\right) \partial_{t} u_{\varepsilon}, \quad t \in \mathbb{R}, x \in \mathbb{R}^{d} . \tag{4.16}
\end{equation*}
$$

We see that $U_{0}^{\varepsilon}:=\left(\partial_{\mathrm{t}} u_{0}^{\varepsilon}, a_{0} \nabla u_{0}^{\varepsilon}, v_{0}^{\varepsilon}, b_{0} \nabla v_{0}^{\varepsilon}\right)^{\top}$ solves the homogenised evolutionary thermoelastic system

$$
\left(\partial_{t} M_{0}+N_{0}+A\right) U_{0}^{\varepsilon}=F+R_{\varepsilon}, \quad \text { where } R_{\varepsilon}:=\left(-\gamma\left(\frac{x}{\varepsilon}\right) v_{\varepsilon}+\langle\gamma\rangle v_{0}^{\varepsilon}, 0, \bar{\gamma}\left(\frac{x}{\varepsilon}\right) \partial_{t} u_{\varepsilon}-\overline{\langle\gamma\rangle} \partial_{\mathrm{t}} u_{0}^{\varepsilon}, 0\right)^{\top} .
$$

We shall prove below that

$$
\begin{equation*}
\left\|\left(R_{\varepsilon}\right)_{1}\right\|_{H_{\nu}^{1}\left(\mathbb{R}^{d} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\left(R_{\varepsilon}\right)_{2}\right\|_{L_{\nu}^{2}\left(\mathbb{R}^{d} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left(\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{\left.L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)\right)}\right) \tag{4.17}
\end{equation*}
$$

This informs us that $U^{\varepsilon}-U^{0}$ solves a the homogenised evolutionary system with $\varepsilon$-small right-hand-side. Indeed, Theorem 4.1 implies

$$
\begin{align*}
\left\|\partial_{\mathrm{t}} u_{0}^{\varepsilon}-\partial_{\mathrm{t}} u_{0}\right\|_{H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|a_{0} \nabla_{x} u_{\varepsilon}-a_{0} \nabla_{x} u_{0}\right\|_{H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} ; \mathbb{C}^{d}\right)\right) \cap L_{\nu}^{2}\left(\mathbb{R} ; H_{\mathrm{div}}\left(\mathbb{R}^{d}\right)\right)} \\
+\left\|v_{\varepsilon}-v_{0}\right\|_{H_{\nu}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|b_{0} \nabla_{x} v_{\varepsilon}-b_{0} \nabla_{x} v_{0}\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; H_{\mathrm{div}}\left(\mathbb{R}^{d}\right)\right)} \\
\lesssim \varepsilon\left(\left\|\partial_{\mathrm{t}}^{2} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\left\|\partial_{\mathrm{t}} g\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right) . \tag{4.18}
\end{align*}
$$

Inequalities (4.8)-(4.10), (4.13)-(4.15) and (4.18) prove the desired result (4.6).
The proof is complete, subject to establishing (4.17). Let us prove this inequality here. Clearly, $\left(R_{\varepsilon}\right)_{1}=-\gamma\left(\frac{x}{\varepsilon}\right) v_{0}^{\varepsilon}$ up to a term of order $\varepsilon$ that we have the desired control over (see (4.13)). Now, by Proposition 2.15

$$
\mathcal{P}_{\varepsilon} \gamma\left(\frac{x}{\varepsilon}\right) \mathcal{P}_{\varepsilon} v_{0}^{\varepsilon}=\langle\gamma\rangle \mathcal{P}_{\varepsilon} v_{0}^{\varepsilon},
$$

and we compute

$$
\langle\gamma\rangle v_{0}^{\varepsilon}=\gamma\left(\frac{x}{\varepsilon}\right) v_{0}^{\varepsilon}+r_{\varepsilon} ; \quad r_{\varepsilon}:=-\left(I-\mathcal{P}_{\varepsilon}\right) \gamma\left(\frac{x}{\varepsilon}\right) v_{0}^{\varepsilon}-\mathcal{P}_{\varepsilon} \gamma\left(\frac{x}{\varepsilon}\right)\left(I-\mathcal{P}_{\varepsilon}\right) v_{0}^{\varepsilon}+\langle\gamma\rangle\left(I-\mathcal{P}_{\varepsilon}\right) v_{0}^{\varepsilon} .
$$

Inequality (2.43), the assumption that $\gamma\left(\frac{x}{\varepsilon}\right)$ is uniformly bounded and a uniform $H^{1}$-multiplier, see (4.2), and Theorem 4.1 give

$$
\begin{aligned}
\left\|\gamma\left(\frac{x}{\varepsilon}\right) v_{0}^{\varepsilon}-\langle\gamma\rangle v_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R}^{d} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} & =\left\|r_{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R}^{d} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \\
& \lesssim \varepsilon\left\|v_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R}^{d} ; H^{1}\left(\mathbb{R}^{d}\right)\right)} \lesssim \varepsilon\left(\left\|\partial_{\mathrm{t}} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\|g\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right) .
\end{aligned}
$$

Then the desired inequality for $\left(R_{\varepsilon}\right)_{1}$, in (4.17), follows. Similarly,

$$
\left.\begin{array}{rl}
\left\|\bar{\gamma}\left(\frac{x}{\varepsilon}\right) \partial_{\mathrm{t}} u_{0}^{\varepsilon}-\overline{\langle\gamma\rangle} \partial_{\mathrm{t}} u_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R}^{d} ; L^{2}\left(\mathbb{R}^{d}\right)\right)} \\
& \lesssim \varepsilon\left\|\partial_{\mathrm{t}} u_{0}^{\varepsilon}\right\|_{L_{\nu}^{2}\left(\mathbb{R}^{d} ; H^{1}\left(\mathbb{R}^{d}\right)\right)}
\end{array}\right) \varepsilon \varepsilon\left(\left\|\partial_{\mathrm{t}} f\right\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}+\|g\|_{L_{\nu}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)}\right),
$$

which along with (4.8) provides the desired inequality for $\left(R_{\varepsilon}\right)_{2}$. That is, (4.17) holds and the proof is complete.
