# Long-range interactions between a $\mathrm{He}\left(2^{3} S\right)$ atom and a $\mathrm{He}\left(2^{3} P\right)$ atom for like isotopes

#### Abstract

For the interactions between a $\operatorname{He}\left(2^{3} S\right)$ atom and a $\operatorname{He}\left(2^{3} P\right)$ atom for like isotopes, we report perturbation theoretic calculations using accurate variational wave functions in Hylleraas coordinates of the coefficients determining the potential energies at large internuclear separations. We evaluate the coefficient $C_{3}$ of the first order resonant dipole-dipole energy and the van der Waals coefficients $C_{6}, C_{8}$, and $C_{10}$ for the second order energies arising from the mutual perturbations of instantaneous electric dipole, quadrupole, and octupole interactions. We also evaluate the coefficient $C_{9}$ of the leading contribution to the third order energy. We establish definitive values including treatment of the finite nuclear mass for the ${ }^{3} \mathrm{He}\left(2^{3} S\right)-{ }^{3} \mathrm{He}\left(2^{3} P\right)$ and ${ }^{4} \mathrm{He}\left(2^{3} S\right)-{ }^{4} \mathrm{He}\left(2^{3} P\right)$ interactions.

Recently, there has been considerable interest in the study of helium dimers and ultracold helium collisions associated with metastable helium atoms [1, 2, 3, 4, 5, 6, 6, 8, 9, 10, 11]. Molecular lines of the helium dimers associated with the $\operatorname{He}\left(2^{3} S\right)-\operatorname{He}\left(2^{3} P\right)$ asymptotes have been produced by photoassociation of spin-polarized metastable helium atoms $\operatorname{He}\left(2^{3} S_{1}\right)$. In the purely long-range $0_{u}^{+}$potential well (with a minimum internuclear distance reaching 150 bohr ) associated with the $\operatorname{He}\left(2^{3} S_{1}\right)-\operatorname{He}\left(2^{3} P_{0}\right)$ asymptote, bound states of the helium dimer [1, 2, 5] can be used in measurements of the $s$-wave scattering length for collisions of two ${ }^{4} \mathrm{He}\left(2^{3} S_{1}\right)$ atoms [4, 7]. Molecular lines to the red of the $D_{2}$ atomic transition in helium dimers associated with the $\operatorname{He}\left(2^{3} S\right)-\operatorname{He}\left(2^{3} P_{2}\right)$ asymptote are of interest for control of the scattering length using an "optical Feshbach resonance" 4, 6]. Published data are scarce on the long-range part of the $\operatorname{He}\left(2^{3} S\right)-\operatorname{He}\left(2^{3} P\right)$ potential energies, which determine the energy level structures of the ultralong-range dimers formed in photoassociation of ultracold metastable helium atoms.

In this paper, we present perturbation theoretic calculations of the coefficients determining the potential energies at large internuclear separations using accurate variational wave functions in Hylleraas coordinates. We evaluate the coefficient $C_{3}$ of the first order resonant dipole-dipole energy, and the van der Waals coefficients $C_{6}, C_{8}$, and $C_{10}$ of the second order energies arising from the mutual perturbations of instantaneous electric dipole, quadrupole, and octupole interactions. We also evaluate for the third order energy the coefficient $C_{9}$ of the leading term. We establish definitive values including treatment of the finite nuclear mass for the ${ }^{3} \mathrm{He}\left(2^{3} S\right)-{ }^{3} \mathrm{He}\left(2^{3} P\right)$ and ${ }^{4} \mathrm{He}\left(2^{3} S\right)-{ }^{4} \mathrm{He}\left(2^{3} P\right)$ interactions. Definitive values for the $C_{6}, C_{8}, C_{9}$, and $C_{10}$ coefficients are established.

In this work, atomic units are used throughout. For the $\operatorname{He}\left(2^{3} S\right)-\operatorname{He}\left(2^{3} P\right)$ system, the zeroth-order wave function appropriate for the perturbation calculation of the long-range interaction can be written in the form 12]:

where $\Psi_{n_{a}}$ is the metastable $\operatorname{He}\left(2^{3} S\right)$ wave function, $\Psi_{n_{b}}$ is the wave function for the $\operatorname{He}\left(2^{3} P\right)$ atom with magnetic quantum number $M, \boldsymbol{\sigma}$ and $\boldsymbol{\rho}$ are the collection of coordinates of the two helium atoms in the laboratory reference frame, and the " $\pm$ " sign indicates the gerade and ungerade states. The corresponding zeroth-order energy is $E_{n_{a} n_{b}}^{(0)}=E_{n_{a}}^{(0)}+E_{n_{b}}^{(0)}$. At large internuclear distances, the interaction potential between the two helium atoms can be
expanded as an infinite series in powers of $1 / R$ (12]

$B_{2}$ in Eq.(13) is the exchange interaction of the two states $\operatorname{He}\left(2^{3} S\right)$ and $\operatorname{He}\left(2^{3} P\right)$. After applying the Wigner-Eckart theorem, we have

In this work, we do not present a complete third order calculation. We only consider the leading term $C_{9}(M, \pm)$ of $V^{(3)}$, which is comparable to the smallest term of $V^{(2)}$.

where $m_{n}$ and $m_{e}$ are the masses of nucleus and electron respectively, $q_{n}$ and $q_{e}$ are their charges, and $\mathbf{R}_{n}, \mathbf{R}_{1}$, and $\mathbf{R}_{2}$ are the corresponding position vectors relative to the laboratory
frame. Introduce the following transformation

where $M_{T}=m_{n}+2 m_{e}$ is the total mass of helium atom and $\mathbf{X}$ is the position vector for the center of mass of helum. In the center-of-mass frame, the Hamiltonian becomes

where $r_{12}=\left|\mathbf{r}_{1}-\mathbf{r}_{2}\right|$ and $\mu_{e}=m_{e} m_{n} /\left(m_{e}+m_{n}\right)$ is the reduced mass between the electron and the nucleus. The eigenvalue spectrum and corresponding eigenfunctions are obtained by diagonalizing the Hamiltonian (39) in the correlated Hylleraas basis set [12]

where $\mathcal{Y}_{\ell_{1} \ell_{2}}^{L M}\left(\hat{\mathbf{r}}_{1}, \hat{\mathbf{r}}_{2}\right)$ is the coupled spherical harmonics for the two electrons forming a common eigenstate of $\mathbf{L}^{2}$ and $L_{z}$. Except for some truncations, all terms are included in the basis such that

with $\Omega$ being an integer. As $\Omega$ increases, the size of basis set is increased progressively.
It is necessary to transform the transition operator

It is noted that for the case of infinite nuclear mass, the above operators reduce to

For the finite nuclear mass case, however, $T_{\ell}$ can not be obtained by a simple mass scaling from $T_{\ell}^{\infty}$, except $T_{1}$ which does not contain $m_{e} / M_{T}$ explicitly for a neutral system.

Table $\square$ gives the convergence pattern of $C_{6}(M, \pm)$ for the case of infinite nuclear mass as the sizes of basis sets, including the two initial states and the four intermediate states, increase progressively. Table $\llbracket$ lists the contributions to $C_{6}(M, \pm)$ from three pairs of intermediate symmetries $\left({ }^{3} P,{ }^{3} S\right),\left({ }^{3} P,(p p){ }^{3} P\right)$ doubly-excited states, and $\left({ }^{3} P,{ }^{3} D\right)$. Our final results for $C_{3}(M, \pm), C_{6}(M, \pm), C_{8}(M, \pm), C_{9}(M, \pm)$, and $C_{10}(M, \pm)$ are presented in Table III. To our knowledge, no definitive calculations have been reported for the dispersion coefficients $C_{6}(M, \pm), C_{8}(M, \pm), C_{9}(M, \pm)$, and $C_{10}(M, \pm)$. Table IV is a comparison with the existing values of $C_{3}(M, \pm)$ and $C_{6}(M, \pm)$. Our values for $C_{3}(M, \pm)$ differ from those given in Refs. [2] and [5]. The origins of these discrepancies are uncertain. Drake 14] tabulated the oscillator strengths of helium, including ${ }^{3} \mathrm{He}$ and ${ }^{4} \mathrm{He}$. In order to extract the square of the transition matrix element connecting $2^{3} S$ and $2^{3} P$, besides some numerical constants, the tabulated value should be multipied by $1+2 m_{e} / m_{n}$ and divided by the transition energy corrected for the finite nuclear mass. Our results are in perfect agreement with Drake's values such obtained. For $C_{6}(M, \pm)$, our values differ from the values used in the work of Venturi et al. [5] at the level of $0.8 \%$ and $0.9 \%$ respectively for $C_{6}(0, \pm)$ and $C_{6}( \pm 1, \pm)$ 。
