Page Ranges and Footnotes

When an article is quoted for the first time, but a specific page range is being highlighted in the text above, we place the relevant pages in brackets: 236–338 [p. 240]; 12–28 [14–17].⁴ If a specific footnote is being quoted from the page of a book or an article, put the footnote number in brackets following the letter "n": 40 [n3].

Repeated References

For all repeated references in books or articles, we only include the last name, English title (abbreviated if it is two-part), and page range, if relevant.

Examples:

Wazana, All the Boundaries of the Land, 217.

Greenstein, "The Fugitive Hero Narrative Pattern in Mesopotamia," 22.
