## **President's Report - Vince Gennaro**

It's been another outstanding year for SABR, as we advanced our mission to foster the study of baseball, maintain an accurate account of its historical record and to produce and disseminate a wide range of research. We've made progress in numerous areas.

SABR is a research community dedicated to deepening the public's understanding and appreciation of the great game of baseball. We recognize, support, and foster a wide range of baseball interests, ranging from the Deadball Era, to Latinos in baseball, science and baseball, and our scouts research committee. Our ability to fulfill our mission is directly related to the diversity of our research committees, as well as the quality of our research. Likewise, the more our work is seen and heard within and outside the SABR community, the better we fulfill our mission.

Over the last year the SABR leadership—the Board, our CEO, and our staff—continued our three major themes to forward the Society's mission:

- ▲ Support our members' research efforts by acquiring research assets and tools and providing an outlet for their work through publications
- A Improve our connection to the baseball community—those who have the most to gain from our members' research
- A Maintain SABR's financial stability through a sound operating model, so that we can ultimately invest in additional research tools and assets

We continue to make outstanding progress on all three fronts, including the continued digitization of The Sporting News (TSN) player cards. This important one-of-a-kind set of documents will be an important source of information for researchers for decades to come. On the publications front, it was a banner year. Since last year's convention, 9 SABR e-books have been published, all of which are free to members. Second, we continue to make excellent progress building our awareness and improving our connection to the broader baseball community. These relationships are critical to SABR's mission, namely the dissemination of baseball research and information, by creating a conduit for our research to be seen and heard by those within the baseball community. It ensures that the work of our dedicated SABR researchers has even greater meaning and impact by reaching the leaders and custodians of our national pastime. Finally, we had another solid year financially in 2017. While we did not have the benefit of a large donation from an estate, as we had three years ago, we continue to invest in SABR's future.

Perhaps one of our biggest developments over the last year was the recently announced departure of our CEO, Marc Appleman. Marc's positive impact will be felt for many years to come. While we will miss his talents and leadership, I'm personally very excited about SABR's future. First, Marc is staying within the baseball community, where he can continue to collaborate with SABR in his new role of CEO of HOME: The Baseball Experience. This project is designed to present the game of baseball in never-before-seen ways to fans and potential fans, creating an innovative, and perhaps unlikely partnership between technology and emotion, intending to dazzle the next generation of baseball fans. Second, this project was birthed and incubated at SABR, which shows another dimension of our organization—one which can plant seeds of new concepts and ideas to further interest in the game of baseball, even if the scope of the ultimate project is well beyond the financial reach of our organization. Finally, change is good, even when it disrupts an eight-year successful partnership between a CEO, the staff, and the Board of Directors. As we approach our 50<sup>th</sup> year, "renewal" is on my mind. Renewal in the form of the next generation of membership, renewal of our commitment to our mission, and renewal of our leadership. We look forward to our next leader, who will welcome the challenge to once again revitalize SABR and help take our organization to yet another level, as we head towards our 50<sup>th</sup> birthday.

In the end, SABR is a community for those who share a passion for baseball. The goal of your SABR leadership is to support that passion by bringing you together as a community, providing you with the opportunities to collaborate and share in exciting research projects, and creating outlets for your work to be viewed, discussed and debated by others. As your SABR President, I look forward to another year of building on our successes and helping SABR members enlighten the baseball establishment and fans alike about the game we all cherish.

## **CEO's Report - Marc Appleman**

From the most attended SABR National Convention ever — more than 800 attendees gathered in New York City last June — to producing one of the top SABR Analytics Conferences in March 2018, to the launch of SABR's impressive Oral History Collection at SABR.org, it has been an incredibly exciting and successful year for SABR and its members.

**SABR Chapters**: With the addition of new chapters in Taiwan; the Netherlands (Bert Blyleven Chapter); Lexington, Kentucky (Sweet Lou Johnson); and Cherry Hill, NJ (Goose Gosling Chapter), SABR now has 74 chapters worldwide. For a detailed look at the events that chapters put on and the speakers they hosted, please see the Chapter Reports section in the appendix.

**SABR Research Committees**: The 31 SABR committees continue to produce excellent research and many of them provided top speakers at their SABR 47 annual meetings. For a complete look at the accomplishments of SABR's committees, please see the Research Committee Reports section in the appendix.

**SABR's Publications Program**: Under the direction of Cecilia Tan, SABR published fall and spring editions of the Baseball Research Journal and offered both a print version of The National Pastime and an expanded digital version that was available to all SABR members.

From last year's convention in June 2017 through May 2018, SABR members have received free copies of the following SABR e-books:

The publishing program has also been making in-roads into Spanish-language publishing as well. Last year's Spanish edition of Cuban Baseball Stars will be followed by a new edition of Puerto Rico and Baseball: 60 Biographies in Spanish. We also published a Spanish translation of the SABR Style Guide in 2018, thanks to Martín Alonso and Rob Mains.

**SABR BioProject**: The BioProject is now home to more than 4,500 published biographies. The Baseball Biography Project is an ongoing effort to research and write comprehensive biographical articles on people who played or managed in the Major Leagues, or otherwise made a significant contribution to the sport.

**SABR Games Project**: Started in 2014, more than 1,200 accounts of games have been produced. The SABR Baseball Games Project is an initiative that was formed to research, write, and publish accounts of Major League regular season, postseason, and All-Star Games, along with other games of historical significance such as in the Negro Leagues, Minor Leagues, or international or exhibition contests.

**SABR's collaboration with Rawlings**: The fifth year of this collaboration was once again very successful. The SABR Defensive Index (SDI) played a key role in the selection of a number of the Rawlings Gold Glove Award winners. The winners of the 2017 Rawlings Platinum Glove Awards presented by SABR were announced by SABR President Vince Genaro at the Rawlings Gold Glove Award Banquet in November. The award is decided by a combination of fan votes and the SDI. The SDI considers a fielder's range, his arm and sure-handedness, along with his outstanding plays.

**SABR's partnership with MLBAM**: SABR continues to work closely with MLB.com. We continue to provide member-produced content for MLB.com. SABR members played a key role in selecting the winners of the Esurance MLB Awards (formerly the GIBBYs). The votes from SABR members are equal to each of the other four categories: SABR members (20%), MLB.com (20%), front office personnel (20%), retired players (20%), media (20%). For the sixth straight year, SABR presented SABR-branded panels at the MLBAM stage at the All-Star Game FanFest held in Miami in 2017.

**SABR.org**: SABR.org enjoyed another very successful year, with a record number of page views (nearly 2.9 million) and unique visitors (1.2 million), thanks to excellent content, an increased social media presence by our research committees and regional chapters, and another historic baseball season with multiple four-HR games, triple plays, and an exciting World Series that we provide historical context and interesting content for on a daily basis.

For the first time, SABR.org saw an average of more than 100,000 unique visitors per month over the calendar year, a 12.5% increase over our monthly average in 2016. In six different months, we surpassed 100,000 in unique visitors, the most times that has happened in a single year.

The 2016 responsive redesign of the website continues to pay dividends, as our share of mobile traffic comes close to surpassing 50%. Desktop visitors made up 53.93% of all traffic to SABR.org in 2017, with 37.4% on mobile devices and 8.7% on tablets.

Eleven of our top 25 single-day totals at SABR.org were recorded in 2017, led by an end-of-year 11,663 unique visitors — our second highest daily total ever — on December 27, following a viral post on Reddit.com of our new Ron Necciai biography. Necciai is the pitcher who struck out 27 batters in a minor-league game.

On social media, we surpassed 45,000 followers on Twitter in the spring of 2018 and our list of SABR members who are active on Twitter has grown to more than 640. The SABR Facebook page also includes more than 9,200 followers.

**Oral History Collection**: The launch of the Oral History Collection website at oralhistory.sabr.org in the spring of 2018 has been a rousing success. From Carl Hubbell to Cool Papa Bell, Johnny Vander Meer to Harvey Haddix, the SABR Oral History Collection includes interviews with some of the most memorable players in baseball history. The SABR Oral History Collection includes more than 500 audio files of interviews conducted with ballplayers (Major Leagues, Minor Leagues, Negro Leagues, AAGPBL), executives, scouts, authors, writers, broadcasters, and other figures of historical baseball.

These interviews, some of which date back more than 50 years, were conducted by members of SABR's Oral History Research Committee and many were digitized through a collaboration with the National Baseball Hall of Fame Library.

The SABR collection not only includes interviews with prominent players such as Frank Robinson and Yogi Berra, but also special sessions from SABR events, such as Buck O'Neil's inspiring talk during the 1996 SABR Convention in Kansas City, a Seattle Pilots panel with Jim Bouton during SABR 36 in Seattle, and Hall of Fame manager Tony La Russa's one-on-one interview at the 2015 SABR Analytics Conference. We're also proud to make available some interviews conducted by longtime SABR member and former Major League Baseball commissioner Fay Vincent from his series of oral history books, We Would Have Played for Nothing, The Only Game in Town, and It's What's Inside the Lines That Counts.

Founded in 1986, the SABR Oral History Committee has recorded lengthy interviews with well-known and lesser-known players, helping to preserve the historical record and to provide for recollections of baseball history which exist in no other place.

#### **SABR Events**

SABR 47: A record attendance of 806 SABR members and guests gathered in the heart of New York City for a memorable convention week. The week featured top speakers, research presentations, committee meetings, our annual Ross Adell Welcome Reception, an Awards Reception, the Donors Breakfast, Annual

Business Meeting, and a memorable Trivia Contest.

Former major-league pitcher Jim Bouton joined us to talk about the legacy of *Ball Four* and his baseball career in an emotionally resonant panel that included his good friend and moderator John Thorn, his wife Paula Kurman, and authors Mark Armour, Mitchell Nathanson, and Marty Appel. A panel focused on beloved Yankees great Yogi Berra included his granddaughter Lindsay Berra, former Yogi Berra Museum Director Dave Kaplan, and authors George Vecsey and Harvey Araton. We celebrated Jackie Robinson's legacy 70 years after his historic MLB debut with a panel that included authors William C. Rhoden and Lee Lowenfish, Jackie Robinson Foundation CEO Della Britton Barza, and new Bob Davids Award recipient Larry Lester. MLB Network's Brian Kenny moderated a panel on the Changing State of Sabermetrics with Mark DeRosa, Vince Gennaro, Joel Sherman, and Mike Petriello.

The namesake of our NYC chapter, Casey Stengel, was the focus for a panel with Marty Appel, Ira Berkow, Steve Jacobson and Ed Randall. Our "Day at the Ballpark" at Citi Field featured NY Mets GM Sandy Alderson, first-base coach Tom Goodwin, broadcasters Josh Lewin, Wayne Randazzo, and Steve Gelbs, and an analytics panel with T.J. Barra, Joe Lefkowitz, and Par Roessler. Guest speakers at SABR 47 also included broadcaster Keith Olbermann at the Baseball Cards Committee meeting, New York Yankees Sr. Vice President Jean Afterman in a one-on-one interview with Spink Award winner Claire Smith, David Neft at the Baseball Records Committee meeting, award-winning authors Peter Bjarkman and Glenn Stout, and oral history interviews with Tom Villante and Strat-O-Matic founder Hal Richman.

SABR Analytics Conference: The seventh annual SABR Analytics Conference — held during spring training in Phoenix—attracted more than 475 attendees, including representatives from 26 major-league teams. It was once again a major success for SABR members, potential SABR members, industry insiders, and the many college students who participated in the Diamond Dollars Case Competition. The conference featured leading speakers from MLB teams, major media outlets and baseball organizations, top panels and innovative research presentations. The conference kicked off with a welcome from SABR President of the Board of Directors Vince Gennaro and SABR CEO Marc Appleman. The speakers included Brian Kenny of MLB Network, Jon Sciambi and Eduardo Perez of ESPN, Mike Ferrin of MLB Network Radio, Eno Sarris from The Athletic, Amiel Sawdaye of the Diamondbacks, Chris Getz from the White Sox, Andy McKay from the Mariners, and former Cy Young winner Eric Gagne. Tom Tango, Daren Willman and Mike Petriello from MLB Advanced Media gave a presentation on Statcast and Bill Squadron of Genius Sports spoke about Global Sports Betting and the Role of Integrity Technology. The Diverse Perspectives Panel featured Dr. Lorena Martin of the Mariners and Ehsan Bokhar, Philip Cho and Emilee Fragapane of the Dodgers. The Technology Panel featured Jeremy Booth, Matt Reiland, Jarett Sims and former MLB outfielder Chris Dickerson. Sabermetic pioneer Pete Palmer was honored with the second SABR Analytics Conference Lifetime Achievement Award, which was presented by John Thorn.

**2017 Jerry Malloy Negro League Conference**: The 20th annual Jerry Malloy Negro League Conference, presented by the Negro Leagues Committee of SABR, was held July 27-30 in Harrisburg, Pennsylvania. The opening day of "150 Years of Black Baseball in Harrisburg" featured the Herbert "Rap" Dixon site tour of historic sites relating to the great right fielder. The tour included stops at the following sites: Oscar Charleston's home, Rap Dixon's home, the First Baptist Church, the Hygienic School for Colored Youth Site, Cottage Hill Field, the Rap Dixon dugout at Riech Little League Field and the historic Midland Cemetery. The conference was put on by Larry Lester (SABR's Negro Leagues Committee Chairman), Leslie Heaphy and Ted Knorr, the Harrisburg site coordinator. The conference featured excellent research presentations, panels and the always special Awards Banquet.

**SABR Arizona Fall League Experience**: The ninth annual SABR AFL Experience was held November 2-4, 2017, in Scottsdale, Arizona. It featured three AFL games at three different ballparks, including the Fall Stars Game, an evening at Scottsdale Stadium and dinner at Don and Charlie's. Speakers included AFL President Steve Cobb, Major League veteran Del Unser and former Cubs GM Ed Lynch, former MLB pitcher and author John D'Acquisto, former MLB catcher Terry Kennedy, MLB player agent and attorney Jeff Borris, Sr. Advisor for Baseball Operations for the Giants Tony Siegle, baseball historian and author Charlie Vascellaro, and sportswriter and Hemond-Delhi Chapter President Barry Bloom. A highlight of the conference was having longtime baseball executive and SABR member Roland Hemond at dinner at Don and Charlie's.

Frederick-Ivor Campbell 19th Century Base Ball Conference: The ninth annual conference was held April 21-22, 2017, at the Baseball Hall of Fame in

Cooperstown, New York. Conference highlights included a keynote address from baseball historian Bill Lamb, along with a panel discussion on SABR's Overlooked 19th Century Base Ball Legends Project with Adam Darowski, Michael Haupert, Joe Williams, and moderator John Thorn; a special presentation of the documentary film "Town Teams: Bigger Than Baseball" by Dorothy Seymour Mills and Mark Honer; a Member Spotlight interview of Joanne Hulbert by Tom Simon; plus book signings, research presentations, and a welcome dinner.

**SABR Seymour Medal**: This award was presented at the Seymour Medal Banquet at the NINE Spring Training Conference held in Phoenix in March. The recipient of the 2018 award was Jerald Podair, author of *City of Dreams: Dodger Stadium and the Birth of Modern Los Angeles*. The award honors the best book of baseball history or biography published in the preceding calendar year.

**SABR Day** on January 27, 2018 featured more than 50 events around the country and the world, including events in Canada, the Dominican Republic, Puerto Rico, Taiwan and Tokyo. SABR Day is held on the Saturday between the NFL championship games and the Super Bowl.

Some highlights include:

• While the Boston chapter and more than 100 people were listening to Red Sox historian Gordon Edes and former reliever Craig Breslow at Fenway Park, their rookie manager Alex Cora was in Puerto Rico talking to the Orlando Cepeda Chapter about his new job and working for the Puerto Rican national team.

• Tim Kurkjian of ESPN, documentarian Ken Mars and SABR Vice President Leslie Heaphy spoke at the Babe Ruth Chapter's meeting in Baltimore.

- Two new chapters in New Jersey the Goose Goslin Chapter in Cherry Hill and the Elysian Fields Chapter in Hoboken conducted their inaugural SABR Day meetings.
- Dan Evans, former MLB General Manager and the Director of Pacific Rim Operations for the Toronto Blue Jays, spoke to the Rocky Mountain Chapter in Denver.
- Former MLB player and manager Dusty Baker spoke at the Sacramento's SABR Day event. The chapter was recently renamed in his honor.

• Other guest speakers at SABR Day events included: Minnesota Twins catcher Mitch Garver (Albuquerque), International League President Randy Mobley (Rochester), Miami Herald writer Clark Spencer (Ft. Lauderdale), former Seattle Pilots draftee Jerry Bell and Harriet Kimbro-Hamilton — the daughter of Negro Leaguer Henry Kimbro — (Nashville), broadcaster Marty Lurie, and writers Barry Bloom and Tony DeMarco (Phoenix), Florida State University baseball director of operations Chip Baker (Tallahassee), authors Doug Feldmann and Ed Wheatley (St. Louis), Andy McCue and Fred Rodgers (San Diego) and Brian Engelhardt and Eliza Richardson (Pittsburgh).

**Behind the Numbers: Baseball SABR Style**: This weekly baseball analytics show completed its third year on SiriusXM. The one-hour show airs on MLB Network Radio and is available to subscribers nationwide on XM Channel 89, Sirius Channel 209 and on the SiriusXM Internet Radio app. The show is hosted by SABR President Vince Gennaro and focuses on examining and interpreting the statistical analysis that plays a critical role in baseball today. The show features guests from MLB teams, the media, and members of SABR.

SABR's Data Program: Under the direction of Sean Lahman, who heads up SABR's data program, and the many volunteers who work with Sean, it was another strong year.

Highlights from the past year include:

- Maintenance and updates to SABR's player register
- Continued work on Minor Leagues Database, with a focus on early leagues
- Support for the Minor Leagues ballparks project
- Working with the College Committee and Nineteenth Century Committee on digitizing datasets and source materials.

- Improvements and updates to the Home Run Log, Triple Plays Database, no-hitters, and similar collections.
- Support for TSN card project.
- Review and update of master SABR data archive

The success of SABR would not be possible without our members that make this a tremendous organization, the Board of Directors, our consultants, the excellent interns from the Walter Cronkite School of Journalism and Mass Communication at Arizona State University, and of course, our terrific staff in Phoenix. Highlights of SABR 47 included featured speakers, Jim Bouton, Keith Olbermann, William C. Rhoden, Claire Smith, Lindsay Berra, and an afternoon at Citi Field, where New York Mets General Manager Sandy Alderson spoke. SABR47 also had a record attendance of 806.

# **SABR Awards**

SABR respects and values the contributions of individuals who have added to the historical record of the game. Every year, baseball writers and researchers add to our knowledge and understanding of baseball with quality scholarship in the form of books, articles, and a wide variety of other media. SABR presents four annual awards for specific research accomplishments among its six annual awards and two discretionary awards. The individuals and projects that follow are an example for current and future baseball researchers to follow as they expand our knowledge of baseball and achieve their own recognition for baseball scholarship.

#### BOB DAVIDS AWARD

The Bob Davids Award, first awarded in 1985, honors a SABR member of long standing (excepting paid member employees of SABR) who reflects the ingenuity, integrity, and self-sacrifice of the founder of SABR and who makes a significant contribution to the Society in such areas as administrative responsibility, original research, information exchange, or other voluntary and cooperative efforts in the best interests of baseball. It is considered to be SABR's highest honor.

▲ The 2017 Bob Davids Award recipient is Larry Lester.

#### HENRY CHADWICK AWARD

The Henry Chadwick Award was established in November 2009 to honor baseball's great researchers—historians, statisticians, annalists, and archivists—for their invaluable contributions to making baseball the game that links America's present with its past.

Apart from honoring individuals for the length and breadth of their contribution to the study and enjoyment of baseball, the Chadwick Award will educate the baseball community about sometimes little known but vastly important contributions from the game's past and thus encourage the next generation of researchers.

The contributions of nominees must have had public impact. This may be demonstrated by publication of research in any of a variety of formats: books, magazine articles, websites, etc. The compilation of a significant database or archive that has facilitated the published research of others will also be considered in the realm of public impact.

A The 2018 recipients of the Henry Chadwick Award are: Jefferson Burdick, Bob McConnell, Tom Shieber, Andrew Zimbalist.

#### DOUG PAPPAS RESEARCH AWARDS (first awarded 1993; as John Cox Award 1990-92)

The Doug Pappas Award honors the best research presentation at the annual National Convention with a cash prize and a matching amount donated to SABR. One winner will be selected at each convention, and finalists will be named at the discretion of the award committee. It was renamed the Doug Pappas Award in 2004 after the tragic death of the 2000 winner, Doug Pappas.

The award winners at SABR 47 were:

- ▲ Oral presentation: "Does Changing Leagues affect player performance and how?" by Chuck Hildebrandt.
- A Poster presentation: "The Evolution of the Baseball Catcher's Mitt, 1888-2015" by Richard Macaluso.

#### SEYMOUR MEDAL (first awarded in 1996)

The Seymour Medal recognizes the author(s) of the best book of baseball history or biography first published during the preceding calendar year. The award was named in honor of baseball historians Harold Seymour and Dorothy Seymour Mills. To be considered for the medal, a work must be the product of original research or analysis. The winning book shall significantly advance our knowledge of baseball and shall be characterized by understanding, factual accuracy, profound insight and distinguished writing. "History," for the purposes of determining the eligibility of a book for Seymour Medal consideration, is understood as analytical nonfiction narrative. "Biography" is the history of a person or persons. No more than one Seymour Medal shall be given each year. If, in the judgment of the award committee, a worthy candidate cannot be found, the medal shall not be awarded.

▲ The 2018 Seymour Medal is awarded to *City of Dreams, Dodger Stadium and the Birth of Modern Los Angeles*, by Jerald Podair (Princeton University Press).

#### MCFARLAND-SABR BASEBALL RESEARCH AWARD (awarded 1987-2000 as the Macmillan-SABR Baseball Research Award)

The McFarland-SABR Baseball Research Award honors the author(s) of the best articles or papers, published or unpublished, on baseball history or biography completed during the preceding calendar year. Eligible works will include magazine and journal articles, previously unpublished chapters or articles in anthologies or other books with multiple authors, unpublished research papers and written versions of oral presentations. Authors honored for unpublished work may not later receive a SABR research award for that work (or work that is substantially the same) in published form.

The 2018 McFarland-SABR Baseball Research Award winners are:

- ▲ Warren Corbett, The 'Strike Against Jackie Robinson, BRJ Spring 2017 (SABR).
- Doron "Duke" Goldman, 1933-1962: The Business Meetings of the Negro Leagues, Baseball's Business The Winter Meetings, Volume 2, 1958-2016 (SABR).

#### SABR BASEBALL RESEARCH AWARDS (first awarded in 1995)

The SABR Baseball Research Award, formerly known as the *Sporting News*-SABR Baseball Research Award, honors those individuals whose outstanding research projects completed during the preceding calendar year have significantly expanded our knowledge or understanding of baseball. Eligible projects must be the product of original research or analysis and must significantly advance our knowledge of baseball. They must be characterized by factual accuracy and notable insight. Eligible projects will include, but not necessarily be limited to, research in statistics, statistical analysis and statistical compilation, and research in such diverse areas as advertising, architecture, bibliography, collectibles, economics, equipment, labor relations, sociology and technology. Research project may be of any length and, if published, may be published separately or as part of a larger work. Researchers honored for unpublished work may not later receive a SABR research award for that work (or work that is substantially the same) in published form.

- \* Steve Steinberg, Urban Shocker, Silent Hero of Baseball's Golden Age (University of Nebraska Press)
- ▲ William A. Young, J.L. Wilkinson and the Kansas City Monarchs, Trailblazers in Black Baseball (McFarland Press)

#### RON GABRIEL AWARD (first awarded in 2012)

The Ron Gabriel Award honors the author(s) of the best research, published or unpublished, on the subject of the Brooklyn Dodgers completed during the preceding calendar year. Eligible works include but are not limited to magazine and journal articles, previously unpublished chapters or articles in anthologies or other books with multiple authors, unpublished research papers, written versions of oral presentations, books, databases and websites. If the committee is unable to find a suitable award candidate, the prize money will be awarded to support the permanent exhibit on the Dodgers at the Brooklyn Historical Society. Ron Gabriel (1941-2009), a native of Brooklyn, New York, and longtime resident of Bethesda, Maryland, was a former Vice President of SABR and instrumental in establishing the Bob Davids Chapter, which serves the Washington-Baltimore region. He was founder and president of the Brooklyn Dodger Fan Club, and a charter elected member of the Brooklyn Dodger Hall of Fame. Gabriel, who earned his Ph.D. in Human Resource Management from American University, was a retired U.S. Government executive, having served with the Postal Service Management Institute, the Department of Defense and the General Services Administration.

#### THE JACK KAVANAGH MEMORIAL YOUTH BASEBALL RESEARCH AWARD (first awarded 2000)

The Jack Kavanagh Memorial Youth Baseball Research Award was established in 1999 by the Society for American Baseball Research (SABR) in recognition of Kavanagh's writing and research achievements and his contributions to SABR. The Award is supported with funding from Diamond Communications and was presented for the first time at the SABR National Convention in West Palm Beach, Florida in June 2000. The Kavanagh Award may be presented each year for either a research presentation given at the SABR National Convention (papers must accompany any oral presentation), or for a research paper that is submitted to the awards committee between the end of one SABR Convention and no later than June 1 of the following year by a researcher in grades 6-8 (middle school category), grades 9-12 (high school category), or undergraduates 22 and under (College Category). The awards committee will consist of members appointed each year by the education committee chair. The winner will receive a plaque honoring this achievement and the following, according to his/her category: College (\$200 prize, plus 1-year membership) High School (\$200 prize, plus 1-year membership) Middle School (\$100 prize, plus 2-year membership)

## Treasurer's 2018 Mid-Year Report

I am honored to continue serving as the society's treasurer and look forward to serving the Society for at least the next two years if not longer. The Society is in sound financial condition and well positioned to take on transformative projects to perpetuate SABR into the future. Much like FY 2016, FY 2017 notable items were the increase in events revenue, the increase in payroll as our additional staffer devoted to chapter enhancement was active all year, and small but distinct reductions in dues and licensing revenue. Altogether we ran a smaller deficit than in 2016, about 8 thousand instead of 24 thousand.

So while it is true that we've established a new equilibrium, and I'm not particularly concerned about running a deficit of this magnitude, this is one of the reasons why the board has started to take a fresh look at our organization's long term strategy – an entirely predictable outcome after our 7 year turnaround effort has reached fruition.

Turning to the Balance Sheet, we see that our assets are back up to 2015 levels but this is largely due to timing differences on when we recognized certain event revenues and expenses. The Balance Sheet shows that when all is said and done we have \$400,000 plus that we can draw on for special projects or emergencies. Our permanently restricted funds, or endowment, at \$132K, is not large enough to generate meaningful income and I regard it as more of an emergency source of funds.

## Philanthropy

SABR began an annual campaign to solicit donations from members during the 1993-1994 renewal drive. That first campaign raised just over \$5,000. Every subsequent year has seen members and friends continue to support SABR through their time and donations. From June 1, 2017 through June 1, 2018, SABR donations are in excess of \$89,000, including more than \$63,000 in unrestricted giving. It is the tenth consecutive \$50,000+ year, and counts more than 500 individual donors to date.

## History

The Society for American Baseball Research has come a long way since 16 individuals met around two tables at the National Baseball Library in Cooperstown, New York, on August 10, 1971. SABR has grown to nearly 6,000 members and added research committees, regional groups, and a variety of other membership services. Once "SABR Who?" was a familiar question. Today, nearly all baseball publications make some reference to SABR or SABR members. Professional baseball executives and media are well aware of the collective expertise and talents of SABR members. Slowly, but surely, more and more general baseball fans are learning about SABR.

SABR was the brainchild of L. Robert "Bob" Davids of Washington DC. For many years, starting in 1951, he contributed freelance articles to *The Sporting News*. When *The Sporting News* discontinued statistical-history types of articles in the mid-1960s, Davids sought another outlet for his avocations and launched a four-page newsletter, "Baseball Briefs." The initial response to the publication spawned the idea of forming an organization of researchers, and in March 1971, he sent letters to approximately 40 "statistorians" around the country asking for expression of interest in forming a research group. The 16 willing and able to meet in Cooperstown formulated the Society's objectives, its name and acronym. The essential constitutional objectives of SABR are to foster the study of baseball, stimulate interest in baseball, establish an accurate historical account of baseball and disseminate baseball information.
