RESOLUTION NO. 1094-1

RESOLVED by the Santa Clara County Board of Education, County of Santa Clara, State of California, that:

WHEREAS, pursuant to the procedures set forth in Education Code section 47605.6 and its implementing regulations, on January 19, 2005, the County Board of Education approved the charter for Pathfinder High School Charter School for a period of three operational school years, from July 1, 2005 through June 30, 2008; and

WHEREAS, on January 11, 2007 the board of directors of Pathfinder High School Charter School voted to close the school effective January 31, 2007, and on January 31, 2007 the school closed and ceased to operate, and has remained closed since that date; and

WHEREAS, the Santa Clara County Office of Education has taken custody of the student records and personnel records from the school, and has ensured appropriate educational placements for the students from the school;

NOW, THEREFORE, the County Board of Education does hereby REVOKE the charter of Pathfinder High School Charter School, effective March 1, 2007.
