THE OKLAHOMA INDIAN AFFAIRS COMMISSION

The **Oklahoma Indian Affairs Commission (OIAC)** is in its 44th year of existence as an agency of the State government of Oklahoma. The Commission's statutory mission is to serve as the liaison between the State of Oklahoma and Oklahoma's American Indian Nations (74 O.S. § 1201).

The Commission is governed by a Board of Commissioners, comprised of nine tribal members appointed by the Governor with consent of the Senate. The OIAC is also served by 11 Ex Officio members representing various state agencies as well as elected officials. A maximum 15-member Advisory Committee also assists the Commission in its short and long-range planning.
