I am delighted to present to you our new catalog in Sociology and Anthropology, bigger and, I dare say, better than ever. Fortunately, so far we have not been adversely affected by the economic crisis, from which so many trade publishers are suffering. We have stuck by our scholarly guns and deepened rather than broadened our core lists. It is gratifying to see how anthropology continues to impact other areas of the humanities and social sciences (political scientists, for instance, now draw more on ethnography than ever before), just as anthropology has benefited from opening up to other disciplines. This is not without problems for a discipline that has always had a tendency to question its character, goals, and ethics, possibly more so than other disciplines. Several new titles in the section "Theory and Methodology" illustrate this "self-reflexivity." On the other hand, it is remarkable to what degree anthropologists are involved, practically or scholarly, in the non-academic world, as reflected in applied and public anthropology (a combination of the terms preferred by British, respectively American anthropologists), medical/biological, political, environmental or refugee studies - all fields showing strong growth, as confirmed by our many new titles in these areas. More recently the study of space and movement within and between spaces has attracted more interest and has been added to our program in form of a new list, including a new series. Even more noticeable, also in our growing list of related titles, is "the return of the religious" over the last decade, as Bruce Kapferer and his co-editors observe in their volume on this topic, causing some people to argue that "secularization itself now takes a religious form."

In order to keep up with innovative scholarship and sift through the bewildering mass of new research in this as well as other fields we are launching a new line of annuals in 2010: Advances in Research, with the first two volumes focusing on religious, resp. environmental studies in response to the growing need for a rigorous, critical review of current work in the social sciences and humanities. The intention is to stimulate advanced research from an interdisciplinary perspective. Moreover, we continue to expand our journals program, as its section shows, with new titles, such as *Asia Pacific World: The Journal of the International Association of Asia Pacific Studies*, offering a forum for this new association, as well as *Regions and Cohesion*, a multilingual journal published on behalf of the Consortium for Comparative Research on Regional Integration and Social Cohesion. Finally, we are very pleased to have our journals program recognized by the American Association of Publishers through the award for Best New Journal in the Humanities & Social Sciences two years in a row! For 2008 the award went to *Projections* and for 2009 to *Girlhood Studies*, which has also just been short-listed by the equally prestigious Association of Learned and Professional Society Publishers for their Best New Journal Award across all disciplines.

In Béarn, a region of south-west France, longstanding and resilient ideas of property and practices of inheritance control the destinies of those living in the foothills of the Pyrenees. First, sociological arguments about the family, proposed by Frédéric Le Play, shaped debates on social reform and the repair of national identity during the last third of the nineteenth century – and these debates would subsequently influence contemporary European thought and social policy. Second, these local ideas entered into late twentieth-century sociological categories through the influential work of Pierre Bourdieu.

## Volume 22 OUT OF THE STUDY AND INTO THE FIELD Ethnographic Theory and Practice in French Anthropology

Outside France, French anthropology is conventionally seen as being dominated by grand theory produced by writers who have done little or no fieldwork themselves, and who may not even count as anthropologists in terms of the institutional structures of French academia. This applies to figures from Durkheim to Derrida, Mauss to Foucault, though there are partial exceptions, such as Lévi-Strauss and Bourdieu. It has led to a contrast being made, especially perhaps in the Anglo-Saxon world, between French theory relying on rational inference, and British empiricism based on induction and generally skeptical of theory. It is this aspect of French anthropology that this collection addresses, in the belief that the neglect of many of these figures outside France is seriously distorting our view of the French tradition of anthropology overall.

war. It finds that although Slobodan Milosevic played a highly significant role, he was not always able to control the local Serb leaders. Moreover, it adds to the emerging evidence of the lack of importance of popular attitudes; hardline dominance was generally based on the control of economic and coercive resources rather than on elites successfully "playing the ethnic card." It moves beyond an assumption of automatic ethnic outbidding and thus contributes toward a better understanding of intra-ethnic rivalry in other cases such as Israel/Palestine, Northern Ireland, Nagorno-Karabakh and Rwanda.

The Ju/'hoan San, or Ju/'hoansi, of Namibia and Botswana are perhaps the most fully described indigenous people in all of anthropology. This is the story of how this group of former hunter-gatherers, speaking an exotic click language, formed a grassroots movement that led them to become a dynamic part of the new nation that grew from the ashes of apartheid South West Africa. While coverage of this group in the writings of Richard Lee, Lorna Marshall, Elizabeth Marshall Thomas, and films by John Marshall includes extensive information on their traditional ways of life, this book continues the story as it has unfolded since 1990. Peopled with accounts of and from contemporary Ju/'hoan people, the book gives newly-literate lu/'hoansi the chance to address the world with their own voices. From September 1990 to June 1991, the UK deployed 53,462 military personnel in the Gulf War.
