Nondualism and the Conduct of Sacrifice T. M. S. Evens, University of North Carolina at Chapel Hill

Taking its inspiration from the defining thesis of the Manchester School that all social orders exhibit basically conflicting underlying principles, this rich work mounts a radical assessment of the ontology of self and other in relation to dualism and nondualism. The author draws especially on Continental social thought, including Wittgenstein, Merleau-Ponty, Levinas, Dumont, Bourdieu and others, and on pre-modern sources such as the Hebrew bible, the Nuer, the Dinka, and the Azande and demonstrates how the self-other dichotomy disguises fundamental ambiguity or nondualism, thus obscuring the essentially ethical and sacrificial nature of all social life.

Anthropologists have been keenly aware of the tension between cultural relativism and absolute norms, and nowhere has this been more acute than with regards to moral values. Can we study the Other's morality without applying our own normative judgments? How do social anthropologists keep both the distance required by science and the empathy required for the analysis of lived experiences? The plurality of moralities has not received an explicit and focused attention until recently, when accelerated globalization often resulted in the collision of different value systems. Questions of the conduct of fieldwork, of ethnography and of ethics have preoccupied many anthropologists for some time now. In 1900, Sheffield was the tenth largest city in the world. Cutlery "made in Sheffield" was used across the globe, and the city built armored plate for the navy in the run-up to the First World War. Today, however, Sheffield's derelict Victorian shop floors and industrial buildings are hidden behind new leisure developments and shopping centers. Based on an extended period of research in two local steel factories, this book combines a lively, descriptive account with a wide-ranging critique of postindustrial capitalism. Its central argument is that recent government attempts to engineer Britain's transition to a post-industrial and classless society have instead created volatile post-industrial spaces. Personhood in Melanesia has been explored using concepts of dividuality, individuality, partibility, and degrees of permeability and autonomy, confirming Marilyn Strathern's argument that for "Melanesian persons" the distinction between "individual" and "society" is not relevant, which is also true for the concepts of "person" and place. However, the author argues that it is important to relate these concepts to their specific local historical context, taking account of Vanua Lavans' ongoing engagement with modernity, in particular with different forms of individualism. Engagement with Christian individualism, with a singular person's relationship to God, presupposes a moral "core self" that makes a person responsible for their own actions. Karnatik music was one of the most ancient and rigorous classical musical traditions of India. This study explores changes it underwent once it was relocated from traditional spaces of temples and salons to the public domain. Madras city, as patron and custodian of the performing arts, especially classical music, played a particularly important role in the transformation of Karnatik music in the 19th century, most noticeably affecting pedagogy or modes of musical transmission, performance conventions and criticism or music appreciation. Once the urban elite demanded the widening of the teaching of classical music, traditional modes of music instruction underwent a major change involving the tradition wherein the teacher imparted knowledge to a chosen few. Caste and kinship were important determining factors for the selection of these students, but in modern institutions like the universities these boundaries had to be demolished. 





By linking the experiences of immigrant families with the

increased reliance on cheap and flexible workers for care and domestic work in Southern Europe, this study documents the lived experiences of neglected actors of globalization - migrant women - as well as the transformations of Western families more generally.
