### Introducing the ICTR's Satellite Service – "ICTR by Satellite"

The International Criminal Tribunal for Rwanda is pleased to introduce its TV Satellite Service known as "ICTR by Satellite". This service provides ICTR-related information for professionals working in television and radio and for institutions and persons interested in the ICTR legal process.

As its name suggests, "ICTR by Satellite" is transmitted via satellite using a non-coded signal. This service is presently available in Africa, Europe, Asia and the Americas (see footprint).

ICTR offers live coverage from the Trial Courts, thematic raw footage and completed programmes related to the ICTR activities.

### Information available on "ICTR by Satellite"

### "ICTR by Satellite" will feature:

#### Live coverage in English and Kinyarwanda

- Live coverage of pre-trial and trial proceedings in each of the Trial Chambers
- Live coverage of pronouncement of judgments and sentences

#### Satellite uplink

• ICTR by satellite also offers to TV stations an uplink feed point for news related to the work of the ICTR.

#### On-Site Access

ICTR's Audiovisual Unit is offering (free of charge) the following facilities on site:

- DV Cam playouts (PAL)
   Note: uplink from NTSC is possible if you are carrying a transcoder NTSC-PAL.

  Playouts from your DVC Pro or Beta SX are also possible.
- Stand-up position (the ICTR building is the backdrop to the shot)
- Live signal of court hearings
- Copies from court sittings on DV Cam
- Access to photographs from the ICTR library collection.
