Illiperease, With approximately 8,000 acres of agricultural production, Limoneira is one of the largest providers of lemons and avocados in the United States, and as an environmentally responsible corporate citizen, the company has used IPM as part of its whole farm sustainability initiative for several decades; and

Limoneira's IPM program includes pest scouting and monitoring; planting pest-resistant citrus and avocado varieties; raising beneficial insects; using mulch to suppress weeds and insects that lay eggs in soil; skirt pruning to control snails and brown rot; applying softer pesticides; planting native vegetation to keep dust down; and practicing water management to reduce incidence of fungal diseases; and

Thereas, Limoneira has also partnered with Agromin to convert green waste into mulch and compost that are used in its orchards and in the community, and as the owner of several area developments, the company has included landscape and structural IPM strategies in its plans for new developments in Santa Paula and throughout Ventura County; and
