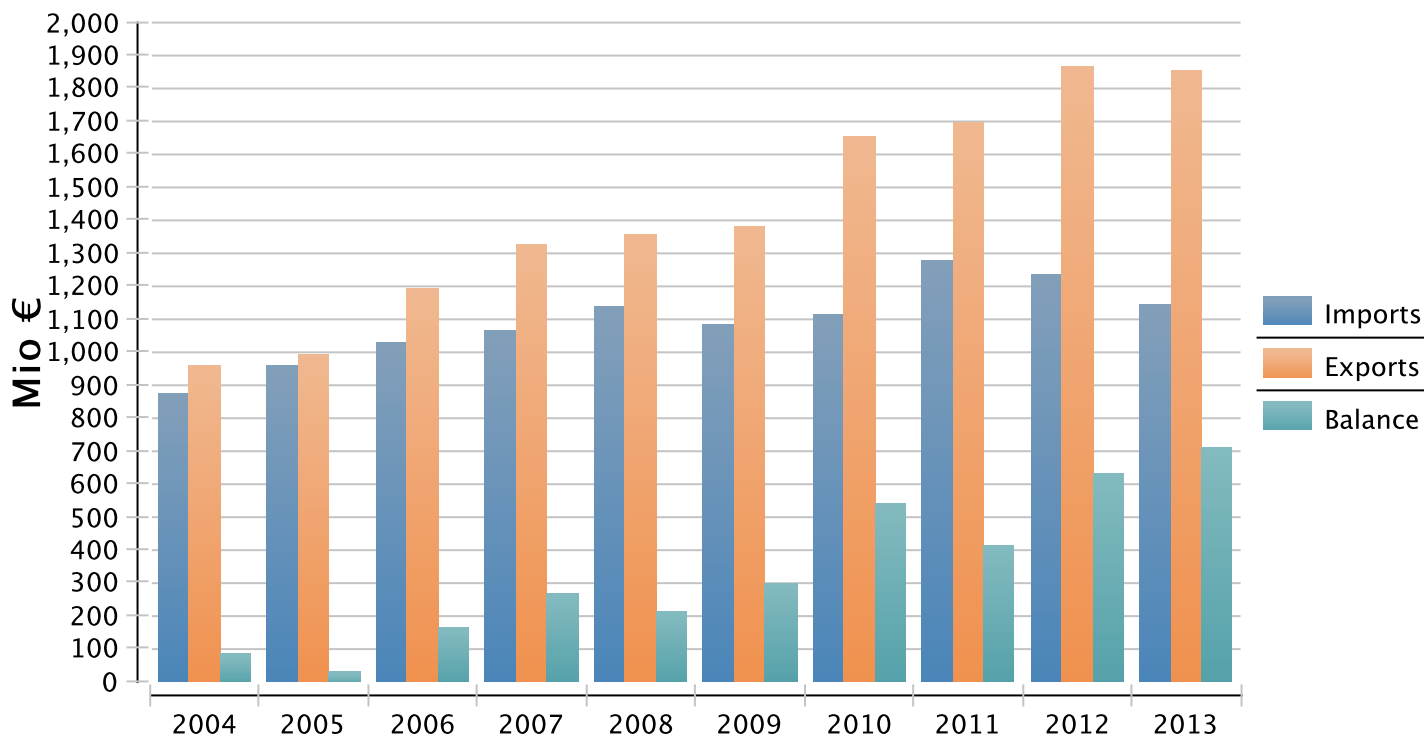

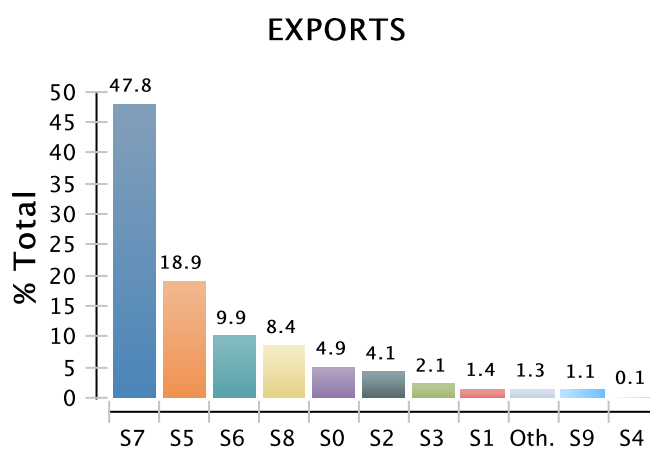
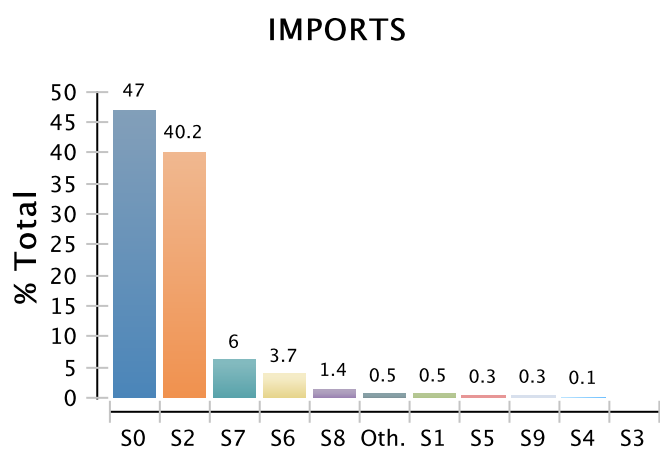
### Total goods: EU Trade flows and balance, annual data 2004 - 2013
