BRILL OPEN CONSENT TO PUBLISH

JOURNAL TITLE

2. The Author understands and fully endorses that the Publisher will publish the Article in its open access service Brill Open under a [Creative Commons Attribution-NonCommercial 3.0 Unported License](#) (CC-BY-NC-ND) permitting all users:
 - The unlimited right of unpaid access to the full text of the Article;
 - The unlimited right to copy, paste, download the full Article in its original form as long as these uses are restricted to non-commercial and non-derivative use only and provided that due acknowledgement is made to the original Author and the original publication in the Journal. For the purpose of this agreement the use of the Article in a Virtual Learning Environment (VLE) or a course-pack, shall be considered non-commercial.
3. The Author retains the right to post or deposit the Article in a subject or institutional repository, including that of or designated by the research funding body that (co)financed his/her research, as long as the posting or depositing of the Article serves no commercial goal. The author ensures that the Journal and the Publisher are properly credited.
4. The Author retains the right to publish the Article in a volume of his own work.

The Author will indemnify the Publisher for, and hold the Publisher harmless from any loss, expense or damage occasioned by, any claim or suit by a third party for copyright infringement or arising out of any breach of the foregoing warranties as a result of publication of the Article. The Article shall be delivered to the Publisher free of copyright charges.
7. The Author guarantees that the Article to the Journal has not been previously published elsewhere, or that if it has been published in whole or in part, any permission necessary to publish it in the Journal has been obtained and provided to the Publisher together with a statement of the original copyright notice.
8. The Author declares that any person named as co-author of the Article is aware of the fact and has agreed to being so named.
9. The Publisher shall have the right to protect the Article against unauthorized use and to authorize dissemination by means of off prints, legitimate photocopies, microform editions, reprints, translations, and secondary information sources such as abstracting and indexing services including data bases.
