



In Nomads in the Shadows of Empires Gufu Oba presents accounts of why the legacies of banditry and ethnic conflicts have proved so difficult to resolve along the southern Ethiopian and northern Kenyan frontier. 

The apartheid state employed many weapons against its opponents: imprisonment, banning, detention, assassination – and banishment. 
