World War II Era Records of the World Council of Churches

The documents in this collection form a subset of the World Council of Churches archives dating from 1932 to 1957. They were assembled hurriedly and in a very provisional form during the "dark days" of the war by an administration just being born and still in the making. Under such chaotic conditions, some elements were inevitably lost and the original order of the records was difficult to reconstruct. Yet a dramatic story is revealed here, the story of the fledgling ecumenical movement's thought, policy, and activities in the face of the power of Nazi Germany. During the Second World War, the World Council of Churches in Process of Formation was instrumental in smuggling several hundred Jews across the borders into Switzerland, actively helped by courageous and inventive young French workers affiliated with CIMADE (Comité Inter-Movement Auprès Des Evacués). Reflecting on this era, Dr. W. A. Visser 't Hooft, then General Secretary of the World Council of Churches, wrote "... as I look back on these attempts to help the Jews during the war years, I feel far from proud. I know that I should have done a great deal more." Not all the sources testifying to this period have been preserved, but what remains is gathered in this collection.
