WHAT TO EXPECT IN FARGO–MOORHEAD

Lying on opposite banks of the Red River of the North is Fargo-Moorhead, a twin-city community that offers an aesthetic and progressive environment unique to cities of its size. The metropolitan area reaches surrounding communities in western Minnesota and eastern North Dakota for a total population of over 233,000,¹ the largest metropolitan area between Minneapolis and Spokane, WA.

With a thriving economy and diverse culture, Fargo-Moorhead hosts three major universities, advanced health care facilities, exceptional parks and recreational facilities, extensive youth sports activities, a symphony, museums, a ballet company, and live theatre groups.

Things to Do

Multiple art galleries, yoga studios, and coffee shops pepper the award-winning, revitalized downtown area, while sprawling parks and golf courses offer an escape into the prairie landscape for which the area is known.

Several community events occur annually, like the Fargo Film Festival, Fargo Marathon, Red River Valley Fair, RibFest, Cruisn'Broadway, RiverArts, Downtown Street Fair, Red River Valley Sportsman's Show, Streets Alive, and Holiday Lights Parade. An active community offers many cross-promotional opportunities with other concerts and events coming to the area.

Scheels Arena is also home to the USHL's Fargo Force hockey team. It will also play home to the 2018 Olympic curling nationals.

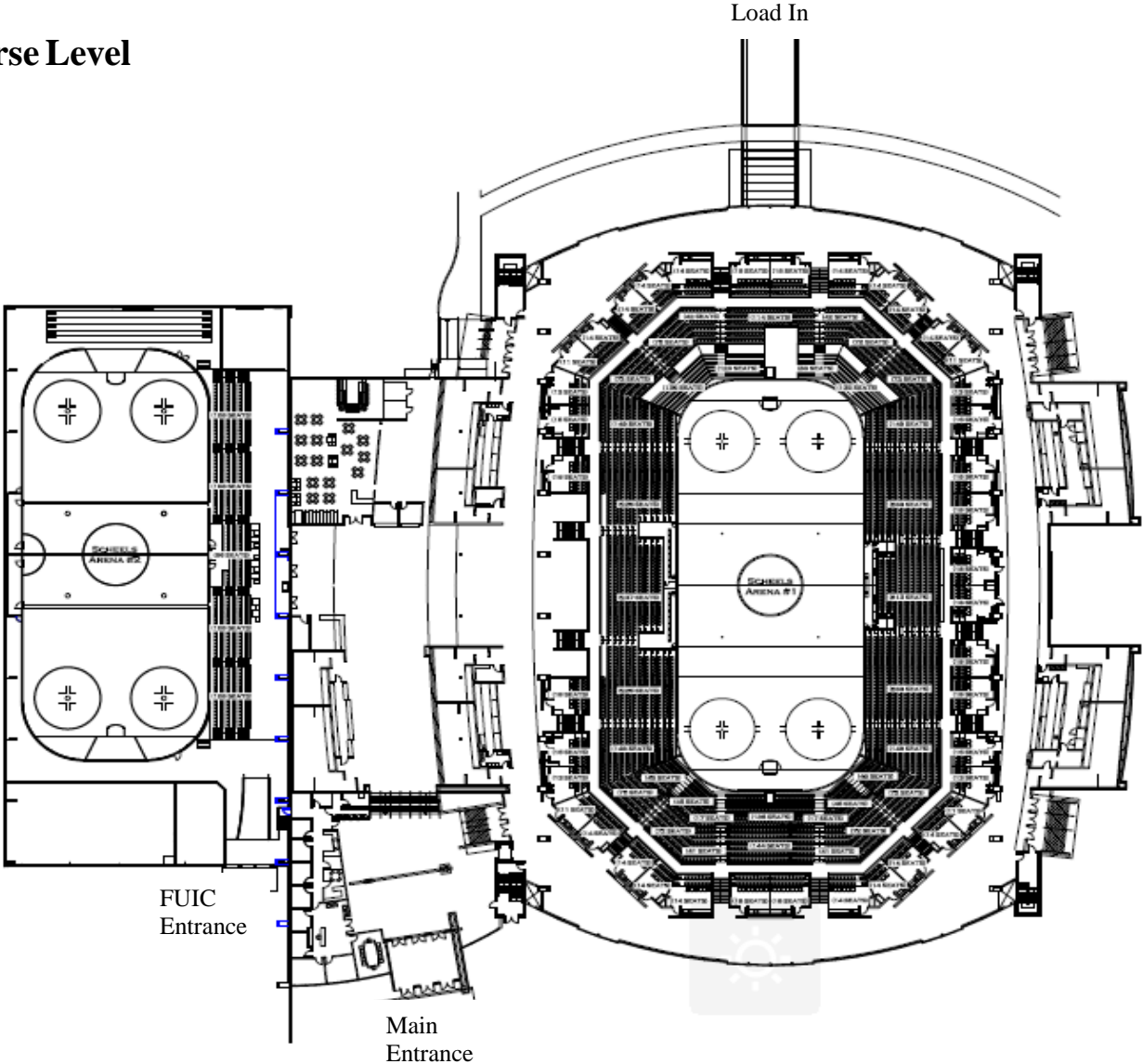

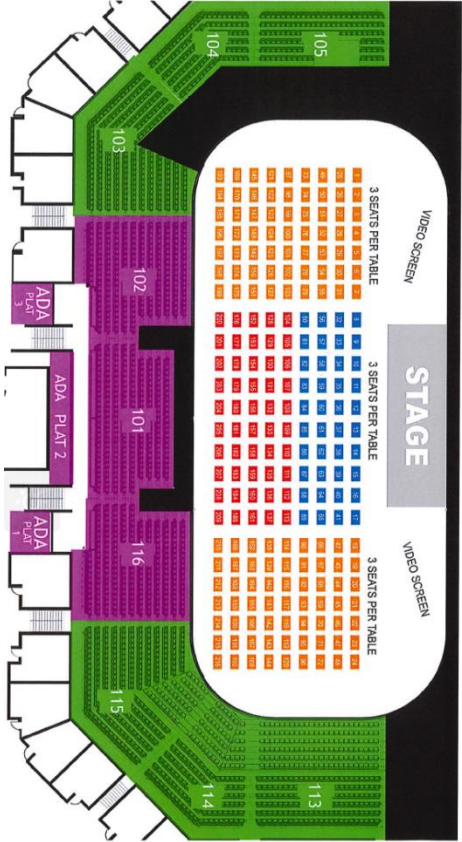
End Stage Reserved Seating

SEATING CAPACITIES

Scheels Arena can host up to 6,000 fans for concerts, and 5,000 – 6,000 for sporting events like hockey, basketball, and wrestling.

Standing Room Only Floor

Standing Room Only (SRO) floor size fluctuates based on size of stage. With a 60' wide x 40' deep stage, the arena can accommodate up to 5,433 SRO guests and offer the following seating options:

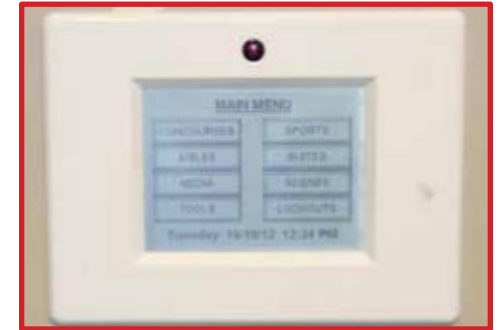
Audio System

Scheels Arena's sound system uses a combination of QSC and innovox speakers throughout the concourses and over the surface, allowing for 100 dB to all seats and 100% building coverage.

The sound system is equipped with 2 hard-wired microphones, 2 wireless microphones, 16 channel audio mixer, audio XLR and video connections (SDI & Triax) on media deck, truck dock, penalty box, and production room.

House Lighting

- Florescent lighting situated above arena bowl provides instant lighting and black-out conditions. Fluorescents rate at 600 lux.
- Sport lighting around main arena ensures maximum lighting exposure and increases lighting to 1500 lux.
- An 8-minute time period is required for sport lighting to hit full capacity once on.



Video Production

Scheels Arena is equipped with a Panasonic video system with 10' x 18' jumbotrons on the north and south ends of ice area, 2' x 190' fascia ring, and two smaller fascia rings 2' X 160'.

The system feeds live video to all televisions in the building with an in-house channel (Channel 94 or HD channel 120-1). The system has the ability to interface with outside equipment.

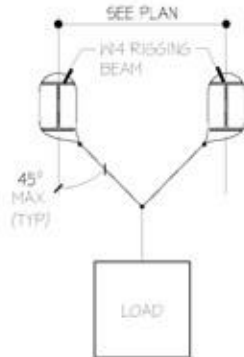
