## Annual report of the Joint Implementation Supervisory Committee to the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol

### Summary

This report covers the work carried out by the Joint Implementation Supervisory Committee from 18 September 2019 to 16 October 2020. During the reporting period, the Committee maintained the necessary infrastructure for the operation of joint implementation and prudently managed its resources as requested by the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol.

#### I. Introduction

#### A. Mandate

- 1. CMP 1 established<sup>1</sup> the JISC to supervise, inter alia, the verification of emission reductions or removal enhancements generated by projects under Article 6 of the Kyoto Protocol (JI projects) in accordance with the guidelines for the implementation of Article 6 of the Kyoto Protocol (JI guidelines).<sup>2</sup>
- 2. In accordance with paragraph 3(a) of the JI guidelines, the JISC is required to report on its activities to each session of the CMP. The CMP provides guidance regarding the implementation of Article 6 of the Kyoto Protocol and exercises authority over the JISC.

#### B. Scope

- 3. This annual report of the JISC to the CMP covers JI activities carried out between 18 September 2019 and 16 October 2020 (hereinafter referred to as the reporting period), including its responsibilities relating to the operation of the verification procedure under the JISC (hereinafter referred to as JI Track 2)<sup>3</sup> and the financial status of the JI mechanism.
- 4. Full details of the operation and functions of the JISC are available on the JI web pages of the UNFCCC website, which are the central repository for reports on meetings of the JISC; information on JI projects, programmes of activities and accreditation; and documents adopted by the JISC.<sup>4</sup>

# C. Possible action by the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol

- 5. The CMP may wish to review this annual report and provide guidance regarding the operations of JI.
- 6. In accordance with paragraphs 4–5 of the JI guidelines, the CMP is to elect JISC members for a term of two years, upon receipt of nominations from Parties, as follows:
- (a) Two members and two alternate members from Parties included in Annex I with economies in transition;
- (b) Two members and two alternate members from Parties included in Annex I that do not have economies in transition(a) above;
  - (c) One member and one alternate member from Parties not included in Annex I.

## II. Doha Amendment

7. The JISC recognizes with great pleasure that the Depositary received the necessary number of ratifications by Parties to the Kyoto Protocol to ensure the entry into legal force of the Doha Amendment to the Kyoto Protocol (by which the second commitment period was agreed)<sup>5</sup> before the expiry of that commitment period on 31 December 2020. The JISC recognizes the importance of the Doha Amendment to the implementation of pre-2020 ambition under the UNFCCC.

## III. Work undertaken in the reporting period

# A. Ensuring cost-effective and transparent functioning of joint implementation

- 8. CMP 15 did not give the JISC any new mandates.
- 9. The JISC maintained operations in accordance with its two-year management plan for 2020–2021<sup>6</sup> by maintaining the infrastructure and capacity to support JI operations, as needed, and by monitoring the intergovernmental negotiation process and creating opportunities to provide further information and recommendations from the lessons learned from JI, as appropriate, for developing the rules to operationalize the mechanisms under Article 6 of the Paris Agreement.

#### B. Outreach activities

10. The secretariat maintains the JI web pages and the UNFCCC web pages related to JI as a promotional tool and a repository of information relating to the mechanism.

#### C. Meeting in 2020

- 11. The JISC held its 43<sup>rd</sup> meeting on 16 October 2020 in a virtual environment.<sup>7</sup> A total of 16 of the 18 current JISC members and alternate members participated in the meeting and electronic oaths of service were submitted to fulfil the requirements of the rules of procedure of the JISC.<sup>8</sup>
- 12. The annotated agenda for the meeting, supporting documentation for agenda items, on-demand broadcasts and a report containing all agreements reached by the JISC are available on the JI web pages.<sup>9</sup>
- 13. At the meeting, the JISC honoured the memory of Rajesh Sethi, who served as the secretary to the JISC for the past six years, by observing a minute of silence. Mr. Sethi was remembered for his significant contribution to the Kyoto Protocol mechanisms, having spent several years working as the designated national authority for India, in his country's delegation to the UNFCCC, and as both member and Chair of the Executive Board of the CDM during the period 2005–2011.
- 14. In the spirit of prudent resource management, the JISC decided not to hold any physical meetings during 2020, and that its Chair and Vice-Chair would consult electronically with members for decision-making, if required.

#### D. Interaction with bodies and stakeholders

15. The JISC continued to make itself available for interaction with independent entities, AIEs, project developers and observers by encouraging stakeholders to submit written input to the agenda for its 43<sup>rd</sup> meeting and inviting the chairs of the DOE/AIE Coordination Forum and the Project Developer Forum to the meeting.

#### E. Accreditation of independent entities

16. The JISC reviewed its reliance on the CDM accreditation system and agreed to continue allowing DOEs accredited under the CDM to act voluntarily as AIEs to perform JI

determinations and verifications. As at 16 October 2020, 10 DOEs had submitted self-declarations expressing interest in acting voluntarily as AIEs.

17. During the reporting period, no JI project determinations or verifications under JI Track 2 were submitted by a DOE acting voluntarily as an AIE under JI.

## F. Verification procedure under the Joint Implementation Supervisory Committee

- 18. Since the inception of JI, 597 JI projects have been published under Track 1,<sup>10</sup> of which 548 have received unique project identifiers and have been submitted to the international transaction log. Information on 332 projects and one programme of activities under JI Track 2 has been made available on the JI web pages. A total of 52 determinations regarding project design documents have been published, of which 51 have been deemed final, while 128 of the 129 published verifications have been deemed final. A total of 871,893,629 emission reduction units have been issued, of which 846,477,357 were under Track 1 and 25,416,272 under Track 2.
- 19. As in the previous reporting period, no determination or verification cases were submitted for processing under JI Track 2 during the current reporting period.

## IV. Governance and management matters

#### A. Membership of the Joint Implementation Supervisory Committee

- 20. CMP 15 elected new members and alternate members of the JISC to fill vacancies arising from the expiration of the terms of tenure of outgoing members and alternate members. During the reporting period, the JISC comprised the members and alternate members listed in table 1.
- 21. The JISC wishes to highlight to the CMP the importance of constituencies filling vacant seats and the impact of vacant seats on constituting a quorum. The JISC encourages constituencies with vacant seats to nominate individuals to join the JISC.

# B. Election of the Chair and Vice-Chair of the Joint Implementation Supervisory Committee

- 22. The JISC, at its 43<sup>rd</sup> meeting, by consensus, elected Vanessa Leonardi, a member from a Party included in Annex I, as its Chair, and Derrick Oderson, a member from a Party not included in Annex I, as its Vice-Chair. Their tenures will end immediately before the first meeting of the JISC in 2021.
- 23. The JISC expressed its deep appreciation to the outgoing Chair, Kyekyeku Oppong-Boadi, and Vice-Chair, Vanessa Leonardi, for their excellent leadership during 2019.

# V. Status of financial resources for the work of the Joint Implementation Supervisory Committee and its supporting structures

- 24. The JISC continued to carefully monitor the status of, and prudently use, the resources available for the work on JI.<sup>11</sup> Resources were used in support of the approved two-year management plan for 2020–2021.<sup>12</sup>
- 25. A summary of the income of the JISC is provided in table 2.
