An Act to enable Her Majesty to confirm an Act passed by the Legislature of Antigua, intituled "An Act to extend the Operation of the Laws of Antigua to the Island of Barbuda".

(8th August, 1859.)

Whereas in the month of September, one thousand eight hundred and fifty-eight, an Act was passed by the Legislature of Her Majesty's Island of Antigua, intituled "An Act to extend the Operation of the Laws of Antigua to the Island of Barbuda", and it was provided in the said Act that the same should not have effect until Her Majesty's pleasure should be signified thereon:

And whereas doubts are entertained respecting the competency of the said Legislature to enact the said Act and of Her Majesty to ratify and confirm the same:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal and Commons, in this present Parliament assembled, and by the authority of the same, as follows—

Her Majesty empowered to confirm recited Act of the Legislature of Antigua. • It shall be lawful for Her Majesty, with the advice of Her Privy Council, to ratify and confirm the said Act, and the said Act shall, from the day on which it shall have been so ratified and confirmed, be deemed to be valid and effectual within the said Islands of Antigua and Barbuda, to all intents and for all purposes whatever.
