

**The Child Allowance system will change partially,
starting from the October 2022 payment.**

Two Important Announcements

1 An upper income limit has been established for High-Income Child Allowance.

⇒You may not be able to receive High-Income Child Allowance depending on your income. ("High-Income Child Allowance" refers to the 5000 yen per child payments made to people whose income exceeds the limit for receiving standard Child Allowance.)

2 The Update Form (genkyō todoke) submitted each June is no longer necessary for most recipients.

⇒If you still need to submit an Update Form (genkyō todoke), the city will send you a notification (see Item 2 on the reverse page for details).

(1) Income Limit for Receiving Child Allowance, Upper Income Limit for Receiving High-Income Child Allowance

· Starting October 2022, those whose income is equal to or greater than listed in Column ② in the chart below will not receive any allowance, even if they are raising children.

· Those who are raising children and whose income is less than listed in Column ① in the chart below will receive Child Allowance, and those raising children whose income is greater than Column ① but less than Column ② will receive High-Income Child Allowance.

※**If your income is too high to receive allowance but later drops to the amount listed in Column ② or lower, you will need to re-apply for Child Allowance.**

(2) The Omission of Update Forms (genkyō todoke)

ア Starting from 2022, Izumo City will use public registry information to confirm the status of Child Allowance recipients, and update forms are therefore not necessary.

※However, if you fall under any of the following categories, you will receive a notice from the city about submitting an Update Form (genkyō todoke).

- ① You came to Izumo fleeing domestic violence from your spouse or in other such circumstances, and your Certificate of Residence is somewhere other than Izumo City
- ② Your children are not listed on your family registry (koseki) or Certificate of Residence (jūminhyō)
- ③ You are living separately from your spouse during divorce proceedings

イ When any of the following occur, you must complete procedures at City Hall.

- ① If the number of children under your care who are eligible for Child Allowance decreases or drops to zero (due to divorce, aging out, etc.)
- ② If you, your spouse, or your child move addresses (including moving to another municipality or overseas)
- ③ If you, your spouse, or your child undergo a name change
- ④ If you get married or divorced
- ⑤ If you enroll in a different pension scheme, or become a public employee
- ⑥ If you were previously in divorce proceedings, but your divorce is now finalized
