Notice of Decisions on the Proposed Second Generation Dunedin City District Plan (2GP) – 7 November 2018

Pursuant to clauses 10 and 11 of Schedule 1 of the Resource Management Act 1991, the Dunedin City Council gives notice of its decisions on submissions on the Proposed Second Generation Dunedin City District Plan (2GP).

The 2GP Hearings Panel has considered submissions and made decisions on the provisions of the Plan affected by those submissions.

There are 29 decision reports, accompanied by a marked-up version of the notified Plan (2015) showing changes made to provisions. A new decisions version of the 2GP and planning maps, will replace the notified version on the 2GP website. The notified 2GP (2015) will still be available online in a PDF format.

The website can also be accessed at one of the public computers at the Dunedin City Library, Mosgiel Library, Port Chalmers Library, Waikouaiti Library, South Dunedin Community Pop-Up and the Blueskin Bay Library at Waitati. Status of 2GP once decisions are released

Once decisions have been released, all provisions (objectives, policies and rules) in the 2GP decisions version (November 2018) have legal effect. Legal effect means that both the new 2GP decisions version (November 2018) provisions and the operative District Plan (2006) provisions apply.

The 2GP provisions will overtime replace the Operative District Plan (2006) provisions as the 2GP provisions become beyond appeal (e.g. no appeals received, or appeals determined or withdrawn).

Appeals

Clause 14 of the first schedule RMA establishes who can appeal the decisions. It says submitters may appeal decisions on matters that were the subject of their submission. The deadline for lodging a notice of appeal is 30 working days from being served with the public notice. 30 working days from 7 November is 19 December 2018.
