Signed and dated character reference (not from your employer or a relative). It must include:  • the person's relationship to the applicant  • how long they've known the applicant  • a statement of recommendation  • the referee's contact details.

Minimum six (6) months' recent and relevant experience in the alcohol industry (If you've had experience at premises other than where you are working now, please include a reference from your previous employer)
