

TERMS OF USE

The following terms and conditions of use (the “Terms and Conditions”) govern your use of the MGP Processing, Inc. Web site www.MGPIIngredients.com, which shall include, without limitation, the home page, splash page, and all other pages under the same top level domain name, and all content thereon (the “Site”) as provided by MGPI Processing, Inc., (“MGP” or “we”). We may change the Terms and Conditions from time to time and at any time without notice to you, by posting such changes on the Site. BY USING THE SITE, YOU ACCEPT AND AGREE TO THESE TERMS AND CONDITIONS AS APPLIED TO YOUR USE OF THE SITE. If you do not agree to these Terms and Conditions, you may not access or otherwise use the Site. By using the Site following any modifications to the Terms and Conditions, you agree to be bound by any such modifications to the Terms and Conditions.

Age Requirement for Use of Site.

This Site is intended only for the use and enjoyment of persons who are of legal age to purchase beverage alcohol in the jurisdiction in which they reside.
