RE: Letter of Intent to Enter into an Agreement with the United States Nuclear Regulatory Commission

Dear Chairman Hanson,

The State of West Virginia is committed to an all-of-the-above energy policy, building off of its proud history as the source of so much of this Nation's energy supply. Today, that means including nuclear energy as a component of our energy security framework. West Virginia is committed to regulating exposure to radiation to assure the protection of the public, workers, and the environment. Moving forward, the State of West Virginia is also committed to continuing its history as a leader in providing clean and safe nuclear energy to satisfy the growing energy needs of the public. West Virginia already has exceptional resources for radiological environmental surveillance as well as radiological and nuclear emergency preparedness. Further, West Virginia recently passed legislation repealing a previous ban on nuclear energy production, a step taken to advance our goal of becoming an energy leader in the United States.

By this Letter of Intent, the State of West Virginia does hereby notify the United States Nuclear Regulatory Commission of our commitment to become an "NRC Agreement State." In accordance with Section §274(b) of the Atomic Energy Act of 1954, as amended, West Virginia intends to enter into an agreement with NRC to regulate source materials, small quantities of special nuclear materials, and byproduct materials as defined in §11e (1), (3) and (4) of the Act.

As Governor, I will ensure that West Virginia dedicates the resources necessary to meet the requirements of the Agreement. I authorize Tera Patton, Director, Office of Environmental Health Services-Radiological Health Program, to coordinate the process with your staff. To the US Nuclear Regulatory Commission:


