DISEASES OF FISH ACT 1937

Notice is hereby given that the Secretary of State for Wales, having reasonable grounds for suspecting that certain inland waters and land adjacent to them is an infected area, has made a Diseases of Fish Designated Area Order.

The Order designates the area for the purpose of section 2 of the Diseases of Fish Act 1937, as amended by the Diseases of Fish Act 1983, and restricts the movement of any live fish or live eggs of fish without the previous consent in writing of the Secretary of State for Wales.
